We have performed audits of the accompanying financial statements of Cescaphe Event Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

(1) **Plan Description**

General

The following description of Cescaphe Event Group 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

The effective date of the Plan is January 1, 2007. The Plan is a defined contribution plan covering full-time employees of Cescaphe Limited, LLC (the “Company” or “Administrator”) and its subsidiaries who have two months of service and are age 21 or older. The Plan also covers part-time, temporary, and seasonal employees who are age 21 or older and have accumulated 1,000 hours of service or 500 hours for three consecutive years.

Non-resident aliens and union employees are ineligible as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Each year, eligible participants’ elective deferrals may not exceed 100 percent of eligible compensation on a pre-tax basis, after-tax basis (“Roth”) or a combination of both. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Those elective salary reduction contributions are subject to the limits of Internal Revenue Code Section 401(k). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Under the 401(k) plan, the Company makes discretionary matching contributions. Plan provisions provide for the Company to match 100% of participant’s elective deferrals not to exceed 4% of the participant’s compensation as defined in the Plan document. The Company’s matching contributions in the plan year ended December 31, 2024 were \$268,449.

Contributions, Continued

At the end of the Plan year, at the discretion of the Company's board of directors, the Company may make profit-sharing contributions, as defined in the Plan document. There were no discretionary profit-sharing contributions for the plan year ended December 31, 2024. Contributions would have been subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, employer contributions plus actual earnings thereon. A participant is always 100 percent vested upon normal or early retirement age. To receive an allocation of matching contributions, nonelective contributions and qualified nonelective contributions, a participant must be employed by the Company on the last day of the year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balances in the participants' accounts and bear interest of 5.25 to 10.50 percent. Principal and interest is paid ratably through payroll deductions.

Payments of Benefits

Upon retirement, death, disability, or termination of service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified time period selected by the participant. For termination of service or other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. A participant may also elect to withdraw all or a portion of their account at any time through hardship provisions as defined by the Internal Revenue Code and subject to approval by the Company.

Forfeitures/Unallocated Funds

When certain terminations of participation in the Plan occur, normally those of part-time employees, the non-vested portion of the participant's account, as defined by the Plan, are subject to forfeiture. At December 31, 2024 and 2023, there were no forfeited non-vested accounts, however, there did exist unallocated employer contributions of \$808 and \$142, respectively. These funds will be used to reduce future employer contributions, in addition to funds of \$4,976 in participant accounts that are required to be similarly re-allocated.

Investment Elections

The Plan offers its participants investment options in various investment funds that are exposed to different types and amounts of risk. There were approximately 21 investment options, consisting principally of mutual funds, available for the investment of participants' and employer contributions. Plan participants may change their investment selections daily.

(2) **Summary of Significant Accounting Policies**

Basis of Accounting and Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with US generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts in the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gains have also been included in the net appreciation in the fair value of net assets.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the Plan document. As such, no allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions

Contributions from employees are recorded as they are withheld from the participants' wages.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees relating to the administration of notes receivable from participants are charged directly to the participants' accounts. Investment related expenses are included in the net appreciation in the fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

(3) **Investments**

On January 1, 2018, the trustees appointed Fidelity Management Trust Company as the trustee/custodian of the Plan assets. All investments are participant-directed.

(4) **Information Prepared and Certified by Trustee - Unaudited**

The information in the accompanying financial statements, notes and supplementary information related to, investments held and notes receivable from participants, at December 31, 2024 and 2023, and net appreciation or depreciation in fair market value of investment securities, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(5) **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The input levels are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observed for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and the money market fund held by the Plan are deemed to be actively traded.

The valuation method as described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) **Related-Party Transactions and Party-in-Interest Transactions**

Parties-in-interest include fiduciaries, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and a person who owns 50% or more of such an employer or relatives of such persons.

Certain plan investments are shares of mutual funds held by Fidelity Management Trust Company, the trustees and parties-in-interest to the Plan. The Plan provides for employer contributions, holds notes receivable from participants and paid certain expenses related to plan operations and investment activities to various service providers. Transactions with these entities qualify as exempt party-in-interest transactions.

Fees paid by the Plan for custodial, investment advisory, and record-keeping services amounted to \$42,552 for the year ended December 31, 2024. The Company provides certain other management services to the Plan for which no fees are charged. These transactions are also exempt party-in-interest transactions.

(7) **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(8) **Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
