Opinion

We have audited the accompanying financial statements of Chugach Government Solutions Health and Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Chugach Government Solutions Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

General: The Plan and related trust were established January 1, 2016 to provide health and other benefits to eligible participants. The sponsoring employer, Chugach Government Solutions, LLC, has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits: The Plan provides medical, dental, vision, prescription drug coverage, short-term disability, long-term disability, life and supplemental accident benefits for eligible participants and their dependents. The Plan provides many of these benefits on a self-funded basis and others on a fully funded basis determined by the insurance plans offered and the insurance coverage enrolled in by the participant. The Plan also has contracts with third party insurance companies and a stop-loss insurance policy, which covers both specific and aggregate claims in excess of the deductibles as specified in the contract for the self-insured coverages.

There is a 30-day waiting period after employment for coverage of benefits. The Plan Sponsor also provides benefits for participants through a Health Reimbursement Arrangement (HRA) component and a Wellness Program to the health services. The HRA component is used to reimburse covered persons for qualified health expenses incurred upon eligibility, provided the covered employee was enrolled at the time the expense was incurred. The Wellness Program is an added health insurance service to encourage employees to improve their well-being. The program can provide an opportunity for participants to earn additional funds to be deposited into their HRA plan, if approved.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). The Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Imprest Account Receivable (Payable): Represents an amount on deposit with a claims processing company for payment of claims or amount due to replenish overpayments out of the account. Account is replenished, as needed, to maintain a deposit sufficient to pay claims for participants.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (continued)

Sponsor Contributions Receivable: Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The Plan invests in investment security. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

Administrative Expenses: The Plan's administrative fees are paid by the Plan.

Trust Fees: The Plan's trust fees, for processing and payment of insurance premiums and other administrative services, are paid by the Plan.

Claims Payable and Claims Incurred, But Not Reported: Liabilities for claims payable and claims incurred, but not reported, for covered participants as of year-end, but not paid until after year-end, are included in Plan benefit obligations. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and/or received dates of December 31 and prior.

Benefit Obligations: Benefit obligations include those claims for which services have been performed but which have not been paid as of December 31. Based on the inherent uncertainties involved, it is reasonably possible that the estimate will change in the near term.

Accrued Administrative Expenses: This amount represents other administrative fees pertaining to the current year, but not yet paid at year end.

Trust Fees Payable: This amount represents trust fees pertaining to the current year, but not yet paid at year end.

Contributions: Sponsor, employee, and COBRA contributions are recognized as income in the month the benefits are earned.

Prepaid Expenses: These amounts represent payments for insurance premiums and administrative expenses for further periods.

Subsequent Events: Plan management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued and determined that there were no subsequent events requiring disclosure.

NOTE 3: CONTRIBUTIONS

The Plan is funded primarily by contributions from the Plan Sponsor. Benefit or insurance premium payments are made from these contributions. Contributions are allocated to Plan benefits and expenses in accordance with an administrative services agreement between the Plan Sponsor and the third-party administrator. The Plan Sponsor is ultimately responsible for the allocation and administration of funds. The third-party administrator is responsible for paying premiums to various insurance companies and paying the benefits in the form of reimbursements for claims submitted for eligible participants through the medical, dental and vision benefits. Premiums to pay for elected benefits for eligible participants' dependents are funded through authorized payroll deductions, based on contract agreements.

NOTE 4: RESERVES AND BENEFIT OBLIGATIONS

Claims Funding Reserve (“Vision”): The Employer contributes a required amount for employees based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses and claims, are retained in the Plan for the benefit of these participants.

Health Reimbursement Arrangement Reserve (HRA): The HRA component of the Plan will reimburse covered persons for qualified health expenses incurred after the effective date of this HRA component, provided the covered employee was enrolled at the time the expense was incurred. Qualified health expenses are amounts paid for the diagnosis, cure, mitigation, treatment or prevention of disease, or for the purpose of affecting any structure or function of the body. HRA benefits are funded for eligible participants only. The Plan Sponsor remits fringe contributions to the trust based on hours paid or worked as specified in the wage determination as posted at the jobsite. HRA benefits are also funded for eligible participants through participation in the health insurance Wellness Program, based on approval of the wellness activity by the third-party provider.

Asset Balance Reserve: The Plan Sponsor contributes a required amount for employees of the Plan based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the “asset balance reserve.”

NOTE 5: FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of benefit obligations and net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs were not available.

NOTE 6: INCOME TAX STATUS

The Plan has not applied for exemption from state or federal income taxes. Plan management believes that the Plan qualifies for exemption from income tax under the Internal Revenue Code and, therefore, no provision for income taxes is reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 7: TRANSACTIONS WITH PARTIES-IN-INTEREST

Trust fees charged to the Plan's third-party administrator were \$252,462 and \$302,409 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 there was not an amount payable to the Plan's third-party administrator. At December 31, 2023, amount payable to the Plan's third-party administrator for trust fees was \$72,379.

NOTE 8: PLAN TERMINATION
