*Opinion*

We have audited the financial statements of BLDG Management Co., Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1 - Description of Plan

The following description of the BLDG Management Co., Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan established to provide retirement benefits to eligible employees, as defined, of BLDG Management Co., Inc. (the "Company" or the "Plan Administrator"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

##### **Eligibility**

An employee, who is not covered by a collective bargaining agreement or not a nonresident alien, is eligible to participate in the Plan after completing one year of service or 1,000 hours in a given 12-month eligibility period and attaining the age of 21. Participation in the Plan is on a quarterly basis subsequent to the date all the requirements are met.

##### **Contributions**

For the year ended December 31, 2024, participants can elect to contribute up to \$23,000 of their pre-tax annual compensation, as defined in the Plan, subject to certain limitations of the Internal Revenue Service (the "IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make matching contributions equal to a discretionary percentage of the participant's elective deferral. The Company, at its discretion, may also contribute a profit-sharing contribution.

##### **Participant accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contributions, and allocations of the profit-sharing contributions, if any, and Plan earnings and losses, and charged with withdrawals. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. A participant's enrollment in the Plan or change in elections may occur January 1, April 1, July 1 or October 1 of each Plan year.

Participants may direct their contributions into various investment options offered by the Plan. Company contributions are automatically invested in the funds as the employee directs. The Plan currently offers mutual funds and a stable value fund as investment options for participants.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. Participants must be employed on the last day of the Plan year to receive credit for a year of service. A participant is 100% vested in the Company's matching contributions and profit-sharing contributions after six years of credited service. Notwithstanding the foregoing, a participant becomes fully vested in the Company's contributions upon the earlier of: (i) retirement at age 65; (ii) total and permanent disability; (iii) age 65 while employed; and (iv) termination of employment by way of death.

#### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested value of their account, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1.5% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions over a one to five-year period, unless the loan is used to purchase a primary residence. Participants may not have more than three loans outstanding at any one time.

#### **Payment of benefits**

On termination of service due to death, disability, retirement or termination of employment in accordance with the Plan's provisions, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments, not to exceed the participant's life expectancy or the joint life expectancy of the participant and his or her beneficiary. In addition, participants are allowed to receive hardship distributions.

#### **Forfeited accounts**

Forfeited contributions are used to reduce the Company's contributions, subject to the Plan's provisions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,547 and \$11,244, respectively. During the year ended December 31, 2024, no amount of forfeitures was used to reduce Company contributions and \$4,065 was used to pay administrative expenses.

### **Note 2 - Summary of significant accounting policies**

#### **Basis of accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, which is all attributable to mutual funds, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Contributions**

Contributions from Plan participants are recorded in the year in which participants' compensation is earned.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements while other expenses are charged to participants' accounts. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued (see Note 8).

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting ("FASB") issued Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 4 - Related party transactions and party-in-interest transactions

Certain Plan investments are shares of mutual funds managed by American Funds. American Funds operates under the Capital Group Companies, which is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

American Funds provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and American Funds. American Funds receives revenue from mutual fund service providers for services American Funds provides to the funds. This revenue is used to offset certain amounts owed to American Funds for its administrative services to the Plan.

If the revenue received by American Funds from such mutual fund service providers exceeds the amount owed under the MSA, American Funds remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants or are otherwise recorded as revenue sharing income on the statement of changes in net assets available for benefits. During 2024, \$4,065 in administrative expenses was covered by revenue sharing.

#### Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 6 - Tax status

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Subsequent events**

Effective January 1, 2025, the Plan has been amended for eligible participants to participate in the Plan after completing 6 months of service.
