**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Astoria Generating Company, L.P. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of Astoria Generating Company, L.P. and USPG Power Services, Inc. (together, the “Company”) except those who are covered by a collective bargaining agreement, leased employees, or nonresident aliens. Employees are eligible to participate in the Plan upon their initial employment date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The trustee and custodian for the Plan is Vanguard Fiduciary Trust Company (Vanguard FTC). The Vanguard Group, Inc. is the recordkeeper for the Plan.

**Contributions**

Participants may elect to contribute from 1% to 50% of eligible compensation on a pre-tax and/or Roth basis, up to the maximum contribution amount allowed by law. The annual eligible contribution limit was \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may make additional after-tax contributions (from 1% to 16% of eligible compensation), and contribute rollover contributions from other qualified plans.

Each pay period, the Company contributes a safe harbor enhanced matching contribution in the amount of 100% of each participant’s elective deferrals up to 6% of eligible compensation. The Company may also make discretionary contributions as a uniform percentage of eligible compensation for all eligible participants employed on the last day of the plan year. For 2024, the Company made a discretionary contribution equal to 3% of each participant’s eligible compensation.

The Plan is participant directed and participants may change their contribution amounts each pay period and investment options at any time.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings. In addition, participants are charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**Vesting**

Participants are at all times fully vested in their contributions and Company contributions and the appreciation or depreciation thereon.

**Payment of Benefits**

Normal retirement age under the Plan is 60. Upon termination of service, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period not to exceed the participant's assumed life expectancy. The Plan also allows hardship withdrawals and in-service withdrawals for participants who have attained age 59 ½.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined under the Plan at the date of the loan. Principal and interest are paid ratably through payroll deductions for periods ranging up to five years. Participants may only have one loan outstanding at any time.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. **NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investments**

All of the Plan's investments consist of a divided interest in the Astoria Generating Company, L.P. Master Trust (the "Master Trust"). The Master Trust was established for the collective investment of certain defined contribution plans of the Company. Vanguard FTC invests the assets of the Plan in certain investments included in the Master Trust pursuant to the directions of the participants and in accordance with Plan provisions.

Investments included in the Master Trust are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Master Trust's investment policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the safe harbor enhanced matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The discretionary contribution is recorded in the plan year in which participant compensation is paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, notes receivable from participants and withdrawals are charged directly or allocated to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments in the Master Trust.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the investments in the Master Trust. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of investments in the Master Trust that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

*Collective Trust Fund:* Valued at NAV as determined by the fund's trustee based on the underlying investments, as a practical expedient to measure fair value. The underlying investments are primarily pools of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality fixed income securities. Participant transactions may occur daily. The Plan has no unfunded commitments and no contractual obligations to further invest in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**NOTE 5 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard FTC has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan, through its participation in the Master Trust, invests in certain mutual funds and a collective trust fund managed by Vanguard FTC and an affiliate of Vanguard FTC. Transactions in such investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 7 - TAX STATUS**

The Plan adopted a nonstandardized pre-approved plan, which received its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through June 30, 2025, the date the financial statements were available to be issued.
