Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements**

Plan Description

The following description of the Case & Associates Properties, Inc. 401(K) Plan (the "Plan") provides only general information. Participants and others should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan is a defined contribution plan covering all employees of Case & Associates Properties, Inc. ("Employer") who have completed one year of service, as defined in the Plan document, and who have attained the age of 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions

Participants are permitted to contribute 100% of their pretax annual compensation, as defined in the Plan document, not to exceed the annual contribution limit set by the Internal Revenue Service (IRS), which was \$23,000 in 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants who have attained age 50 prior to the end of the Plan year are eligible to make catch-up contributions.

Employer Contributions

The Employer may contribute a discretionary matching contribution equal to 75% of the participant's contributions on the first 4% of the participant's compensation. At the end of the Plan year, the Employer may elect to make an additional matching Employer contribution equal to a percentage (as declared by the Employer) of the deferral contributions made by the participant during the Plan year. Contributions are subject to certain limitations as defined in the Internal Revenue Code (IRC) Section 402(g)(3).

Participants' Accounts

Each participant's account is credited with the participant's voluntary contribution, the Employer's discretionary matching contribution, any Employer additional matching contributions and plan earnings, which are allocated proportionately among all participants based upon their investment in each fund. The Employer's discretionary additional contribution allocation is based on the participant's contribution as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in the Employer contributions and related earnings thereon is based on years of continued service and is determined as follows:

Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance. Minimum loan amounts are \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates (currently 4.25% to 9.5%) which are commensurate with local prevailing rates as determined by the Plan administrator. Loan terms can be up to five years unless the loan is for the purchase of the participant's primary residence, for which the term can be up to ten years. Principal and interest are paid ratably through payroll deductions.

Plan Description (continued)

Payment of Benefits

Benefits under the Plan begin when a participant retires, dies, or ceases to be an employee, whichever applies as provided by the Plan. Benefits may begin before normal retirement date for a participant who becomes totally and permanently disabled while employed. Employment terminated for any reason other than retirement, death or total and permanent disability, with the participants' vested percentage less than 100%, the amount allocated to the participants' accounts may be forfeited and reallocated to the accounts of participants remaining in the Plan.

Forfeited Accounts

In the event of a forfeiture, the forfeited amount shall be used to restore forfeitures or reduce Employer contributions (or reallocate as Company contributions), or to pay reasonable Plan expenses. Reallocated forfeitures as Company contributions will be allocated to all participants eligible to share in the allocations in proportion to each such participant's compensation for the year. The allocations are considered employer contributions for vesting purposes. The following table sets forth the forfeiture activity for the Plan year ended December 31, 2024.

Plan Operating Expenses

Total expenses related to operating the Plan for the year ended December 31, 2024 were \$137,625. This entire amount was paid by the Plan, and none of it (\$0) was paid by the Employer.

Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of assets, including the fair value of investments held within the Plan, liabilities, additions and deductions reflected within the financial statements. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Subsequent events were evaluated through October 8, 2025 the date the financial statements were available to be issued.

Summary of Significant Accounting Policies (continued)

Valuation of Investments and Income Recognition

The Plan's mutual fund investments are carried at fair market value at the balance sheet date as determined by quoted market prices. Pooled separate accounts are valued at estimated fair value by Reliance Trust Company. Fully benefit-responsive investment contracts are valued at contract value as estimated by Reliance Trust Company. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally will receive if they were to initiate permitted transactions under terms of the Plan. Interest income is recorded as earned. Purchase and sales of securities are recorded on a trade-date basis. Dividends are recorded on the execution date. The Plan does not have any non-participant directed investments.

Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value and NAV. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts (PSA's)

Valued at the net asset value ("NAV") of units of the separate account. The NAV, as provided by the asset custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Value based on using quoted prices in active markets for identical assets.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investment Information Prepared and Certified

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the asset custodian has certified the following data included in the financial statements is complete and accurate:

The following information was certified by the Reliance Trust Company:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Schedule H, Line 4i-Schedule of Assets (held at year end), December 31, 2024
- Investment income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Related Party Transactions

The Employer provides certain accounting, administrative and investment management services to the Plan for which no fees are charged. These transactions are exempt party in interest transactions.

Certain Plan investments were maintained with and managed by Reliance Trust Company, which served as the asset custodian of the Plan during the year ended December 31, 2024. Therefore, these transactions qualify as exempt party-in-interest transactions.

Plan Termination

Although they have not expressed any interest in doing so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan assets would be allocated to the participants' account balances as if each participant were 100% vested in the Plan.

Tax Status

The Plan adopted the Volume Submitter 401(k) Profit Sharing Plan with a deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Risks and Uncertainties

The Plan invests in a variety of investment funds. Investments, in general, are exposed to various risks such as interest rate, market, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.

Plan Administration Change

During the current fiscal year, the Company transitioned the administration of the Plan from Transamerica Retirement Solutions to T. Rowe Price Retirement Plan Services. The change was effective February 20, 2024, and was made to enhance participant services, investment options, and overall plan management. All plan assets and participant account balances were successfully transferred to T. Rowe Price, and there was no disruption to participant access or contributions during the transition.
