**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Brazeway Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan with Internal Revenue Code Section 401(k) provisions. The Plan covers substantially all Brazeway, LLC (the “Company”) U.S. employees. All employees except for employees not scheduled to work a minimum of 1,000 hours during the Plan year are eligible to participate in the Plan immediately upon hire date if they have attained the age of 19. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: A participant can make voluntary salary or wage deferral contributions of his or her eligible compensation, within the maximum allowed by the Internal Revenue Service. Employees are automatically enrolled to defer a defined percentage of their eligible compensation, unless the employee specifically requests otherwise. The Plan allows for Company matching contributions and a discretionary Company profit sharing contribution for eligible participants, which are determined on an annual basis. For the year ended December 31, 2024, the Company matching contribution was 100% of employee contributions up to 4% of eligible participant compensation. For the year ended December 31, 2023, the discretionary Company profit-sharing contribution was 2% of eligible participant compensation.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions, (b) the Plan earnings and (c) forfeitures and is charged with his or her withdrawals and an allocation of administrative expenses. Each participant directs the investment of their account to any of the investment options available under the Plan. Discretionary Company matching contributions are allocated to participants who made salary or wage deferrals in the current year. Discretionary Company profit-sharing contributions are allocated to all eligible participants who are employed by the Company during the Plan year and who remain employed by the Company on the last day of the Plan year. Allocations of Plan earnings or losses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death, and Disability Benefits: Under the Plan, a participant (beneficiary) is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their voluntary contributions and Company matching contributions plus actual earnings thereon. Vesting in discretionary Company profit-sharing contributions plus earnings thereon is based on years of service. Participants become 100% vested after five years of credited service with graduated vesting of 20% per year.

Forfeitures: The nonvested portion of the discretionary Company profit-sharing contributions of terminated participants is used to offset administrative fees or future employer contributions of the Plan. For the year ended December 31, 2024, \$30,000 of forfeited employer profit sharing contributions were applied to offset employer contributions receivable reflected in the financial statements. The remaining balance of forfeitures that are available to offset administrative expenses of the Plan were \$34,638 and \$38,306 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants: The Plan provides that participants can borrow funds against their employee account balances limited to 50% of their vested account balance and not less than \$1,000 or more than \$50,000. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

Payment of Benefits: On termination of service a participant with a balance less than \$1,000 will receive a lump-sum payment equal to the value of his or her vested balance. A participant with a balance between \$1,000 - \$5,000 will have their vested balance rolled over into an IRA and a person with a balance greater than \$5,000 can choose to leave the amount in the plan, request a payout or request a rollover.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan provides for various investment options including mutual funds and a collective trust fund. The underlying investment securities are exposed to various risks, such as, interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Administrative Fees: The Plan reports administrative fees net with the revenue credit which is calculated in arrears each quarter. The revenue credit is excess recordkeeping revenue received by the plan that is allocated to eligible participant accounts as an offset to recordkeeping fees.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 – CERTIFIED INFORMATION - INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective trust stable value fund:* The fair values of participation units in the stable value collective trust are based upon the net asset values per unit as reported by the fund managers. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Transactions during the year with parties-in-interest included administrative services. The Plan incurred administrative expenses of \$94,685 and revenue credits of \$126,791 during the year ended December 31, 2024. For the year ended December 31, 2023, the Plan received a net revenue credit of \$32,106, representing the excess of revenue sharing amounts received over administrative fees paid to Fidelity and CapTrust. Substantially all investments and notes receivable from participants held by the Plan are considered party-in-interest transactions. As of December 31, 2024 and 2023, \$49,036,371 and \$44,001,383, respectively, of Plan investments, and \$703,615 and \$642,214, respectively, of notes receivable from participants were managed by Fidelity Management Trust Company or Fidelity Investments, an affiliate.

**NOTE 6 – TAX STATUS**

In 2015, the Plan was restated on a prototype document that has received a favorable opinion letter dated June 30, 2020. Since the Plan was restated on a prototype document, it is not required to file for an individual determination letter. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
