**Note 1 – Description of the Plan**

The following brief description of Blue & Co. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan instrument for complete information.

General

The Plan is a defined contribution plan established January 1, 1992 for the benefit of the employees of Blue & Co., LLC and affiliated companies (collectively, the Companies).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was restated as of January 1, 2021. Employees of the Companies are immediately eligible to participate in pretax and Roth elective salary deferrals upon their hire date and may be immediately enrolled in the Plan once they reach 18 years of age. Employees are also immediately eligible to receive matching contributions made by the Companies and become eligible to receive qualified non-elective employer contributions after reaching 1,000 hours of service in one year. The Plan credits specified service with certain designated predecessor employers; a full list can be found in the plan document. Part-time employees will become eligible to enroll in the Plan once they reach three consecutive years of service with at least 500 hours in each year.

Contributions

Each year, participants may contribute up to a maximum amount of their pretax and after-tax annual compensation as defined by the Internal Revenue Service and recorded in the plan document, not to exceed 75% of compensation. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified plans. Each year the Companies may choose to make a discretionary matching contribution and/or a discretionary non-elective contribution. The Companies' matching contribution may be any amount up to 6% of elective salary deferrals. For the years ended December 31, 2024 and 2023, the Companies made matching contributions of 50% of elective deferrals, not to exceed 6% of eligible salary. There were no discretionary non-elective contributions made in 2024 or 2023. Both the employer match and any discretionary non-elective contributions are calculated on an annual basis.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Companies' matching contributions, if any, allocations of plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant account balances or earnings, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions plus actual earnings (losses) thereon. Employer matching and discretionary non-elective contributions, as well as earnings (losses) thereon, are subject to a six-year graded schedule where participants become 100% vested after six years of service. Participants also become fully vested at normal retirement age, or in the event of death, disability, retirement, or plan termination.

Investment Options

Upon enrollment in the Plan, participants are able to invest in a variety of investment choices as more fully described in the plan document. Participants may change their investment options at any time during the year.

Notes Receivable from Participants

Participant loans are not allowed under the Plan.

Payment of Benefits

Upon termination of employment, retirement, death or disability, a participant or beneficiary may receive benefits based on the participant's vested account balance. Benefits may only be paid in a lump sum. Also, hardship distributions of pretax elective deferrals are permitted. In-service withdrawals can be made once a participant reaches age 65 or in the case of a hardship as defined in the plan document. The Plan also allows forced distributions. Participants who are retired, terminated, or otherwise separated from service and have an account balance under \$1,000 will receive a lump sum payment of their entire balance after 45 days unless their balances are moved elsewhere. Terminated participants with balances between \$1,000 and \$5,000 will have their accounts rolled over to an IRA after 45 days unless their balances are moved elsewhere. Terminated participants with account balances greater than \$5,000 may have their account balances distributed as lump sums, rolled over, or postponed and remain in the Plan.

Forfeited Accounts

Forfeitures may be used to reduce the Companies' matching contributions or to pay Plan expenses. As of December 31, 2024 and 2023 forfeited non-vested accounts totaled \$36,265 and \$24,883, respectively. During the year ended December 31, 2024, \$120,589 in forfeitures were used to pay plan expenses.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), which requires management to make estimates and assumptions affecting certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plans' investments are reported at fair value. Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses paid by the Companies are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events have been evaluated by management through October 8, 2025, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy prioritizing the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices observable for the asset or liability;
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at the daily closing price as reported by the fund (Level 1 inputs).

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

**Note 4 – Tax Status**

The Internal Revenue Service determined the prototype plan used by the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code, as indicated in a letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position which more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**Note 6 – Certified Information**

At December 31, 2024 and 2023, the Plan's investments were maintained by Fidelity Personal Trust Company, FSB (the trustee). The trustee supplied the plan administrator with a certification as to the completeness and accuracy of all information relating to investments as of December 31, 2024 and 2023, and income and expenses on such investments for the year ended December 31, 2024. The certified information includes total investments of \$113,975,061 and \$100,505,267 at December 31, 2024 and 2023, respectively, and the activity reported on the statement of changes in net assets available for benefits for the year ended December 31, 2024 with the exception of the impact of the employee and employer receivables as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The certified information did not include employee and employer receivables.

**Note 7 – Party-In-Interest Transactions**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds certain investment funds managed by the plan trustee. Such investments and the Plan's payment of fees qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Some professional fees for the administration and audit of the Plan are paid directly by the Companies.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to numerous risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 – Subsequent Event**

Effective June 2025, the Company elected to change the Plan's trustee and third-party administrators from Fidelity Personal Trust Company, FSB, to Empower Retirement, LLC.
