NOTE 1 - DESCRIPTION OF THE PLAN

A. General

The following description of the New Columbia Fruit Packers, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was adopted on November 1, 1989, and was most recently restated effective November 1, 2021. The Plan was amended on January 1, 2023, to substitute the name of the Plan from Columbia Fruit Packers, Inc. 401(k) Plan to New Columbia Fruit Packers, LLC 401(k) Retirement Plan.

The Plan is a defined contribution plan in accordance with Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all full time employees of New Columbia Fruit Packers, LLC 401(k) Retirement Plan (Plan Sponsor) and its related entities, who have one year of service and are age eighteen or older. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions

Participants may contribute up to the maximum percentage allowable by the applicable IRC, plus catch-up contributions, if applicable, of pretax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Plan Sponsor shall make a matching contribution equal to 20% of the participant's salary reduction. Additional amounts may be contributed at the option of the Plan Sponsor's Board of Directors. The amounts contributed by the employer are limited to a maximum of 25% of a participants' compensation electively deferred.

C. Participant accounts

Each participant's self-directed account is credited with the participant's contribution and allocations of the Plan Sponsor's contribution and Plan earnings and charged with an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant account balances or earnings, as directed in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after four years of credited service.

E. Notes receivable from participants

The Plan allows participants to borrow up to 50% of the vested balance of their account, up to a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

E. Notes receivable from participants (continued)

The term of the loan is generally five years, but can be longer if the loan is used for the purchase of a principal residence. In the event of termination of employment, loan balances and accrued interest shall be deducted from the amount of the distribution.

Based on the Plan administrator's assessment of the outstanding balance of notes receivable from participants in comparison to the secured balance of the vested participant account, an allowance for doubtful accounts is not considered necessary.

F. Payment of benefits

On termination of service due to death, disability, retirement or other reasons, a participant receives a lump sum amount equal to the value of the participant's vested interest in their account.

G. Forfeited accounts

Upon a participant's termination from the Plan, non-vested account balances are forfeited and used to reduce future employer contributions or to pay any administrative expenses. For 2024 and 2023, the Plan incurred \$962 and \$2,887 in forfeitures, respectively. Forfeitures of \$2,614 and \$1,688 were used to reduce the Plan Sponsor's matching contribution for 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The financial statements of the Plan are prepared utilizing the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

B. Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

C. Investment valuation and income recognition

The Plan's investments, other than fully benefit-responsive investment contract (FBRIC), are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

C. Investment valuation and income recognition (continued)

FBRIC is reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in FBRICs through the Stable Value Option. See Note 6 for discussion of Stable Value Option.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) in the pooled separate accounts (PSAs) include the Plan's gains and losses on investments bought and sold, as well as held during the year plus dividends and interest on the investments.

D. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

E. Payment of benefits

Benefits are recorded when paid.

F. Administrative expenses

All administrative expenses of maintaining the Plan are paid by the Plan or the Plan Sponsor.

NOTE 3 - INVESTMENTS

During 2024 and 2023, the Plan's investments (including interest and dividends and gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$819,977 and \$985,287, respectively.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments in the PSAs are managed by Transamerica Life Insurance Company (Transamerica). Transamerica is the custodian of the Plan's assets as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant of the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The PSAs are comprised of shares or units of underlying funds that are valued at the net asset value (NAV) of shares held by the Plan at year end. Underlying assets in these funds primarily include publicly traded equity securities and fixed income securities and are valued at their NAVs calculated by Transamerica and have a daily liquidity. There have been no changes in methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - STABLE VALUE OPTION

Transamerica offers a Stable Value Option that the participant may elect to transfer all or part of his or her funds. The Stable Value Option is considered a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by Transamerica, is the beginning balance plus any deposit and credited interest, less any withdrawals, charges, or expenses, a measurement that approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of Transamerica or otherwise. The repayment of principal and interest credited to participants holding the investment is a financial obligation of Transamerica. The terms of Transamerica's Group Annuity Contract require all permitted participant-initiated transactions involving the investment to occur at contract value with no conditions, limits or restrictions.

The contract value of the investment contract at December 31, 2024 and 2023, was \$779,064 and \$877,407, respectively.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 8 - INCOME TAX STATUS

The Plan operates under the provisions of a Non-Standardized Pre-Approved Profit Sharing Plan. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021, which is the standard statute of limitations look back period. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options, including PSAs and FBRIC. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and investment contracts and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - INFORMATION CERTIFIED BY THE CUSTODIAN

Information contained in the accompanying financial statements that was certified by the custodian, Transamerica, is as follows:

- Details (cost and fair value) of investment assets held at December 31, 2024 and 2023.
- Summaries of investment transactions for the years ended December 31, 2024 and 2023.
- Investment income for the years ended December 31, 2024 and 2023.
- Net appreciation (depreciation) in fair value of investments for the years ended December 31, 2024 and 2023.

NOTE 11 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements except as noted below.

On January 1, 2025 the Plan was amended to adopt safe harbor matching contributions.
