Note 1 – Description of plan

The following description of the InMobi Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of InMobi Inc. and its affiliates Meson Mediation LLC (fka AerServ, LLC) and PinSight Media+, Inc., and an unrelated employer, Glance InMobi Inc. (the "Companies"). The Plan covers substantially all employees. The Plan also covers employees of Sprout Builder Inc. and MMTG Labs who did not have any employees through December 31, 2024.

The Plan entry date is the day that the participant meets all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustee is responsible for oversight of the Plan. InMobi, Inc. is the Plan Administrator and is responsible for the day-to-day operations of the Plan. The Plan's trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute up to 85% of their annual compensation, as defined by the Plan. Participants that are fifty years of age or older may make catch-up contributions to the Plan. Contributions are subject to certain statutory limitations. Participants may also contribute amounts representing distributions from other qualified plans as rollover contributions. The Companies may make discretionary matching contributions which are allocated each pay period.

For 2024 and 2023, the Companies elected to make discretionary matching contributions of 100% of employee contributions up to 3% of eligible compensation with a maximum matching contribution of \$5,000 per participant (see Note 5).

Notes receivable from participants

The loans are collateralized by the balance in the participant's account and bear interest at the prime rate in effect at the loan's inception plus 1%. Principal and interest is paid ratably through payroll deductions over a period generally not to exceed sixty months, unless the loan is for the purchase of a principal residence, for which the repayment term may not exceed three hundred and sixty months. A participant may have no more than one loan outstanding at a given time.

Participant accounts

Each participant's account is credited with the participant's elective and rollover contributions and the Companies' matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are immediately 100% vested upon Plan participation for employer matching contributions.

Note 1 – Description of plan (continued)

Payment of benefits

Benefits are paid in the form of a lump sum. Participants may withdraw all or a portion of the vested portion of their accounts if they:

- terminate employment before attaining normal retirement age
- become disabled
- retire
- die
- attain normal retirement age but continue to work, or
- qualify for in-service distributions upon attaining age 59 ½

In addition, participants may make withdrawals from their account if they incur a financial hardship.

Note 2 – Summary of significant accounting policies

Unallocated plan assets

Unallocated plan assets generally consist of funds transferred to the Plan accounts by the employer in advance of funding obligations or in error due to computational differences. At December 31, 2024 and 2023 unallocated funds totaled \$28,118 and \$103,548, respectively. Company matching contributions for the years ended December 31, 2024 and 2023 were reduced by \$84,337 and \$-0-, respectively, from unallocated funds. Employer matching contributions made during 2025 will be reduced by the balance in the unallocated plan assets account.

Funding policy

The Companies remit employee deferral and employer matching contributions to the Plan on a payroll by payroll basis. The Companies remit true-up matching contributions, if applicable, after the close of the plan year.

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies using information provided by the trustee. See Note 3 for discussion on fair value measurement.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Tax status

The Plan adopted a plan document using the C-Ben Group LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA (a volume submitter plan). The Internal Revenue Service determined and informed C-Ben Group LLC by letter dated November 23, 2020, that the form of the volume submitter plan as then designed was in compliance with applicable provisions of the Internal Revenue Code (IRC). Although the volume submitter plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with applicable requirements of the IRC. The Plan administrator believes that the Plan is qualified and the related trust is tax exempt. Accordingly, there is no provision for income taxes in the accompanying financial statements.

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 740 *Accounting for Uncertainty in Income Taxes* requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if they have taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's policy is to recognize interest and penalties related to unrecognized tax benefits in income tax expense.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from the financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in administrative expenses as well.

Plan termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 3 – Fair value measurements

Financial Accounting Standards Board *ASC 820, Fair Value Measurements*, provides a framework for measuring, reporting and disclosing fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued using the related liability recorded by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, no auditing procedures were performed with respect to the information certified as complete and accurate by the custodian, except for comparing such information to information included in the financial statements.

Note 5 – Employer contributions

For 2024 and 2023, the Companies elected to make discretionary matching contributions of 100% of employee contributions up to 3% of eligible compensation with a maximum matching contribution of \$5,000 per participant. In 2024 and 2023, the Companies made matching contributions in excess of \$5,000 for certain employees. These excess contributions were moved from participant accounts to the unallocated plan assets account in 2024 for errors made in 2024 and 2023. Certain of these amounts were inadvertently missed and were subsequently moved to the unallocated plan assets account in 2025.

Other employer contributions in the accompanying financial statements include QNEC and QMAC corrections for the year ended December 31, 2024 of \$41,885, as well as lost income of \$1,601 on late remittances and other operational failures that occurred in the year ended December 31, 2023. Other employer contributions for the year ended December 31, 2024 also includes a duplicate remittance of employee deferrals and employer match of \$14,238 that was subsequently moved to the unallocated plan assets account and will be used to reduce future employer contributions.

Note 6 – Related party transactions

Empower Trust Company LLC and Empower Annuity Insurance Company of America (Empower) is the custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan custodian and trustee receive all charges, fees, and compensation, both direct and indirect, for services provided to the Plan under the packaged retirement services programs.

InMobi, Inc. provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. These transactions are exempt party-in-interest transactions.

Note 7 – Prohibited transactions

During 2024, the Companies failed to timely remit to the Plan's Trustee certain contributions totaling \$52,695 within the period prescribed by Department of Labor (DOL) regulations. The Companies, using self-correction, intend to make additional contributions to the affected participants' accounts in 2025 to compensate for lost income due to these late remittances.

During 2023, the Companies failed to timely remit to the Plan's Trustee certain contributions totaling \$190,688 within the period prescribed by Department of Labor (DOL) regulations. During 2024, the Companies, using self-correction, made additional contributions to the affected participants' accounts to compensate for lost income due to these late remittances.

The Plan identified certain contributions that were not made in accordance with participants' deferral elections and employer matching contributions not made in accordance with the Plan document.

Other receivables in the accompanying statement of net assets available for benefits as of December 31, 2024 consist of qualified non-elective contribution (QNEC) receivables which total \$31,717 and employer Qualified Matching Contribution (QMAC) receivables which total \$10,168. The Companies, using self-correction, intend to make the necessary QNEC and QMAC contributions for these errors in 2025.

Other receivables in the accompanying statement of net assets available for benefits as of December 31, 2023 consist of qualified non-elective contribution (QNEC) receivables which total \$7,655 and employer Qualified Matching Contribution (QMAC) receivables which total \$1,869. During 2024, the Companies, using self-correction, funded the affected participants' accounts, including lost income, to correct these errors.

Note 8 – Subsequent events

Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued.


