Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rolling Hills Country Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. PLAN DESCRIPTION

The following description of Rolling Hills Country Club 401(k) Plan (the Plan) for the employees of Rolling Hills Country Club (the Club, the Employer, and the Plan Sponsor) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees who are at least 21 years of age and have completed one year of service with at least 1,000 hours of service during the first 12 months of employment. Plan entry date is January 1 or the date 6 months later, coincident with or next following satisfaction of the eligibility requirements. The Employer established the Plan under the Employee Retirement Income Security Act of 1974 (ERISA) to provide deferred compensation benefits for eligible employees.

Contributions: The participant contributions are subject to the annual limits of the Internal Revenue Code (IRC). The maximum participant deferral limit was \$23,000 for the year ended December 31, 2024. Catch-up contributions of \$7,500 were available to participants who had attained age 50 or older by December 31, 2024, and had not exceeded the contribution limit for the Plan year. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined in the Plan.

The Plan includes provisions for Safe Harbor contributions where the Employer may elect to make matching or nonelective contributions. For the year ended December 31, 2024, the Employer made nonelective Safe Harbor contributions equal to 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. The Plan also provides for discretionary Employer profit sharing contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, and allocations of the Employer's contribution and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, Safe Harbor contributions and actual earnings thereon. Vesting in the Employer's discretionary profit sharing contribution portion of their accounts is based on years of service. Participants are vested in Employer discretionary profit sharing contributions, as defined in the Plan, at 20% per year, beginning at two years of service over a six-year period.

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, Employer's discretionary profit sharing contributions become 100% vested without regard to years of service.

Forfeitures: Forfeitures of Employer contributions can be utilized to pay the Plan administrative expenses or to reduce future Employer contributions. For the year ended December 31, 2024 and 2023, forfeitures of \$0 and \$5,147, respectively, were applied against Company contributions. As of December 31, 2024 and 2023, there were \$18,873 and \$5,891, respectively, of forfeitures available for future use.

Payment of Benefits: Upon retirement, death, disability or other termination of employment, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account as permitted under the Plan.

NOTE 1. PLAN DESCRIPTION (Continued)

Participant Loans: Participants may borrow from their vested account balances up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The minimum loan is \$1,000. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal, plus two percentage points. Principal and interest are paid ratably through payroll deductions or the participant's own personal funds over a term not to exceed five years, except for loans used to purchase or improve the participant's primary residence, which may have a repayment term not to exceed 30 years.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: Investments are reported at fair value with the exception of fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in the Voya Fixed Accounts, which meets the definition of fully-benefit responsive investment contracts and are valued at contract value.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year, net of fund investment expense.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses: Administrative expenses incidental to the administration of the Plan, including administrative fees not paid by the Employer, are paid by the Plan. Most investment options have fees that reduce the overall return on assets. The net appreciation of investments is inclusive of these fees.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed or corrective distributions based upon the participant's status and the terms of the Plan document.

Contributions Receivable: Contributions receivable are recognized when amounts are due to the Plan from employers, participants, or other sources as of the reporting date. Recognition is based on a demonstrated commitment, such as a formal resolution, a consistent funding policy, a tax deduction taken by the employer, or the employer's recording of a liability.

Benefits Payable to Participants: Benefits are recorded when paid.

Subsequent Events: The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued and has determined no events or transactions require recognition or disclosure in these financial statements.

NOTE 3. INVESTMENT CONTRACT WITH INSURANCE COMPANY

As of December 31, 2024, the Plan participates in two (2) group annuity or other types of contracts issued by Voya Retirement Insurance and Annuity Company (Voya Fixed Accounts). The Voya Fixed Accounts are deposit liabilities with no defined maturities and are fairly stated at contract value. The Voya Fixed Accounts, available under the group annuity contracts, are considered fully benefit-responsive and contract value is the relevant measurement.

The Voya Fixed Accounts have no stated maturity. Interest rates are reset monthly as of the beginning of each month, during which a new interest rate is applied daily to the total outstanding balance of the investment. Contract value, as reported to the Plan by Voya, represents contributions, plus earnings, less withdrawals and administrative expenses. Although the participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without restrictions, there may be a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance.

Since the Voya Fixed Accounts are an obligation of Voya, the occurrence of an event that limits the ability of the investment to transact at contract value with Voya and participants holding the investment is not probable.

In the event that the Plan terminates its contract with Voya, the Plan has the option of (a) liquidating Plan assets by making benefit payments under any form of payment available or (b) transferring all Plan assets to other funding vehicles. Plan assets held in the group annuity contract and mutual funds held within pooled separate accounts will be transferred ninety and ten days, respectively, following Voya's receipt of the notice of termination.

NOTE 4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their Employer contributions.

NOTE 5. TAX STATUS

The Plan obtained a favorable determination letter dated June 30, 2020 in which the Internal Revenue Services (IRS) stated the Plan is in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax position taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

NOTE 5. TAX STATUS (Continued)

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. As of December 31, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

NOTE 6. CERTIFIED FINANCIAL INFORMATION

Information on the Plan's investment assets as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified by Voya Retirement Insurance and Annuity Company (Voya), the custodian of the Plan. The Plan Administrator has obtained a certification from Voya that information provided to the Plan Administrator by Voya related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the Plan's investment assets which appear throughout the financial statements and ERISA-required supplemental schedule.

NOTE 7. FAIR VALUE MEASUREMENTS

Fair Value: The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value measurement hierarchy is based on three levels of inputs, of which the first two are considered observable and the last unobservable. The three levels of the fair value hierarchy are the following:

- Level 1:* Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The fair value of pooled separate accounts is determined using Level 1 inputs.
- Level 2:* Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3:* Inputs to the valuation that are unobservable and significant to the fair value measurement.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments were in funds managed by Voya, the Plan's custodian. For the year ended December 31, 2024 the Plan made indirect payments to Voya for service fees for \$2,898. These transactions qualify as party-in-interest transactions.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 10. PLAN AMENDMENT

In connection with COVID-19, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law on March 27, 2020. During the year ended December 31, 2020, the Plan Sponsor elected to operate the Plan to allow the optional provisions of the CARES Act immediately upon enactment. During the year ended December 31, 2023, the Plan was formally amended to include these provisions.

During the year ended December 31, 2024, the Plan was amended to include safe harbor provisions.

NOTE 11. EXCESS CONTRIBUTIONS

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability in the accompanying statements of net assets available for Plan benefits as of December 31, 2023. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the following year. There was no similar accrual recorded as of December 31, 2024.
