Their report dated October 1, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to asset held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of the Plan

The following description of the Hawaiian Airlines, Inc. Pilots' 401(k) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General - The Plan is a defined contribution plan established by Hawaiian Airlines, Inc. (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration - The Plan is administered by a committee consisting of certain employees of the Company. Empower Trust Company, LLC (Empower) serves as the trustee of the Plan.

Eligibility - Employees who are on the pilots' Systems Seniority List and covered by the collective bargaining agreement between the Company and the Air Line Pilots Association, International are eligible to participate in the Plan on their date of hire.

Contributions - Participants may elect to defer up to 50% of eligible compensation as pretax or Roth contributions. Participants may also elect to defer up to 10% of eligible compensation as traditional after-tax contributions. Participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions. Participants may also make eligible rollover contributions to the Plan. Newly hired or rehired eligible employees are automatically enrolled at a 6% deferral rate the first of the month following one year of service, unless they elect a different deferral rate or elect not to participate in the Plan.

Eligible pilots as of January 1, 2006 whose accrued benefit under the Retirement Plan for Pilots of Hawaiian Airlines, Inc. was frozen as of December 31, 2007 and eligible pilots hired after June 30, 2005 are eligible for employer nonelective contributions of 16% of eligible earnings. Additionally, the Company contributes \$2,500 for pilots who elect such contribution in lieu of a contribution to a health reimbursement arrangement or post-Medicare health plan. For pilots who are eligible participants of the Hawaiian Airlines, Inc. Pilots' Voluntary Employee Beneficiary Association Disability and Survivors' Benefit Plan (D&S VEBA Plan), the Company contributes 32% of the pilot's D&S VEBA Plan monthly benefit to the Plan.

Contributions are subject to certain IRC limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, nonelective contributions and plan earnings. Participant accounts are charged with certain administrative expenses based on specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their account into various investment options offered by the Plan. Participants may also access a number of investment securities outside the Plan's investment options via Schwab's brokerage option, a self-directed brokerage tool. Prior to October 3, 2024, certain participant accounts included shares of Hawaiian Holdings, Inc. company common stock. On September 18, 2024, Alaska Air Group completed its acquisition of Hawaiian Holdings, Inc. and all shares of Company stock held by the Plan were liquidated.

Note 1 - Continued

Vesting - Participants immediately vest in all contributions.

Payment of Benefits - Benefits are payable upon death, disability or termination of employment in a lump-sum payment or installments. Participants who have attained age 59½ may also elect to receive an in-service withdrawal of all or any portion of their vested account prior to termination of employment. The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by plan participants. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and distributions are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than the quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data correlation, or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time, and are valued based on this published price.

Self-Directed Brokerage Accounts - Accounts primarily consist of registered investment company funds, common stocks, and cash. Registered investment company funds consist of exchange-traded funds and mutual funds. Exchange-traded funds are valued at their last sale or official closing price on the exchange on which they are principally traded which approximates their NAV. Exchange-traded funds are registered with the Securities and Exchange Commission (SEC). Mutual funds are valued according to the methodology described above. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Cash is valued at cost plus accrued interest which approximates fair value.

During the current year, management reexamined the nature and characteristics of the collective trust funds held by the Plan and determined they would meet the criteria for a readily determinable fair value measurement and should be presented within the fair value hierarchy. This presentation has been retrospectively applied.

Note 4 - Tax Status

The Plan was amended and restated as of January 1, 2015. The Plan received a favorable determination letter from the IRS dated May 25, 2017. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax period in progress.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the written approval of the Air Line Pilots Association, International.

Note 6 - Related Party and Party-in-Interest Transactions

The Plan pays certain expenses related to plan operations to various services providers and issues loans to participants. These transactions are party-in-interest transactions. Transactions involving Hawaiian Holdings, Inc. common stock held by the Plan as of December 31, 2023 and for a portion of 2024 are related party and party-in-interest transactions.

Note 7 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except comparing such information to the related information included in the financial statements and supplementary information.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Subsequent Events

Subsequent events have been evaluated through October 7, 2025, the date the financial statements were available to be issued.
