INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Kesslers Diamond Center, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Kesslers Diamond Center, Inc. 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Voya Retirement Insurance and Annuity Company as of and for the years ended December 31, 2024 and 2023 and Johnson Bank as of December 31, 2024 and for the period February 1, 2024 through December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - Kesslers Diamond Center, Inc. 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through September 24, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Kesslers Diamond Center, Inc. is the plan sponsor, employer and plan administrator. Latitude Retirement was the third party administrator and tax counsel that performed various compliance tests through January 2024, Voya Retirement Insurance and Annuity Company ("Voya") was the investment agent that maintained participant records and held custody of the plan's pooled separate account assets through January 2024, Morningstar Associates, LLC was the plan's investment advisor through January 2024 and two officers of the plan sponsor functioned as the plan's trustees through January 2024. Effective February 1, 2024, Johnson Bank assumed the third party administrator, tax counsel, investment agent, investment advisor and trustee responsibilities. Johnson Bank engages Mid Atlantic Trust Company as a sub-custodian for the plan to hold and safeguard the plan's mutual fund investments. American Trust Company is used by Johnson Bank as a sub-service provider for the plan's record keeping. Voya holds custody of the plan's fixed account investment.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances to these investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports for more information.

Investments at fair value - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Voya separate accounts - The Voya separate accounts were valued at the NAV as provided by Voya. The NAV was generally based on the fair value of the underlying mutual fund investments held by the separate accounts less its liabilities. The NAV was used as a practical expedient to estimate fair value.

- (d) The objective of the specialty fund is to achieve long-term capital appreciation by utilizing the global real estate market segment.
- (e) The objectives of these funds are to provide capital appreciation and/or income consistent with the risk and return of growth, stock blend and emerging markets fund types utilizing various international market segments.

Investment at contract value - The plan has a fully benefit-responsive guaranteed investment contract through an annuity contract issued by Voya. Voya maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a stated amount of interest rate for the life of the contract. The contract provides two stated interest rates; a current rate, determined at least monthly, and a guaranteed minimum floor rate, determined at least annually. The guaranteed minimum floor rate may change after a defined period. The average yield earned by the fund was 1% in 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value. The plan has initiated the termination clause of the contract with Voya. As further defined in contract, the participant account balances will be transferred out of the fixed account investment at contract value over a period of years.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date the financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was established on October 1, 1995 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible once they have completed 60 consecutive days of service and have reached age eighteen. An employee can enter the plan on the first day of the month after meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to Internal Revenue Service limitations (elective deferral contributions). The plan also allows Roth elective deferral contributions. New employees are automatically enrolled in the plan and have 4% of compensation withheld as elective deferral contributions. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. Rollover contributions are accepted by the plan from other qualified plans.

- c. Matching contributions may be made equal to a discretionary percentage, determined by the employer's board of directors, of the employee's elective deferral contributions. The discretionary percentage was 25% of the first 8% of the employee's compensation contributed to the plan as elective deferral contributions in 2024 and 2023.
- d. Nonelective contributions may be made at the discretion of the employer's board of directors. No such contributions were made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options and change their deferral percentage at any time.

Vesting - Participants are always 100% vested in their employee elective deferral contributions, rollover contributions and related earnings. Participants become 20% vested in their employer contributions and related earnings upon one full year of service. The participant's vesting then increases at the rate of 20% per year. Upon death, disability or attainment of normal retirement age while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attaining the age of 59½. Distributions are generally required to be in the form of a single lump sum. Partial withdrawals or installments are only permitted for participants who must receive required minimum distributions. In addition, hardship withdrawals are permitted under certain circumstances.

Forfeitures - Forfeited nonvested employer contributions are used to pay plan administrative fees, used to reduce employer contributions or allocated to participants as additional employer contributions. Forfeitures used to reduce employer contributions were \$3,000 in 2024 and \$5,000 in 2023. There were no forfeitures allocated to participants in 2024. Forfeitures allocated to participants totaled \$5,000 in 2023. Forfeitures used to pay plan administrative fees were \$16,000 in 2024 and \$3,000 in 2023. Unapplied forfeitures were \$1,000 and \$4,000 as of December 31, 2024 and 2023.

Administrative fees - Certain fees and expenses of the plan are paid by the plan sponsor. Certain other fees and expenses are paid by the plan using plan assets and recorded as administrative expenses in the accompanying financial statements. Administrative expenses paid by the plan consist of participant directed charges for individual investment management services and participant loan and distribution processing fees and nonparticipant directed charges for certain administrative services. Nonparticipant directed fees, not paid using forfeitures, are allocated to participants on an account value basis.

Notes receivable from participants - Actively employed participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at any given time. The maximum loan term for a general purpose loan is five years. The loan terms may be extended if the loan proceeds are used to purchase a primary residence. As of December 31, 2024, the notes receivable from participants have various repayment schedules through December 2029 with interest rates from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Any transactions between the plan and the investment agents qualify as party-in-interest transactions. Direct administrative fees paid to the investment agents by the plan, included as a component of administrative expenses in the accompanying financial statements, were \$32,000 in 2024 and \$3,000 in 2023. The investment agents also provide certain administrative services to the plan pursuant to services agreements between them and the plan sponsor. The investment agents receive revenue in the form of indirect compensation (including service fees and commissions) from mutual fund service providers for services the investment agents provide to the funds. This revenue is used to offset amounts that would otherwise be owed to the investment agents by the plan for its administrative services to the plan. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

Prior to changing the plan's third party administrator during 2024 (see Note 1), the plan was operating under a Voya non-standardized pre-approved profit sharing plan that received a favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan adopted the AT Retirement Servies LLC pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

- c. Contributions to, withdrawals from, purchases and sales of investments and interfund transfers between accounts in 2024 and 2023.
