Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan for Employees of Community Health Resources, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Note 1 - Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Community Health Resources, Inc. (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution retirement plan established under Internal Revenue Code ("IRC") Section 403(b) covering all eligible employees of Community Health Resources, Inc. and its affiliated employers (collectively, referred to as the "Company"). Eligible employees may begin to make salary deferral contributions to the Plan immediately following their date of hire. Nonresident aliens and employees who are eligible to make salary reduction contributions to another qualified plan, as defined, are excluded from participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Finance Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions

Each year, participants make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined in the Plan, up to IRC limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan has also elected to allow participants to make additional Special Section 403(b) Catch-Up Contributions provided they have completed at least 15 years of service, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a guaranteed investment contract as investment options for participants.

The Company made contributions to the Plan for all nonunion employees equal to 3% of eligible compensation, as defined. The Company also made contributions to the Plan for all union employees equal to 5% of eligible compensation, as defined. Eligible employees must be at least 21 years old, have completed one year of service (with a minimum of 1,000 hours) and be actively employed on the last day of the Plan year to receive any employer contributions. Fee-for-service clinicians, per-diem staff and certain union employees, as defined by the Plan, are ineligible for these contributions.

The Plan also contains a provision for discretionary employer matching contributions and discretionary employer nonelective contributions. Fee-for-service clinicians, per-diem staff and certain union employees, as defined by the Plan, are ineligible to receive any discretionary employer contributions. Eligible participants must be at least 21 years old, have completed one year of service (with a minimum of 1,000 hours) and be actively employed on the last day of the Plan year to receive any discretionary employer contributions. For the year ended December 31, 2024, the Board of Directors elected to make a discretionary nonelective contribution to the Plan equal to a percentage of eligible compensation as determined by each participant's classification within the various groups defined by the Plan. There were no discretionary employer matching contributions made to the Plan for the year ended December 31, 2024. Participants direct the investment of all Company contributions. Contributions are subject to certain IRC limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and any discretionary matching contributions, as well as an allocation of any employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their salary deferral and any rollover contributions plus actual earnings thereon. In the event of termination due to death, disability or normal retirement, participants shall become 100% vested in the Company's employer contribution portions of their account. For all other participants, vesting in the Company's employer contribution portions of their account is based on credited years of service, as defined in the Plan, according to the following schedule:

Payment of benefits

On termination of service due to death, disability or retirement, a participant with an account balance of \$1,000 or less will receive a lump-sum amount equal to the value of the participant's interest in his or her account. For terminated participants with account balances greater than \$1,000, they may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account, select one of the annuities offered by the Plan or defer payments of benefits until a later date. For termination of service for other reasons, a participant may receive the value of the interest of his or her account as a lump-sum distribution.

Withdrawals from the vested portion of a participant's account may also be made in the event of termination of employment, upon reaching age 59½ and for a financial hardship, in accordance with the provisions specified in the Plan.

Forfeited accounts

At December 31, 2024 and 2023, the forfeited nonvested account balances were \$162,419 and \$17,025, respectively. Forfeited amounts will be applied in the following order. First, to pay any charge made in connection with the termination of employment of any participant whose termination resulted in the forfeiture and, any other charges which are past due. Second, if the employer so elects, to restore the forfeited portion of the accounts of reemployed participants in accordance with the Plan. Third, to pay reasonable Plan expenses as determined by the employer, and fourth, to reduce future employer contributions. For the year ended December 31, 2024, forfeited nonvested accounts of \$313,219 were utilized to reduce employer contributions.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and any matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Any nonelective contributions from the Company are recorded in the year in which the contributions are earned.

Investment valuation and income recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes dividends and the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain participant accounts are charged a monthly account maintenance fee which is included in administrative expenses. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

Reclassification

Certain amounts in the 2023 financial statements have been reclassified to conform to the current year presentation.

Subsequent events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification Topic 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Valued using the accumulation unit value, which is based on the fair value of the underlying assets of the accounts. The accumulation unit value is deemed equivalent to net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. In accordance with Subtopic 820-10, investments measured at NAV per share (or its equivalent) are not classified in the fair value hierarchy. Therefore, no fair value hierarchy table is included in the accompanying notes to the financial statements.

Note 4 - Investment contract with insurance company

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company via an investment in the Interest Accumulation Account totaling \$5,206,774 and \$4,862,063 as of December 31, 2024 and 2023, respectively. Mutual of America Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mutual of America Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer.

Note 5 - Plan loans

Participants are allowed to borrow from Mutual of America Life Insurance Company an amount up to 50% of the salary deferral contribution portion of their account balance in the form of a Plan loan. Plan loans are issued directly from funds owned by Mutual of America Life Insurance Company and not directly from a participant's account within the Plan. Adequate security is required and a portion of the participant's account is reserved, or held in collateral, to cover 120% of the outstanding loan in case of default. The collateral is held in the interest accumulation account in the participant's account. As of December 31, 2024 and 2023, the total outstanding Plan loans collateralized by individual participant accounts were \$301,337 and \$310,683, respectively, of which \$17,643 and \$22,072, respectively, were in default.

Note 6 - Related party transactions and party-in-interest transactions

Plan investments include units of pooled separate accounts and a guaranteed investment contract managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Expenses paid by the Plan directly to the custodian for administrative expenses amount to \$16,954 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans from Mutual of America Life Insurance Company using the vested interest in their accounts as collateral, which are also considered party-in-interest transactions.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Tax status

The Plan has been designed to qualify under Section 403(b) of the Code. The provisions of the Plan have been developed using an individually designed (nonprototype) 403(b) plan document sponsored by Mutual of America Life Insurance Company. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). Although the Plan has never received a determination letter from the Internal Revenue Service ("IRS"), the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is deemed to be qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company, the custodian of the Plan.

Note 11 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain salary deferral contributions were not remitted to the Plan within the time frame specified by DOL Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2024. The Company worked with its third-party administrator to correct these delinquent participant contributions and calculate lost earnings related to payroll periods during the year ended December 31, 2023. The Company made a corrective contribution of lost earnings related to these delinquent contributions that was deposited in the Plan and allocated to the affected participants in February 2025. The Company believes that these transactions should not affect the tax-qualified status of the Plan.
