Basis for Opinion

Note 1 – Description of the Plan

The following description of the Clark Group 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan established January 1, 2002 and most recently amended and restated on August 24, 2021 to formally adopt the provisions of the Coronavirus Aid Relief and Economic Security Act (CARES Act) effective as of January 1, 2020. It covers, immediately upon employment, all employees of Charles Clark Chevrolet and Clark Knapp Motor Co. (collectively the “Company”) who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participant’s elective deferrals each payroll period. Each year the Company determines the formula for the discretionary matching contribution. For the years ended 2024 and 2023, the matching contribution was of an amount equal to 10 percent of salary deferral up to the first 5 percent deferred. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of (a) Plan losses and (b) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their elective deferrals, including catch up contributions, and rollover contributions plus actual earnings thereon. Vesting in the Company’s contributions plus actual earnings thereon is based on years of continuous service, subject to a six-year graded vesting schedule. Participants will always, however, be 100% vested in the Company’s matching contributions if the participant is employed on or after their normal retirement age (65 years old) or upon termination due to death or as a result of becoming disabled.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50 percent of their vested account balance or \$50,000. The loan must provide at least quarterly payments under a level amortization schedule and Participant is required to enter into payroll deductions or repaid by the participant to the Company. In no instance may the term of the loan exceed five years unless the loan is for the purchase of a participant’s primary residence. Home loans may not exceed thirty years. The loans are secured by the vested balance in the participant’s account and bear interest varying between 4.25 – 9.50 percent, which is commensurate with the local prevailing rate as determined by the Plan administrator.

Payment of Benefits - Upon termination of service due to death, retirement, disability, or other reasons, a participant receives a mandatory lump-sum distribution if the vested account balance does not exceed \$5,000. If the vested account balance exceeds \$5,000, the participant may choose the method of distribution as specified in the Plan agreement.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,731 and \$18,392, respectively. Any forfeitures occurring during a Plan year may be used to pay administrative expenses under the Plan at any time, if so directed by the Plan administrator. Any forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce the contributions of the Company for the immediately following Plan Year. Plan expenses paid by forfeitures totaled \$0 for the years ended December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Financial Statement Presentation - The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates - In preparing the financial statements, the Plan administrator is required to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividends date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits - Benefits are recorded when paid.

Operating Expenses - Expenses of maintaining the Plan are paid by the Plan to the extent of forfeited non-vested accounts; the excess is paid by the Company. The Plan will assess against an individual Participant's account certain Plan expenses that are incurred by, or are attributable to, a particular Participant based on the use of a particular Plan feature.

Date of Management's Review - Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Recorded at cost, which approximates fair value.

Mutual funds: Valued at a daily calculated NAV and is traded at the settlement price established each day by the board of trade or exchange on which they are traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Company evaluates the significance of various inputs to assess the appropriate classification of the Plan's investments within the fair value hierarchy. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Transfers between levels are evaluated for their significance based upon the nature of the investment and size of the transfer relative to the net asset available for benefits.

Note 4 – Related Party Transactions

The Plan fully absorbs and is responsible for administrator fees, which totaled \$3,375 for the Plan year ended December 31, 2024. Forfeitures may be used to pay administrative expenses under the Plan at any time, if so directed by the Plan administrator. The Company fully absorbs the remaining administrative expenses which totaled \$26,130 for the Plan year then ended. These transactions are exempt party-in-interest transactions.

Certain employees of the Company, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Company with the most recent letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the most recent determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7 – Excess Contributions Payable

At December 31, 2024 and 2023, payables of \$24,801 and \$0, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service.

Note 8 – Concentrations

At December 31, 2024, all investments of the Plan are in mutual funds or in a money market account placed with Fidelity Management Trust Company, the trustee of the Plan.

Note 9 – Information Prepared and Certified by Trustee

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

The following information included in the accompanying financial statements as of December 31, 2024 and 2023 and the supplemental schedule of assets at December 31, 2024 was obtained from data that has been prepared and certified to as complete and accurate by the trustee, Fidelity Management Trust Company:

Note 11 – Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, market, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 12 – Subsequent Events

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 provisions include both required and optional elements. One mandatory provision increased the required minimum distribution (RMD) age from 72 to 73. Plan sponsors have until the end of the 2025 to adopt the necessary amendments. The plan administrator will determine the optional provisions to elect and amend the Plan document accordingly.
