## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PLM 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PLM 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ## 1. Plan Description

The following description of PLM 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is sponsored by Pacific Landscape Management, Inc. (the Employer) and is a defined contribution plan effective January 1, 2018, covering substantially all employees who are at least 21 years of age and not considered a part-time, temporary, or seasonal employee according to the Plan document. Eligible participants may enter on the first day of the plan year quarter coinciding with or next following date requirements met. The plan's most recent restatement was effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator oversees the governance of the Plan.

### Contributions

Each year, participants may contribute a portion of their compensation up to the limits provided by the Internal Revenue Code (IRC). Participants may elect their deferrals to be treated as pre-tax or after-tax (Roth). Individuals who attain age 50 by the end of the Plan year are eligible to make additional "catch-up" contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. All participant contributions shall be fully vested at all times.

The Employer contributes a Safe Harbor match equal to 100 percent of the first 3 percent and 50 percent of the next 2 percent of a participant's compensation contributed as deferrals. The Plan does allow the Employer to make a discretionary profit sharing contribution in addition to a discretionary match each year. There was no Employer discretionary profit sharing or match contribution for the years ended December 31, 2024 and 2023.

The Plan's investments are held in a trust fund administered by Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan. Upon enrollment in the Plan, a participant may direct employee contributions in any investment option provided by the Plan. Descriptions of the individual investment options are available from the Plan Administrator. Participants may change investment options at any time.

### Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the provisions of the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Plan Description, continued**

**Vesting**

Participants are vested immediately in their contributions and the employer Safe Harbor contribution, plus actual earnings thereon. The Employer's discretionary match and profit-sharing contributions are subject to a graded vesting schedule and participants become 100 percent vested after five years of credited service.

**Forfeited Accounts**

Amounts that are not fully vested when participants terminate from the Plan are forfeited. These amounts are used to pay Plan administrative expenses or offset future Employer contributions. There were no forfeitures for the years ended December 31, 2024 and 2023, and there were no forfeitures available for use as of December 31, 2024 and 2023.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, a participant or their designated beneficiary may elect to receive the vested value of their account in a lump-sum payment, substantially equal installments or partial withdrawal. Participants age 59½ or older may take in-service distributions of all or part of their vested account balance at any time. Hardship distributions are not permitted. On January 1, 2024, the Plan elected to allow for domestic abuse withdrawals, emergency expense withdrawals, and qualified declared disaster withdrawals under SECURE 2.0 Act.

**Participant Loans**

The Plan does not permit loans.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Employer's management determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

**2. Summary of Significant Accounting Policies, continued**

**Investment Valuation and Income Recognition, continued**

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses of the Plan are paid from Plan assets or from the balance of available forfeitures. Administrative expenses may also be paid by the Employer; these expenses are excluded from these financial statements. Investment related expenses are included in net change in fair value of investments.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are participant and employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**3. Fair Value Measurements, continued**

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Pooled separate accounts:* Recorded at fair value based on the stated net asset value (NAV) of the separate account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

*Common/collective trusts:* Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trusts measured at NAV have not been classified in the fair value hierarchy. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

*Registered investment companies:* The Plan's investments are units of mutual funds held within a group annuity contract. Quoted market prices are used to value each fund based on the NAV of shares held by the Plan at year-end. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded and have a readily determinable fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer discretionary profit sharing and match contributions.

**5. Tax Status**

The Plan has adopted the Pension Plan Specialists, PC Non-Standardized Pre-Approved Profit Sharing Plan with CODA. Pension Plan Specialists, PC, the sponsor of the Prototype Plan, has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and the related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified.

Although the plan has been amended since receiving the opinion letter, the Plan's tax counsel believes that the Plan is designed and currently is being operated in compliance with the applicable requirements of the IRC.

**5. Tax Status, continued**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. Party-in-Interest Transactions**

Certain Plan investments options are funds managed by Principal Life Insurance Company and Principal Trust Company, the custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan directly to Principal Life Insurance Company were \$17,110 and \$11,711 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**8. Information Certified by the Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Principal Life Insurance Company and Principal Trust Company, acting as the custodians for the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31:
