## Independent Auditor's Report

To the Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of McPherson Hospital, Inc. Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note A - Description of Plan**

The following description of the McPherson Hospital, Inc. Tax Deferred Annuity Plan (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan covers all eligible employees of McPherson Hospital, Inc. (the Employer). All employees, in accordance with the universal availability standards, may enroll in the Plan on their hire date.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan, including reviewing the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan was established with an effective date of January 1, 1987, and an amendment effective March 23, 2018, to allow the Plan to receive employer matching contributions. To be eligible for the employer matching contribution, an employee must be a plan participant, be at least 21 years of age and have completed one year of service. The amount of the employer matching contribution is discretionary.

The Plan was restated with an effective date of April 1, 2022, using an IRS pre-approved volume submitter plan document. This restatement allowed Roth deferrals under the Plan, but it did not make any other substantive changes to the Plan's operation.

2. Contributions

Participants may enter into an elective deferral agreement authorizing the employer to withhold a portion of such participant's compensation to deposit to the Plan, subject to the Internal Revenue Code Section 402(g) limits (\$23,000 for 2024). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan (\$7,500 for 2024). Participants may also make rollover contributions of amounts received from other tax-qualified retirement plans.

Effective on March 23, 2018, the Plan was amended to include employer matching contributions. On behalf of each participant elective deferral contribution made by the employee, the employer contributes to the Plan a matching contribution equal to 100 percent of such participant's elective deferral contribution up to 4 percent of compensation.

Effective on April 1, 2022, the Plan was restated to include Roth deferral contributions, which are also eligible for the employer matching contribution.

Effective January 1, 2024, the Plan was amended to include an automatic contribution deferral arrangement, whereby all newly eligible employees who are hired on or after January 1, 2024, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their salary deferral rate set at 4 percent of eligible compensation. A rehired participant is treated as a new employee if the participant is precluded from making automatic deferrals to the Plan for any period of time.

3. Participant accounts

Each participant's account is credited with the participant's contributions, the designated portion of the employer's contribution, and allocations of plan earnings. Allocations are based on participant earnings or account balances, as defined, and are credited as of the last day of the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Note A - Description of Plan - Continued**

4. Vesting

Participants are immediately vested in their salary deferral contributions, Roth deferral contributions, rollover contributions, and related earnings. Vesting on the portion of a participant's account balance attributable to employer matching contributions is based on years of credited service with the employer. The Plan provides for vesting of 20 percent after 2 years of service with annual vesting increases to 100 percent after 6 years of service. All contributions become fully vested if the participant attains early retirement age, enters normal retirement, becomes disabled, or dies.

5. Investment options

Upon enrollment in the Plan, a participant may direct contributions in one or any combination of investment options provided by the Lincoln Financial Group Trust Company, Inc. (the Plan's custodian), and may change the allocation at any time. The Plan does not have nonparticipant-directed investments.

6. Payment of benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. If the separated participant has a vested account balance of less than \$5,000 and does not elect to receive the vested benefit, a lump sum distribution will be automatically rolled over to an IRA selected by the Plan Administrator as soon as administratively feasible without the participant's election. A participant with a vested account balance in excess of \$5,000 may elect to receive the benefit to be paid in a lump sum distribution or keep the balance in the Plan. Participants may elect to receive the vested account balance in the form of a joint and survivor annuity, a lump sum payment, or a series of installment payments over a set number of years.

7. Forfeitures

Nonvested account balances are forfeited upon a participant's withdrawal from the Plan. Participant forfeitures are applied to reduce future employer contributions or to pay Plan administrative expenses. For the years ended December 31, 2024 and 2023, forfeitures of \$61,491 and \$15,615 were used to reduce employer contributions, respectively. No forfeitures were applied to Plan administrative expenses during 2024 and 2023.

**Note B - Summary of Accounting Policies**

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of accounting

The financial statements of the Plan have been prepared in conformity with generally accepted accounting principles as applied to pension plans, and in accordance with the plan agreement.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

3. Expenses

Certain expenses of maintaining the Plan are paid directly by the plan sponsor and, therefore, are excluded from these financial statements. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Other investment management fees are paid directly by the Plan for participants who elect to have their accounts managed.

4. Investment valuation and income recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note E for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Net appreciation (depreciation) in fair value of investments

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

6. Payment of benefits

Benefits are recorded when paid.

7. Contributions

Contributions from employees and the employer are recorded in the period in which the employer makes the payroll deductions from participant earnings.

8. Excluded contracts and accounts

The plan administrator has elected to exclude certain contracts and accounts from plan assets in accordance with DOL FAB 2009-02 due to the fact that:

- The contract or account was issued to a current or former employee before January 1, 2009;
- The employer ceased to have any obligation to make contributions (including employee salary reduction contributions) and, in fact, stopped making contributions to the contract or account before January 1, 2009;

- All the rights under the contract or account are legally enforceable against the insurer or custodian by the individual owner of the contract or account without any involvement by the employer; and
- The individual owner of the contract is fully vested in the contract or account.

9. Date of management's review and subsequent events

Subsequent events were evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**Note C - Related-Party and Party-in-Interest Transactions**

Plan investments were managed by Lincoln Financial Group Trust Company, Inc., the custodian of the Plan's assets. The Plan paid \$76,528 and \$70,052 of direct investment fees and recordkeeping fees to Lincoln National Corporation and Lincoln Retirement Services for the years ended December 31, 2024 and 2023, respectively. Prime Capital Investment Advisors, LLC provides investment advisory services to the Plan. Their fees are paid directly by the Plan, which were \$30,952 and \$29,590 for the years ended December 31, 2024 and 2023, respectively. Morningstar and Qualified Plan Investors provide investment management services to the Plan's participants. Their fees were paid directly by the Plan, which were \$36,162 and \$38,517 for the years ended December 31, 2024 and 2023.

These transactions qualify as party-in-interest transactions.

**Note D - Investment Contract with Insurance Company**

The Plan's investments include a group annuity contract with Lincoln National Life Insurance Company, which maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Lincoln National Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed by the Plan.

As described in Note B, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln National Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was 2.3 percent at December 31, 2024, and is based on an agreed-upon formula with the issuer, which cannot be less than one percent. Such rates are reviewed periodically for resetting.

**Note E - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets.
  - Quoted prices for similar assets or liabilities in inactive markets.
  - Inputs other than quoted prices that are observable for the asset or liability.
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
  - If the asset or liability has a specified contractual term, Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair market measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note F - Plan Termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will immediately become fully vested in their accounts, and Lincoln National Life Insurance Company shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

**Note G - Reportable Transactions under ERISA**

All plan assets are held by Lincoln Financial Group Trust Company, Inc., the Plan's custodian. The Plan had no loans or fixed income obligations in default at December 31, 2024. The Plan had no leases at December 31, 2024. The Plan had no assets in a common or collective trust fund at December 31, 2024.

**Note H - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note I - Information Certified by Custodian**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (the custodian of the Plan).

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note K - Income Tax Status**

On March 31, 2017, the Internal Revenue Service stated that the nonstandardized pre-approved agreement adopted by the Plan, as then designed, qualifies under Section 403(b) of the Internal Revenue Code (IRC). The Plan was most recently restated with an effective date of April 1, 2022, using an IRS pre-approved volume submitter plan document. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. Management is not aware of any uncertain tax positions taken by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note L - Subsequent Events**

The Plan was amended effective September 22, 2025, to change the in-service distribution age from 65 years-old to 59 1/2.
