### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the accompanying financial statements of Sidwell Friends School Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sidwell Friends School Defined Contribution Plan's financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state of federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Sidwell Friends School Defined Contribution Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sidwell Friends School Defined Contribution Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.





Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

**Note 1 - Description of Plan**

The following description of Sidwell Friends School Defined Contribution Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Sidwell Friends School (the "Company") covering substantially all full time employees with no age or service requirement. Entry dates are the first day of each month. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2018. The Plan was amended for the CARES Act provisions and the SECURE 2.0 Act provisions on July 12, 2022.

**Contributions**

The Plan is a qualified profit-based contribution plan established under the provisions of Internal Revenue Code Section ("IRC") 403(b) covering substantially all eligible employees electing to participate. The Plan is an automatic deferral contribution plan with a 3% deferral rate with no required escalation. The employees may contribute to the Plan annually up to the IRC limit set annually. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees are required to make mandatory employee contributions in the amount of three percent of compensation as a condition of continued employment once they reach age thirty and have three years of service. A discretionary contribution, to be determined by the Company, may also be made. The employee and employer contributions are subject to ERISA limitations. The Company provided contributions in 2024 and 2023 equal to seven to eleven percent of compensation based on service time.

**Participant accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings. Allocations are based on account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant's account is divided into sub-accounts known as a voluntary contribution account, an employer contribution account, and where applicable, a rollover contribution account.

**Investment options**

Upon enrollment in the Plan, participants may direct the custodian of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

**Participant Loans**

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined annually. Principal and interest are paid ratably through payroll deductions. The loans are owned by TIAA as they are issued with participant funds, and the participant account balances are used as collateral on the loans.

The contract loans are not shown in the Plan's statements of net assets available for benefits as the loans were not made from plan assets and are therefore not considered assets of the Plan. Loan interest rates were variable at prevailing interest rates and can be increased or decreased by TIAA. Principal and interest are paid ratably by the participant directly to TIAA. A default will be assessed against the portion of the loan collateral used to foreclose on all or part of any loan. The balances were \$62,615 and \$81,939 at December 31, 2024 and 2023, respectively. The range of interest rates at December 31, 2024 was 4.00% to 5.73% with the oldest maturity date of June 1, 2030.

**Forfeitures**

Forfeitures are reallocated to remaining members and used to offset the first employer contribution made after the forfeiture is determined. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$506 and \$482, respectively.

**Vesting**

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

**Payment of benefits**

On termination of service, a participant may elect either lump sum, installment payments, annuity, or ad hoc distribution. Inservice distributions are allowed at age 59 ½. Hardship distributions are allowed if requirements are met.

**Note 2 - Summary of Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles in the United States.

**Investment valuation and income recognition**

The Plan's registered investments, pooled separate accounts, and fixed annuity contracts are recorded at fair value. Shares of mutual funds and pooled separate accounts, managed by TIAA-CREF, are based on quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Non-benefit responsive fixed annuity contracts are valued at the underlying asset value in the insurance company general account. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

As described under FASB ASC 962-325-35 "*Plan Accounting – Defined Contribution Pension Plans*", the Plan values all fully-benefit responsive fixed annuity contracts at fair value, which is contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant notes are classified as distributions based upon the terms of the plan document. Interest income on participant notes receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Some of the administrative expenses are paid by the Company. Certain transaction fees are paid by the Plan.

**Credit risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Note 3 - Fair Value Measurements**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023. The presentation of investments valued based on the net asset value per share practical expedient has changed in accordance with accounting standard update ASU 2015-07.

*Registered investment accounts:* Valued at quoted net assets values of the shares actively traded on the market and held by the Plan at year-end.

*Pooled separate accounts:* Net asset value as reported by the investment manager based on the value of the underlying assets is the practical expedient.

Fixed annuity contracts: Net asset value of insurance company general accounts are obtained from the insurance company and are based on quoted prices and account balances of the underlying assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Investment in insurance company general account**

The Plan has a benefit-responsive investment contract in an insurance company general account. The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contribution purchases a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting interest rate was 5.25% and 3% percent at December 31, 2024 and 2023, respectively. Lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawals and transfers from contracts must be spread over ten annual installments (five annual installments for withdrawals after termination of employment). When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits. The contract value of the benefit responsive portion was \$34,522 and \$125,770 at December 31, 2024 and 2023. The Plan Loan Default Fund, which represents the collateral associated with defaulted plan loans, is also classified as a benefit-responsive investment contract in an insurance company general account. The balance in this fund was \$57,204 and \$54,353 at December 31, 2024 and 2023.

**Note 4 – Investment in insurance company general account (continued)**

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

**Note 5 – Plan Termination**

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 6 – Tax Status**

The Internal Revenue Service is currently not issuing determination letters on 403(b) plans. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits or any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**Note 7 – Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds and pooled separate account funds managed by the Custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for investment management services amounted to approximately \$24,923 and \$26,166 for the years ended December 31, 2024 and 2023. In 2024, investment advisor fees and audit fees were paid directly by the plan from the revenue credit account balance totaling \$144,453.

TIAA and CREF provide certain administrative services to the Plan pursuant to a Service Agreement between the Company and TIAA and CREF. TIAA and CREF receives revenue from investment service providers for services TIAA and CREF provide to the funds. Plan servicing credit income shared through TIAA and CREF for the year ended December 31, 2024 and 2023 totaled \$47,960 and \$30,529.

The Plan sponsors, owners, and key management are also participants in the Plan. Their account balances totaled less than 1% of the net assets available for benefits as of December 31, 2024 and 2023.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, (the trustees of the Plan).

**Note 9 – Prohibited Transaction**

During the plan year, the Sidwell Friends School Defined Contribution Plan paid certain administrative fees on behalf of the Sidwell Friends School Tax-Deferred Annuity Plan. This activity constituted a prohibited transaction under Internal Revenue Code Section 4975.

On April 1, 2025, the Defined Contribution Plan and the Tax-Deferred Annuity Plan were merged. As part of the merger process, available funds from the Sidwell Friends School Tax-Deferred Annuity Plan were applied to offset the prior administrative fees paid by the Defined Contribution Plan, utilizing remaining plan servicing credit income.

As a result of the prohibited transaction, an excise tax of \$2,370 is due. Management has filed, or intends to file, Form 5330, Return of Excise Taxes Related to Employee Benefit Plans, and remit the tax to the Internal Revenue Service.

**Note 10 – Subsequent events**

The Plan has evaluated subsequent events through July 27, 2025, the date the report is available for issuance. Effective January 1, 2025, the Sidwell Friends School Tax Deferred Annuity Plan will merge into this plan. As part of the merger, automatic enrollment and immediate eligibility will be implemented.
