**Note 1 - Plan Description**

The following brief description of The Houstonian Campus Value Sharing Plan (the Plan) is provided for general information only. Participants should refer to the plan document for more detailed information.

**General**

The Plan is a defined contribution plan which was established on May 1, 2023 for eligible employees of Houstonian Campus, LLC (the plan administrator and the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company is responsible for oversight of the operation and administration of the Plan, determines the diversification and appropriateness of the Plan's investment offerings, and monitors investment performance. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) serves as the Plan's trustee. Principal Life Insurance Company is the recordkeeper for the participant accounts.

**Eligibility**

Participation in the Plan is available for all eligible employees, as defined in the plan document, who are 18 years or older and who have been employed for one year, defined as having completed 1,000 hours of service during a consecutive 12-month period. The Plan includes a savings feature designed to permit the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC).

**Contributions**

Upon meeting the eligibility requirements, employees may receive employer contributions that are determined to be made at the Company's discretion.

The Company may elect to make discretionary non-elective contributions to eligible participants who are employed on the last day of the plan year. The contribution is equal to a discretionary amount as determined by class where each participant is in a separate class.

For the year ended December 31, 2024, the Company elected to make a contribution of \$1,500 per participant for each 1,000 hours worked by a participant during the 2024 plan year, with a maximum contribution per participant of \$3,000. The total contribution was \$1,370,803, which was remitted to the Plan subsequent to year end.

In addition to the contribution above the Company elected to make an additional discretionary contribution to each employee for their past employment with the Company. The total contribution was \$2,996,732 which was remitted to the Plan subsequent to year end.

**Vesting**

Participants are 100% vested in employer contributions and accumulated earnings thereon.

**Participant Accounts**

Under the Plan, earnings and losses are allocated to the participants' accounts on a daily basis according to an allocation formula provided in the plan document.

Upon enrollment in the Plan, a participant may direct Principal with regard to the investment of his or her account balances. Participants may change their investment options daily.

**Benefit Payments**

Distributions may be made to participants upon severance of employment or death. In-service distributions are allowed for participants who have reached the age of 59½, incurred a disability or incurred a financial hardship or for other reasons as permitted by the Plan. Upon termination, participants with an account balance of \$1,000 or less receive an automatic lump sum distribution from the Plan. For participants who terminate with an account balance of more than \$1,000 but less than \$7,000, the plan administrator makes a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to federal income tax on contributions and income earned.

**Note 2 - Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains and losses on investments sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

**Benefit Payments**

Benefits paid to participants or beneficiaries are recorded when paid.

**Excess Contributions Payable**

Amounts payable for contributions in excess of amounts allowable are recorded as a liability with a corresponding reduction to contributions.

**Administrative Expenses**

Distribution fees and certain other transactional fees are paid by the participant. All other administrative costs are paid by the Plan, unless paid by the Company at its discretion.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances and the amounts reported in the financial statements.

**Subsequent Events**

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained a certification from Principal as of December 31, 2024 and for the year then ended, that all of the information provided is complete and accurate. Information included in the accompanying financial statements, and the notes to the financial statements as to investments, investment income and all information in the supplemental schedule of assets (held at end of year) is presented in reliance solely upon this certification.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements, and the supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* These funds are valued daily, based on their quoted market prices.

*Common/Collective Trust Funds:* These funds are valued at their net asset value (NAV) as determined by the issuer, based on the value of each of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

**Note 6 - Federal Income Tax**

The pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan document has been amended since receiving its IRS letter; however, the plan administrator, through its adoption of the pre-approved plan document, believes that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in process.
