Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Vestas America Holding, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - Vestas American Wind Technology, Inc. established the Plan effective January 1, 1999. The Plan is a defined contribution plan covering all eligible employees of Vestas America Holding, Inc. (the Company) and any approved affiliate of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Transfer of Assets to this Plan - Effective January 1, 2023, the Vestas Offshore Wind US Inc. 401(k) Plan Trust (the "Offshore Wind" Plan) was merged into the Vestas America Holding, Inc. 401(k) Plan. The former Offshore Wind Plan participants are employees or former employees of the Company and were eligible to participate in the Vestas Plan prior to the merger, starting on their first date of employment with the Company. As a result, the investments of the Offshore Wind Plan were liquidated in the amount of \$137,998 and merged into the custodial accounts of Vestas America Holding, Inc. 401(k) Plan on January 3, 2023.

Contributions - Contributions consist of employee elective deferrals, discretionary employer matching contributions and non-discretionary safe-harbor matching contributions. Employee elective deferrals, employer matching contributions and non-discretionary safe harbor matching contributions are recorded in the year in which the employee contributions are withheld from compensation. Participants may voluntarily contribute up to 75% of their compensation, limited to \$23,500 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 and older may elect to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. For the years ended December 31, 2024 and 2023, the Company made non-discretionary safe-harbor match contributions of 100% of the first 6% of eligible compensation for all employees. In addition, contributions are subject to other limits under the IRS.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Participants have the option to direct their contributions and earnings thereon into a variety of investments. Each participant's account is credited with the participant's contribution, the Company's matching contributions and net plan earnings (losses), thereon. Participant accounts are valued daily. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting - Participants are immediately vested in all contributions and actual earnings thereon.

Payment of Benefits - On termination of service, death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account, or a single sum distribution of a portion of the vested account balance. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. If a participant's vested account is \$1,000 or less upon termination of employment, the entire vested interest will BE distributed in a lump sum payment to the participant, unless otherwise directed. If a participant's vested account exceeds \$1,000 and is not more than \$5,000 upon termination of employment, the plan administrator may automatically roll over the entire vested interest to an individual retirement account, unless otherwise directed by the participant.

Expenses - Administrative expenses may be paid by the Company. Administrative and investment expenses not paid by the Company are satisfied in part through fees received by the Plan through revenue sharing with the Plan's trustee, T. Rowe Price Trust Company, and the remainder charged to participant accounts based upon relative account values on a monthly basis. Fees for participants receiving distributions pursuant to a qualified domestic relations order and fees for early redemption of certain investments are charged directly to the participant's account and are included in administrative expenses. Expenses of Plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

ERISA Fee Account - The ERISA Fee Account accumulates amounts received from revenue sharing with the investments held by the Plan that the Plan uses to fund administrative expenses and employer match. The Plan received \$9,148 and \$24,761 for the years ended December 31, 2024 and 2023, respectively, from the revenue share arrangement. The ERISA Fee Account paid \$8,665 and \$24,929 in employer match in 2024 and 2023, respectively. The balance is unallocated and generally used in the succeeding Plan year. The balance in the ERISA Fee Account was \$3 and \$7 at December 31, 2024 and 2023, respectively.

Forfeited Accounts - There were \$4,086 and \$3,883 in forfeitures at December 31, 2024 and 2023, respectively. Any forfeiture of nonvested portions of the Company's contribution account balance is utilized to pay plan expenses or offset Company matching contributions. No forfeitures were applied to expense or employer contributions in 2024 or 2023. The Plan has a balance of excess employer contributions due to payroll corrections. These excess funds are used to reduce future employer matching contributions or pay Plan expenses. At December 31, 2024 and 2023 the balance in the excess employer fund amounted to \$5,292 and \$4,530, respectively. Excess employer contributions were not used to reduce Plan expenses or reduce employer contributions during 2024 or 2023.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared using the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Subsequent Events - The Plan's management has performed an evaluation of subsequent events through October 6, 2025, which is the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common trust funds: The Plan holds investments in the T. Rowe Price Stable Value Fund Schedule B (the Stable Value Fund), a common trust fund that is comprised primarily of fully benefit-responsive investment contracts. T. Rowe Price Trust Company is the trustee of the Stable Value Fund. The objective of the Stable Value Fund is to provide a diversified group of investments offering competitive levels of yield consistent with a stable fixed income methodology and the careful and prudent assumption of investment risk providing for preservation of capital stability and predictability of returns, liquidity to pay Plan benefit and high credit quality. The Stable Value Fund invests in other conventional, synthetic, and separate account investments contracts issued by life insurance companies, banks, and other financial institutions that invest in a portfolio of securities, primarily equity securities, money market funds and US treasuries.

Units in all common trust funds are valued based on the underlying investments, the majority of which are based on quoted prices. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in the common trust fund represents the value of the Plan's interests in the overall value of the common trust fund. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner. Investments in common trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity, then the fund may defer honoring any payment request until liquidity is sufficient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company, the trustee of the Plan.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are common trust funds managed by T. Rowe Price. T. Rowe Price is an affiliate of T. Rowe Price Trust Company, the trustee as defined by the Plan, and therefore, these investments represent exempt party-in-interest transactions. Fees for investment management services charged by the trustee are netted against Plan earnings and range from 0.20% to 0.37% of the average daily investment balance.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination all participants will become 100% vested in their accounts.

NOTE 7 – CONCENTRATIONS, RISKS, AND UNCERTAINTIES

The Plan provides for investments that are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There were four investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

NOTE 8 – TAX STATUS

The Plan document is a pre-approved profit sharing defined contribution plan sponsored by T Rowe Price Retirement Plan Services, Inc. The Plan document obtained a favorable opinion letter dated August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended and restated since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
