CAPITAL DISTRICT PHYSICIANS' HEALTH PLAN, INC. 401(k) PROFIT SHARING PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. THE PLAN

The following description of the Capital District Physicians' Health Plan, Inc. (Company, CDPHP) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees and part-time employees of the Company. Plan participants may contribute earnings through traditional 401(k) elections (pre-tax), Roth 401(k) elections (after tax), or a combination of both on the first day of the month following the date of hire and attaining the age of 21. These employees are eligible to receive a proportionate employer match, as defined. The Plan also includes a discretionary employer contribution to employees who have at least six months of service, 1,000 hours and are employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In September 2023, the Plan switched plan recordkeepers from Transamerica Retirement Solutions to Empower Retirement, LLC. At that time, the custodian of the assets transferred from State Street Bank and Trust Company and Transamerica Financial Life Insurance Company prior to the recordkeeping change to Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York.

Contributions and Contributions Receivable

Participants may contribute up to 75% of their annual compensation subject to certain limitations. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation, with annual automatic escalations of 1% until reaching a maximum of 15% of eligible compensation. Contributions are automatically invested in a Default Alternative fund until changed by the participant. The Company makes a qualified matching contribution to the Plan on behalf of the participants as a percentage of the employee's contribution. Effective January 1, 2024, the matching contribution is 50% of the participant's contributions up to 8% of annual compensation. Prior to January 1, 2024, the matching contribution was 100% of the participant's contributions up to 2% of annual compensation, plus 25% of the participant's contributions from 2% to 8% of annual compensation.

At its discretion, the Company may make employer profit sharing contributions to the Plan for each employee that meets the eligibility requirements. The employer did not make a profit sharing contribution to the Plan for the years ended December 31, 2024 and 2023.

There was no employer contribution receivable at December 31, 2024 and 2023 related to the aforementioned discretionary profit sharing contribution. For the years ended December 31, 2024 and 2023 the employer match receivable was \$156,906 and \$152,977, respectively.

1. THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the participant's share of the Company's contributions, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. Administrative expenses charged to participants, if any, are allocated in a manner deemed reasonable by the Plan administrator and that complies with applicable law. The entitled benefit is the participant's account balance subject to vesting.

Forfeitures

Forfeitures may first be used to restore participant's accounts, then to pay administration expenses of the Plan, and finally to reduce the employer profit sharing contribution. During 2024, net forfeitures and revenue sharing approximated \$188,300 and earnings from unallocated accounts amounted to approximately \$11,200. During 2023, net forfeitures and revenue sharing approximated \$270,000 and earnings from unallocated accounts amounted to approximately \$65,700. For the years ended December 31, 2024 and 2023, unallocated accounts used to pay administration expenses, reduce employer contributions and refunds amounted to approximately \$254,000 and \$56,700, respectively. As of December 31, 2024 and 2023, the balances of forfeited and other unallocated accounts available to restore participant accounts, pay administration expenses, or reduce future employer contributions were approximately \$223,000 and \$398,000, respectively.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings/losses thereon. Vesting in Company's match and discretionary profit-sharing contributions, plus earnings/losses thereon, is based on years of continuous service. A participant does not become vested until completing 3 years of service, at which point participants become 100% vested in employer contributions.

Investment Options

The Plan currently offers various mutual funds and collective trust funds, and one stable value guaranteed interest fund. Participants may change their investment options daily. Upon enrollment in the Plan, a participant may direct contributions in 5% increments in any of the investment options. For fund investment objectives, risks, charges and expenses, participants should contact the fund manager for a prospectus. All investments are participant directed.

Payment of Benefits

Upon termination, a participant is entitled to receive an amount equal to the value of the participant's vested interest in their account in a lump sum amount, monthly installment payments, or partial cash payments when requested. Benefits to terminated participants are recorded when paid.

Terminated participants under the age of 65 with account balances will, unless directed otherwise, have the vested balance automatically rolled over to a traditional IRA.

While employed, a participant may also withdraw his or her vested account balance on account of financial hardship, as defined in the Plan Document. All hardship withdrawals must comply with the rules relating to hardships which are uniformly applicable to all participants and be used to pay qualifying expenses of certain immediate and heavy financial need.

1. THE PLAN (Continued)

Administrative Expenses

Forfeitures may be used to pay the expenses for administering the Plan. Generally, any administrative expenses in excess of forfeitures are paid by the Company.

Notes Receivable from Participants

Participants may borrow from their account up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of their account balance. Generally, loan terms range from 1-5 years. If the loan is used to purchase a primary residence, the loan may be repaid over a reasonable period of time that may be longer than 15 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate of interest plus 1% (8.50% at December 31, 2024). Principal and interest is paid ratably through payroll deductions, which cannot be less frequently than quarterly.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of additions and deductions during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as deemed distributions based upon the terms of the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Financial Instruments Measured at Fair Value

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

- *Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2*: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Value based on quoted price in active markets.

Stable value fund - Value based on the fair value using the net asset value (NAV) practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

Collective trust funds – Valued based on the fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Financial Instruments Measured at Fair Value (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used in the prior year.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3. A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 3.

Payment of Benefits

Payment of benefits to participants are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of assets available for benefits.

3. FAIR VALUE MEASUREMENTS

At December 31, 2024, the Plan's investments are measured at fair value on a recurring basis and are valued within the fair value hierarchy as follows:

Stable Value Fund

Effective June 23, 2016, the Plan provided the New York Life Guaranteed Interest Account ("GIA"), a stable value fund managed by New York Life Trust Company ("NYLTC"), as an investment option to participants of the Plan. The GIA is a group annuity contract which consists of a broadly diversified fixed income portfolio within New York Life Insurance Company's ("NYLIC") general account and is intended to provide a stable crediting rate consistent with preservation of principal. Interest is accrued daily and credited monthly to the GIA and reflects the crediting rate declared in advance and guaranteed by NYLIC.

The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account. The interest crediting rate may not be reset more frequently than semi-annually after the first contract year. The crediting rate is subject to a minimum rate provision as provided in the group annuity contract, but may never fall below 1% after deduction for any expenses. Participant-initiated transactions are permitted on a daily basis.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as Plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment, however the Plan administrator deems these employer initiated events as not probable to occur.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of terminations is received by NYLTC at least 30 days but not more than 60 days prior to the intended termination date.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. PARTY-IN-INTEREST TRANSACTIONS

Transactions between Transamerica Retirement Solutions, State Street Bank and Trust Company, Transamerica Financial Life Insurance Company, Empower Retirement, LLC, Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York and the Plan qualify as party-in-interest transactions since these organizations provided custodial and recordkeeping services to the Plan during the reporting period.

A fully benefit-responsive investment contract was entered into and managed by Transamerica Financial Life Insurance Company, who is a related party of Transamerica Retirement Solutions, LLC, the recordkeeper of the Plan from January 1, 2023 through September 1, 2023. Therefore, transactions amongst this account qualified as party-in-interest transactions, which are exempt from prohibited transaction rules.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have notes receivable to the Plan qualify as party-in-interest transactions.

6. RECONCILIATION TO FORM 5500

Form 5500 is prepared on the modified accrual basis and the financial statements are prepared in accordance with generally accepted accounting principles (on the full accrual basis of accounting). Below is a reconciliation between the modified accrual and full accrual methods for the Plan:

7. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the Internal Revenue Code. A prototype document was used by the Plan to obtain its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. PLAN TRANSFER

Transfers from and to affiliated plans represent fund transfers made between the Plan and the Practice Support Services, LLC 401(k) Profit Sharing Plan due to an employment transfer. For the year ended December 31, 2024, transfers to the Plan totaled \$3,638 and for the year ended December 31, 2024, transfers from the Plan totaled \$191,225.

All participant elections effective immediately prior to the transfer under the Plan continued to apply in the Practice Support Services, LLC 401(k) Profit Sharing Plan until changed by the participant. Also, as a transfer (which differs from a rollover), all accounts under the Plan carried over into the Practice Support Services, LLC 401(k) Profit Sharing Plan retained their same character and treatment.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
