INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Hanalani Schools 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of August 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Hanalani Schools 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The Hanalani Schools 403(b) Plan ("Plan") is a OneAmerica Financial Partners, Inc. 403(b) Volume Submitter Plan adopted by Hanalani Schools effective September 1, 2017. The following is a description of the Plan that provides only general information. Participants should refer to the Plan adoption agreement for a complete description of the Plan's provisions.

General

The Plan is an Internal Revenue Code Section 403(b) defined contribution plan covering substantially all employees of Hanalani Schools. All employees of Hanalani Schools; other than non-resident aliens, student employees, and employees who normally work less than 20 hours per week (unless they work more than 1,000 hours during the plan year); are eligible to participate in the Plan at the date of hire with no minimum age requirement. Participants are eligible for employer contributions starting on the first day of each month following the day on which the participant completes two years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to make pre-tax or Roth employee salary deferral contributions to the Plan up to the lesser of their eligible compensation or \$23,000 and \$22,500 in 2024 and 2023, respectively, adjusted annually for the cost of living, plus catch-up contributions of \$7,500 and \$7,500 in 2024 and 2023, respectively, for employees age 50 and over. In addition, participants with 15 years of service may make special catch-up contributions, as provided in the Plan adoption agreement. Total contributions to each participant's account may not exceed the lesser of \$69,000 and \$66,000 in 2024 and 2023, respectively, or annual compensation, as defined.

Hanalani Schools makes discretionary contributions from its own funds in an amount equal to 100% of the participant's salary deferral up to 4% of their compensation for participants up to 10 years of employment and 5% for 11 years of employment or more. Such contributions amounted to \$127,389 for the year ended August 31, 2024. Subject to limitations as defined, participants are permitted to rollover account balances from another qualified retirement plan or account.

Participant accounts

Each participant's account is credited with (a) the participant's contributions, (b) Hanalani School's contributions, and (c) Plan earnings and appreciation. Each participant's account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative and mutual fund expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF THE PLAN - CONTINUED

Vesting

Participants are 20% vested in employer contributions, and the earnings thereon, after one year of service, an additional 20% each year thereafter, and 100% vested after five years of continuous service. Participant voluntary and rollover contributions, and the earnings thereon, are always 100% vested.

Participant loans

Participants may borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested portion of their account balance. The notes receivable and related interest must be repaid within five years unless the proceeds of the notes are used to acquire a principal residence. The notes are collateralized by the participant's account balance and bear interest at prevailing rates, which was 6% at August 31, 2024 and 2023. At August 31, 2024 and 2023, the Plan had notes receivable from participants of \$42,220 and \$53,732, respectively. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of benefits

The amount in each participant's account is payable upon normal retirement (at the age of 59-1/2), disability, death, or termination of employment. Participants may receive the entire value of their accounts in a single lump-sum payment or in periodic payments over their assumed life expectancy or other specified periods of time. Participant account balances that are less than \$5,000 will be paid out as a lump-sum distribution. Participants may elect to rollover their benefits to another qualified retirement plan or account.

Withdrawals

Active participants may withdraw all or a portion of their vested account balances as in-service distributions after attaining age 59-1/2, or as hardship withdrawals, by submitting a written application that is approved by the plan administrator. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined in the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS) and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Forfeitures

Termination of employment for reasons other than retirement, disability, or death results in a forfeiture of the nonvested portion of the participant's account balance. Forfeitures may be used to pay for plan expenses and/or reduce future employer contributions. Forfeitures of \$6,790 for the year ended August 31, 2024 were used to reduce employer contributions. At August 31, 2024 and 2023, there were no unallocated forfeitures.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments valuation and recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the insurance company. See note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments

Benefits are recognized when paid.

Expenses

Expenses are recognized when the related liability is incurred. Investment related expenses are included in net depreciation of fair value of investments from registered investment companies.

3. INSURANCE COMPANY CERTIFICATIONS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held as of August 31, 2024 and 2023, and earnings from investments, contributions, benefits paid to participants, and administrative expenses for the year ended August 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company ("AUL"), the insurance company of the Plan.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

FASB ASC 820-10, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

Level 1 inputs are quoted prices in active markets on the actual asset being valued. An active market has sufficient transaction activity to provide pricing information on an ongoing basis.

Level 2 Fair Value Measurements

Level 2 inputs are those other than quoted prices in Level 1 that are observable and include the following quoted prices on similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; observable inputs other than quoted prices such as yield curves, volatilities, prepayment speeds, or inputs derived principally or corroborated by observable market data by correlation or other means.

Level 3 Fair Value Measurements

Level 3 inputs are unobservable inputs for the asset reflecting internal assumptions used to arrive at an estimate or exit price. Those inputs are based on the best information available in the circumstances.

5. TAX STATUS

Hanalani Schools adopted the One America Financial Partners, Inc. 403(b) Volume Submitter Plan. The IRS has determined by letter dated November 22, 2017, that this Plan is designed in accordance with applicable sections of the Internal Revenue Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, Hanalani Schools has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100% vested in their accounts.

8. GUARANTEED INSURANCE CONTRACT

Guaranteed insurance contract consists of the AUL Stable Value Account (“SVA”), an interest-earning investment option backed by the general account assets of AUL, the insurance company of the Plan. AUL guarantees that interest will be credited at the higher of the rate guaranteed in the group annuity contract and the current rate declared by it. AUL may change the initial interest rate for future contributions. New contributions are guaranteed to earn the applicable initial interest rate for at least a one-year time period from the date contributions are made. Changes in the initial interest rate or in the interest rate for prior contributions will also be effective for at least one year. In no event will the interest rate ever be below the rate guaranteed in the group annuity contract. AUL bears the investment risk for the AUL Fixed Interest Account values and for paying interest.

Each year, at least 35 days prior to January 1, AUL declares a Guaranteed Rate for the SVA that applies to the subsequent calendar year. All monies in the SVA earn interest at the Guaranteed Rate in effect, which was 1.25% and 1.25% for the calendar years 2024 and 2023, respectively. The Guaranteed Rate shall never be less than the average 5-year Constant Maturity Treasury Rate reported by the Federal Reserve for the month of October of the calendar year immediately preceding such specific calendar year (rounded to the nearest 0.05%), minus 1.25%. This minimum guaranteed interest rate shall not be less than 1% nor greater than 3%.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan Administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement, unless certain provisions in the contract are met.

9. RELATED PARTY TRANSACTIONS

The Plan’s assets are administered by and in custody of AUL, the insurance company of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of Hanalani Schools, who receive no compensation from the Plan. Custodian and recordkeeping fees are paid by the Plan.

10. SUBSEQUENT EVENTS

Management has evaluated subsequent events through February 24, 2025, the date on which the financial statements were available to be issued.
