Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Retail Concepts, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Retail Concepts, Inc. 401(K) Plan's (the Plan) financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The Retail Concepts, Inc. 401(K) Plan (the Plan) was adopted effective January 1, 1986 and restated May 1, 2021 to establish a savings and investment plan for the exclusive benefit of the employees of Retail Concepts, Inc. (the Company) and their beneficiaries. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States (GAAP). Interest and dividend income are recognized when earned.

Estimates - The preparation of financial statements in conformity with GAAP requires the Company as Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for several investment options which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

Valuation of Investments - Registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In accordance with the policy of stating investments at fair value, net investment gain or loss is included in the carrying value of related investments in the statements of net assets available for plan benefits and the changes in the net investment gain or loss are reflected in the statement of changes in net assets available for plan benefits.

Participant Loans Receivable - GAAP requires that loans to participants be reported as a receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Federal Income Tax - The Company adopted a non-standardized pre-approved profit sharing plan with CODA (the Non-Standardized Pre-Approved Plan). The Non-Standardized Pre-Approved Plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Non-Standardized Pre-Approved Plan constitutes a qualified plan under Section 401(a) of the Internal Revenue Code (the Code) and is therefore exempt from federal income taxes.

The Plan has been amended since receiving the favorable opinion letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan Administrator believes the Plan was qualified and the related trust was tax-exempt as of December 31, 2024 and 2023.

NOTE A BASIS OF PRESENTATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES
(CONTINUED)

The Plan believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. As of December 31, 2024, the tax years that remain subject to examination by the major tax jurisdictions under the statute of limitations are from the year 2021 forward (with limited exceptions). Tax penalties and interest, if any, would be accrued as incurred and would be classified as tax expense in the statement of changes in net assets available for plan benefits.

Subsequent Events - The Company has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued. No subsequent events occurred which require adjustment or disclosure to the financial statements at December 31, 2024.

NOTE B PLAN DESCRIPTION

The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Participation - An employee (excluding union, leased employees, and independent contractors) is eligible to become a participant in the Plan on the first day of the month coinciding with or next following the completion of one year of service and attaining the age of 21. Upon becoming eligible, the employee is automatically enrolled in the Plan with 3% of compensation deferred from each payroll.

Contributions - Participants may elect to make contributions (including Roth 401(k) contributions) to the Plan in an annual amount ranging from 1% to 90% of their eligible compensation. Contributions are made through authorized payroll reductions. These contributions by individual employees are limited to \$23,000 in calendar year 2024. This limitation is adjusted periodically to reflect cost-of-living increases. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for calendar year 2024).

For each Plan year, the Company may elect to contribute a matching contribution equal to a certain percentage of each participant's contribution. There was no matching contribution for the year ended December 31, 2024. During 2024, the Company funded employer matching true-up contributions totaling \$715, net of forfeitures, for the 2022 Plan year and \$10,635 in employer corrective contributions for the 2020 and 2023 Plan years.

The Company may also make an additional contribution, in an amount determined solely at the discretion of the Directors. Such additional discretionary contributions, if any, are allocated pro rata to all participants who fulfill the participation eligibility requirements at the Plan year end based upon the proportion of the participant's compensation to the total compensation of all eligible participants. There was no additional discretionary contribution for the year ended December 31, 2024.

Each participant account is credited with the participant's contribution, the Company's contributions, and a pro rata share of the earnings of each fund in which the participant has invested.

NOTE B PLAN DESCRIPTION (CONTINUED)

Vesting - A participant is immediately fully vested with respect to the portion of their account attributable to participant contributions and related earnings. A participant becomes fully vested in Company contributions and related earnings upon the earlier of: (1) six years of service or (2) attainment of age 65. Additionally, a participant may become fully vested in the event of severance from employment as a result of death or disability. Vesting of 20% of Company contributions occurs upon two years of service, 40% upon three years of service, 60% upon four years of service, 80% upon five years of service and 100% upon six years of service.

Forfeitures of account balances not fully vested are applied to reduce Company matching contributions and Plan administrative expenses. Forfeited non-vested balances totaled \$1,046 and \$11,897 as of December 31, 2024 and 2023, respectively. During 2024, forfeitures totaling \$2,559 and \$19,096 were used to reduce Company matching contributions and pay administrative expenses, respectively.

Forms of Benefits - Benefits are recorded when paid. Distributions from the Plan will generally be made in one lump-sum payment. If the amount payable is \$1,000 or less, the participant may receive a lump-sum distribution as soon as feasible following the date of termination. If the amount payable is greater than \$1,000 but less than \$5,000, the participant's vested account balance will be directly rolled over as soon as practical, after notice to the participant, into an individual retirement account maintained by an entity selected by the Company. If the amount payable is greater than \$5,000, the participant must give written consent before the distribution can be made. Participants may elect to receive installments over a period of not more than their assumed life expectancy. A participant may be eligible for in-service distributions if the participant has reached the age of 59 ½. Participants may request an in-service distribution only from the portion of their accounts funded through salary deferrals.

Participant Loans - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 limited to 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and participant loans receivable. Loan terms range from 1 to 5 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates on loans outstanding at December 31, 2024 range from 4.25% to 9.50%. Principal and interest is paid ratably through periodic payroll deductions. Participants are permitted to have only one loan outstanding at any time.

Investments - Each participant directs the investment of their account into any of the investment options designated by the Plan Administrator.

Administration - The Company, as the Plan Administrator, may, at its discretion, pay the Plan's administrative expenses. A director of the Company is a trustee for the Plan. Any Plan expenses not paid by the Company will be paid by the Plan.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their employer contributions and related earnings.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE D FAIR VALUE DISCLOSURES

GAAP provides a framework for measuring fair value using a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value based upon whether the inputs to those valuation techniques are observable or unobservable. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical financial instruments and the lowest priority to unobservable inputs. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. These inputs are summarized in the three broad levels listed below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. All registered investment company investments are valued using Level 1 inputs.

Level 2 – Other significant observable inputs (including quoted prices in active or inactive markets for similar financial instruments), or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

NOTE D FAIR VALUE DISCLOSURES (CONTINUED)

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used during fiscal 2024 and 2023.

Registered investment companies are valued at the market value of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers in and/or out of the fair value categories during fiscal 2024 and 2023.

NOTE E PROHIBITED TRANSACTIONS

Employee contributions totaling \$1,160 were not timely remitted by the Company to the Plan as required by ERISA for the Plan years ended December 31, 2024. Because the Company was delinquent in forwarding these amounts and held them commingled with its general assets, the Company engaged in nonexempt prohibited transactions under ERISA Section 406. Delinquent contributions for the year ended December 31, 2024 have been corrected and are included in the schedule of delinquent participant contributions.
