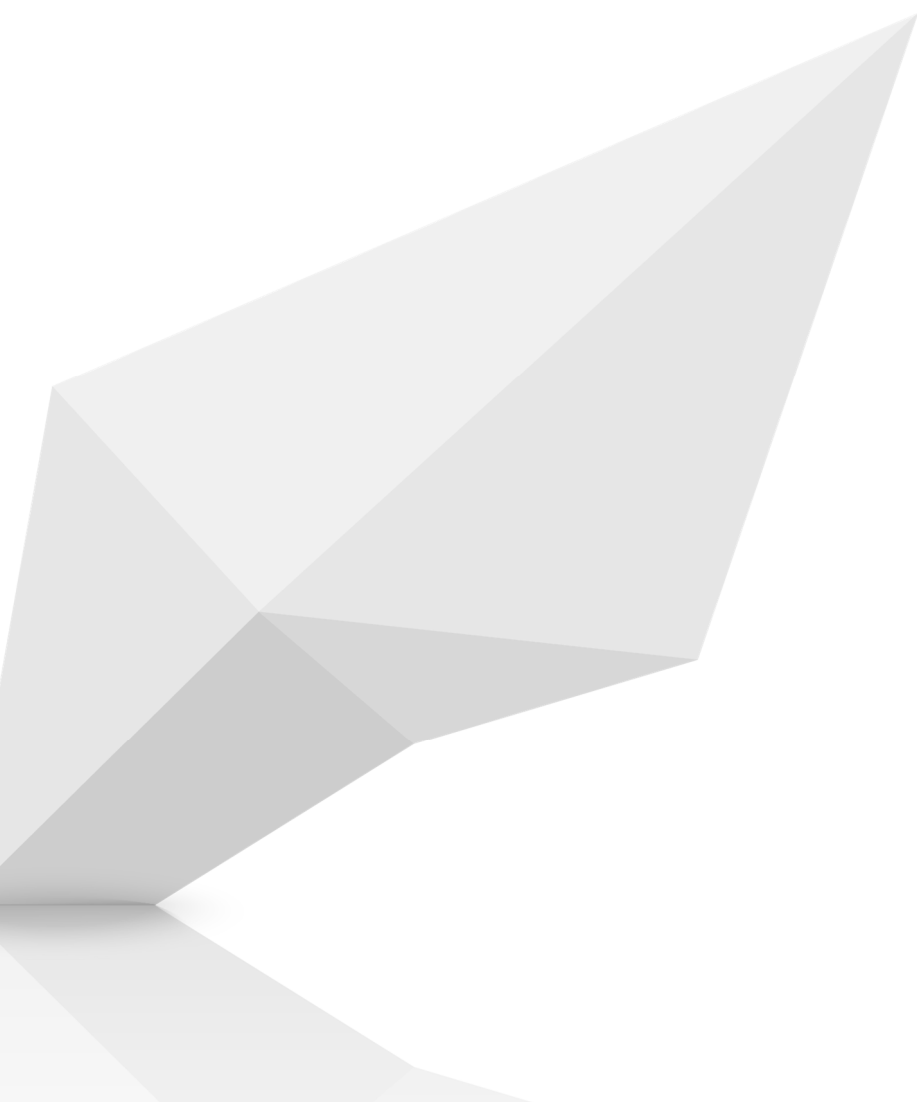

### Note 1: Description of Plan

The following description of the Muscogee Nation Gaming Enterprises 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Muscogee Nation Gaming Enterprises, LLC (the "Enterprises" or the "Company") which opened October 1, 2001. The Plan is managed by the Board of Directors of Enterprises (the Board). The Board serves as the overall manager of Enterprises' casinos, which include River Spirit, One Fire, Muscogee, Bristow, Checotah, Duck Creek, Eufaula, Holdenville, and Okemah casinos (collectively, the Casino). Employees of the Casino are covered by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). BOKF, NA is the trustee of the Plan and also serves as the Plan's contract administrator.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### Contributions

A full-time employee of the Enterprises may begin participation in the Plan beginning on the first day of the month following the completion of 60 consecutive days of employment. Participants are eligible for the employer discretionary matching contributions after completion of at least 1,000 hours of service in a consecutive period of 12 months. Plan entrance dates for the employer discretionary matching contributions are January 1, April 1, July 1, and October 1.

The Plan permits eligible employees through a salary deferral election to make pre-tax contributions of any whole percentage of their eligible compensation from 1% to 80%, as defined by the Plan. The pre-tax contributions and their earnings are taxable at the time of distribution. On the first entrance date following the employee becoming eligible to make salary deferrals, the Plan will automatically enroll participants at a 3% deferral rate unless the participant specifically elects a different percentage prior to the automatic enrollment date. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions.

The Company makes discretionary matching contributions to the Plan as determined by the Board. Discretionary contributions for the year ended December 31, 2024 equaled 100% of employee contributions up to 5% of employee eligible compensation. Contributions are subject to certain limitations.

The Plan also provides for discretionary profit-sharing contributions to be made as determined by the Board. For the year ended December 31, 2024, there were no discretionary profit-sharing contributions made to the Plan.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Participants have the right to direct the investment of their account balances, including their contributions and the Company's matching contributions, into any of the various investment options managed by and offered through BOKF, NA.

Participants have access to change their investment options daily over the phone or via an online portal.

Each participant's allocations of account is credited with the participant's contributions, the Company's discretionary contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or (losses) on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants are 100% vested in the discretionary employer matching contributions or profit-sharing contributions and the earnings thereon on a cliff vesting basis after three years of service, as defined. In the event of death or disability, the participant becomes 100% vested.

#### Notes Receivable From Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is \$7,500 or 50% of the vested account balance. In the event of a principal residence loan, the maximum allowable loan is \$25,000. The number of loans a participant may have outstanding at one time is one. All loans are secured by the balance in the participant's account and are repayable over a period not to exceed five years, unless the loan is for the purchase of the participant's principal residence, in which case the maximum loan term is 15 years. Interest on loans is based on the National Prime Interest Rate plus 2%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Upon severance of service due to death, disability, retirement, or termination, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or a direct rollover to another eligible retirement plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,373 and \$6,155, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, forfeitures used to pay plan expenses were \$63,823, from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Other Receivables**

Other receivables consists of securities traded before month-end, but not settled (sales proceeds coming in or purchase payment going out) as of month-end, are reflected in the asset holdings list whether purchased or sold. In order to not overstate or understate the account's cash position which will not change until trade settlement, the Due to Brokers / Due from Brokers are liability/receivable accounting entries to reflect pending trades that have been executed, but have not settled as of December 31.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

#### Subsequent Events

The Company has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust funds:* Valued at NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. These funds are stable funds and their NAVs are based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily.

*Common stocks:* Valued at the daily closing price as reported by the stocks. Common stocks held by the Plan are registered with the Securities and Exchange Commission.

*Interest-bearing cash:* Interest-bearing cash is made up of money market funds. Money market funds are valued at net asset value (NAV). The NAV is calculated daily.

## Notes to the financial statements

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, non-interest bearing cash, other receivables, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by BOKF, NA, the Trustee of the plan.

### **Note 5: Party-In-Interest Transactions**

Certain plan investments are units of collective trusts or shares of money market mutual funds managed by BOKF, NA or one of its wholly owned subsidiaries, Cavanal Hill Investment Management. BOKF, NA is the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue-sharing rather than a direct payment.

The Plan paid \$127,145 for fees related to general administration, record-keeping, and trust administration for services provided by the Trustee during the year ended December 31, 2024, which are included in administrative services.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
