INDEPENDENT AUDITOR'S REPORT

To The Board of Administration

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Princeton Acquisition, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - DESCRIPTION OF PLAN

The following description of the Princeton Acquisition, LLC (“Company”) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company and its affiliates who have completed three months of service and have also attained age 19. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Participants may elect to defer an amount of pretax compensation or post tax compensation (Roth deferral) as defined by the Plan subject to various limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contribution invested in a designated fund until changed by the participant. Also, the Company may contribute to the Plan matching contributions and discretionary profit-sharing contributions at the option of the Company’s board of directors and are invested in the portfolio of investments as directed by the participant. Since inception of the Plan, the Company has not made any matching or profit-sharing contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Company’s contribution (if applicable) as well as allocations Plan earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts (if applicable) is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

At the time a participant is entitled to receive a distribution under the Plan, the participant may elect to receive a single-sum payment, installments over a period of not more than life expectancy, or partial payments, equal to the value of the participant’s vested account balance.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment custodian and investment advisers. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

Note 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are the unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds are valued at the daily closing price on the active market as reported by the fund.

Pooled separate accounts are valued based on the Net Asset Value (NAV) of corresponding units of the pooled separate accounts. The estimated values are based on the fair value of the underlying assets owned by the pooled separate accounts and are generally based on observable inputs. NAV is a readily determinable fair value and is the basis for current transactions.

Note 4 – FIXED INCOME GUARANTEED OPTION

The Plan has available an investment option that is a Fixed Income Guaranteed Option, which is a traditional fully benefit-responsive contract with Principal Life Insurance Company (Principal) totaling \$2,247,367 and \$1,854,253 for 2024 and 2023, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest is credited at a rate not less than the guaranteed composite interest rate, as shown on the contract specifications. The interest crediting rate is declared on a semi-annual basis. The average credited rate for 2024 was 4.65%.

The Fixed Income Guaranteed Option meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for these contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is based on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Termination of the contract between Principal and the Company is subject to a 12-month advanced notice or a 5% surrender charge. Notice to terminate can be revoked for 90 days, after which, notice is irrevocable.

Note 5 – ROLLOVER CONTRIBUTIONS

Included in employee contributions for the year ended December 31, 2024, are rollover transfers of \$50,355 from participants.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, if applicable.

Note 7 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan changed custodians from Securian Financial to Principal Life Insurance Company in 2023. Principal Life Insurance Company managed the Plan assets during the entirety of 2024. Additionally, the Plan pays direct compensation to the third-party administrator related to recordkeeping and administration services. Indirect compensation is also paid to the custodian and is netted against net appreciation of assets. Transactions involving these investments and services are considered party-in-interest transactions; however, they are not considered prohibited transactions under the ERISA regulations.

Note 8 – NON-EXEMPT PARTY IN INTEREST TRANSACTIONS

The Plan Sponsor remitted the following participant contributions to the custodian subsequent to the date required by the Department of Labor Regulation 2510.3-102.

The Plan Sponsor, with assistance from Principal Life Insurance Company, calculated the earnings on the delinquent contributions that participants would have earned had the deposit been made timely. The Plan Sponsor remitted \$632 on August 19, 2024, to cover the lost earnings on the delinquent contribution. The Plan Sponsor originally deposited the funds timely, but the custodian returned the contributions in question without explanation in 2023. Upon discovering the error, contributions and lost earnings were immediately calculated and resubmitted to the Plan.

Note 9 - TAX STATUS

The Plan is an adoption of a volume submitter defined contribution plan that the Internal Revenue Service (IRS) has issued a favorable determination letter on dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes the Plan is designed, and is currently operating, in compliance with applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified and is exempt from Federal income tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Sponsor believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no examinations currently in progress. The Plan Sponsor believes that the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 10 – RISKS AND UNCERTAINTIES

The participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
