- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Description Of Plan**

The following description of the Clayton H. Landis Company Inc. ("Company") 401(k) Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**a) General**

The Plan is a defined contribution plan covering all full-time employees of the Company who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**b) Contributions**

The January 1, 2011 amendment established the Plan as a 401(k) plan under which employees can make pre-tax deferral contributions to their retirement accounts. As such, the Plan set up an automatic enrollment contribution plan whereby, unless affirmed otherwise, each employee once they become eligible to participate in the Plan will have his/her compensation reduced by 2% for each payroll period in which he/she is an active participant. The Company will then make a pre-tax deferral contribution for this amount on behalf of the participant to the Plan. The employee deferral percentage can be changed by the participant after the enrollment period. Participants are enrolled in the automatic enrollment plan three months following their date of hire if over age 21. Additionally, participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain Internal Revenue Code limitations. Participants direct the investment of their contributions into various mutual fund investment options offered by the Plan.

Beginning April 2018, the Company may, at its discretion, make matching employer contributions equal to one dollar for every dollar contributed by the employee up to 4% of the participants eligible compensation. Prior to April 2018, the Company may, at its discretion, make matching employer contributions equal to fifty cents for every dollar contributed by the employee up to 3% of the participants eligible compensation. Participants are 100% vested in both their employee deferral contributions as well as the employer matching contributions plus actual earnings thereon.

Additionally, the Company may contribute to the Plan a discretionary nonelective contribution, determined by the Board of Directors, not limited to current or accumulated net profits. In order to share in this nonelective contribution, the employee must have completed 1,000 hours of service during the Plan year, be 21 years of age or older and be employed on the last day of the Plan year. The employer nonelective contribution is allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. There were no discretionary nonelective employer contributions made to the Plan in 2024 or 2023.

Employees become vested in the employer discretionary nonelective contributions over the vesting period established by the Plan.

**c) Participant accounts**

Each participant's account is credited with the participant's contribution, employer matching contributions, if any, and allocations of (a) the Company's discretionary nonelective contribution (if any), (b) investment earnings, and (c) any remaining administrative expenses not absorbed by forfeitures. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**d) Vesting**

Vesting is based on years of continuous service. A participant is 100% vested in employer discretionary profit sharing contributions after six years of credited service. However, a participant is always 100% vested if he/she is employed on or after his/her normal retirement age, becomes permanently disabled or upon his/her death. Any nonvested portion of the participant accounts is forfeited by the employee and transferred to the unallocated forfeiture account when benefits are paid.

**e) Notes receivable from participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates at prime rate plus 1% for loans initiated prior to March 1, 2013 and prime rate plus 2% for loans initiated after March 1, 2013. At December 31, 2024 and 2023, participant loan interest rates ranged from 4.25% to 10.50%.

**f) Payments of benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution.

**g) Forfeited accounts**

Under the adopted 401(k) Plan, forfeitures can be used to offset employer matching contributions or administrative expenses of the Plan. For 2024 and 2023, the Plan had forfeitures of \$0 and \$0, respectively. Forfeitures are used to reduce the Company's employer matching contributions and to pay administrative expenses of the Plan. Employer contributions paid from the forfeiture account were \$0 and \$0 at December 31, 2024 and 2023, respectively. For 2024 and 2023, \$0 and \$0, respectively, was paid out of the forfeiture account for administrative expenses. At December 31, 2024 and 2023, the amount remaining in the unallocated forfeiture account is \$0 and \$0, respectively.

**h) Hardship withdrawals**

Hardship withdrawals are permitted under certain restrictions. If a hardship withdrawal is paid out, the employee is not permitted to make salary deferrals for a period of six months after they receive a hardship distribution.

**i) Administrative costs**

Administrative costs are paid by the Plan utilizing the forfeiture account. Third party administrator fees are paid by the Plan sponsor when the balance in the forfeiture account is not sufficient to cover these costs. For December 31, 2024 and 2023, the Plan incurred administrative costs of \$0 and \$0.

**Note 2 - Summary Of Significant Accounting Policies**

**a) Date of management's review**

For the year ended December 31, 2024, the Plan has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, which is the date the financial statements were available to be issued.

**b) Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**c) Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**d) Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

**e) Investment valuation and income recognition**

Investments are presented at fair value based on quoted market prices of the underlying securities within each fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**f) Payment of benefits**

Benefits are recorded when paid.

**g) Administrative costs**

For the Fidelity mutual fund accounts, fees are derived from the mutual fund's Rule 12(b)-1 fee, sub-transfer agency fees, investment management fees, annual maintenance charge (AMC) or other fees and vary between investment funds. Fidelity uses the revenue received from the 12(b)-1 fee, sub-transfer agency fees and investment fees to determine the AMC for that fund. For the majority of the funds, the sum of all fees will not exceed .50% of the fund balance. For the Fidelity Freedom accounts the maximum charge is .65% of the investment balance.

Fidelity also charges the Plan a flat fee for each new loan set up and delivery of the check. An annual maintenance fee is charged for each outstanding loan. These fees totaled \$1,388 and \$1,831 for 2024 and 2023, respectively. The Plan is also charged for return of excess contributions and automated minimum required distribution payments. Fees paid by the Plan, not utilizing the forfeiture account, are allocated at a flat dollar amount to all participants.

**Note 3 - Investments**

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,121,678, and appreciated in value by \$3,222,630, respectively.

FASB ASC-820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of other than the quoted prices in active markets that are observable either directly or indirectly and Level 3 which is based on unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs are only used when Level 1 or Level 2 inputs were not available. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from the corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Note 5 - Notes Receivable From Participants**

Participant loan payments are withheld from the employees through payroll deductions by the Plan sponsor and forwarded to the Plan weekly. There were no payments collected by the employer that were not remitted to the Plan at December 31, 2024 and 2023.

**Note 6 - Cash**

Cash at December 31, 2024 and 2023, represents total participant accounts invested in the FID Retirement Money Market Account.

**Note 7 - Benefits**

At December 31, 2024 and 2023, there were no unpaid benefits.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 9 - Tax Status**

The Plan was approved by the Internal Revenue Service in its most recent determination letter dated June 30, 2020. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 10 - Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
