### SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT OF THE 2024 FINANCIAL STATEMENTS

We have performed an audit of the financial statements of Rogers Group, Inc. & Affiliates Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following brief description of Rogers Group, Inc. & Affiliates Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution plan, covering substantially all eligible employees of Rogers Group, Inc. and certain of its affiliates (collectively, the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was established effective April 1, 1990, and has been amended and restated several times subsequent to its effective date to modify certain Plan provisions and comply with changes in applicable tax regulations. The Retirement Plan Investment and Administration Committee (the "Committee") is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees are eligible to participate in the Plan beginning the month after reaching age 21 and completing two months of service, as defined in the plan document.

In addition, employees become eligible for Employer contributions immediately following the later of the employee's completion of one year of service (1,000 hours) or attainment of age 21.

Effective January 1, 2019, members of the Bloomington Crushed Stone Union, Interstate and Gravel Union, Bloomington Shop Union and the Knox County Union became eligible to defer on their compensation. Effective January 1, 2020, members of the Mitchell Quarry Union and Sieboldt Quarry Union became eligible to defer on their compensation. These union members are excluded from receiving any Employer matching or nonelective contributions.

The Plan excludes union employees other than those noted above, independent contractors, leased employees and nonresident aliens.

Effective January 1, 2025, the Plan was amended to lower the eligibility to age 18 for both the participant deferrals and employer match.

Contributions

Each year, participants may elect to defer a minimum of 1% and a maximum of 80% of their compensation, as defined in the plan document. Participants may change their salary deferral percentage at any time. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides an automatic enrollment feature where newly eligible employees have 3% of their eligible compensation withheld and contributed to the Plan unless the employee elects not to make contributions or designates a different percentage. There will be annual increases on April 1st of each year in the automatic contribution percentage of 1% up to a maximum of 10% of the employee's eligible compensation. The Employer provides a safe harbor matching contribution of 100% of the elective salary deferral amounts on the first 3% of the participant's contribution and an additional 50% of the next 2% of the participant's contribution.

Eligible participants may designate a portion or all of their elective contributions as a Roth contribution (after-tax contribution).

The Plan also provides for the Employer to make a non safe harbor non-elective contribution for participants hired after December 31, 2003, who have completed one year of service, equal to 2% of the participant's compensation. Subsequent contributions are then made on a payroll-by-payroll basis. During 2024, \$4,196,692 of Employer contributions were made under this provision.

Effective January 1, 2025, the non safe harbor non-elective contribution was increased to 3% of the participant's compensation.

Under the profit-sharing component of the Plan, the Employer may contribute to the Plan a percentage of eligible participants' compensation during the Plan year. This discretionary percentage is determined annually by the Employer. The Employer did not make any profit-sharing contributions for the year ended December 31, 2024.

Rollover contributions from other qualified plans are only allowed from employees who have met the eligibility requirements.

Contributions are subject to certain limitations in accordance with applicable regulatory requirements.

Participant accounts

Each participant's account is credited with the participant's after-tax and pre-tax deferral contributions, the Employer's matching contribution, any rollover contributions, any base contributions (applicable to certain participants, as described above), and an allocation of (a) the Employer's profit-sharing contribution, if any, and (b) investment fund earnings, net of investment expenses. Each participant's account is charged with an allocation of investment losses, if any, and withdrawals. Allocations are based on participant earnings in investment funds, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting

Participants are immediately vested in their employee (pre-tax and after-tax), rollover, Employer match and other Employer discretionary contribution accounts. The Employer base contribution, which is made after one year of service, is vested based on continuous years of service. Participants hired prior to January 1, 2012, are 100% vested. Participants hired on or after January 1, 2012, will vest 25% per year beginning on year two and will become fully vested after five years are immediately vested in their contributions, Employer contributions and actual earnings thereon.

Forfeitures

Forfeitures result from termination of employment under circumstances which do not entitle the participant to be fully vested in his Employer contributions and are available to be used to reduce Employer contributions or pay plan expenses. Forfeitures of \$490,989 and \$419,157 were used to reduce Employer contributions for the years ended December 31, 2024 and 2023, respectively.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at one percentage point above the prime rate, as published in the Wall Street Journal, on the date the loan is initiated. Interest rates range from 4.25% to 9.50% on loans outstanding as of December 31, 2024, as determined by the Plan Administrator. Loan terms are for a maximum of 5 years, or longer if used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Interest rates on participant loans are required to be commensurate with current interest rates charged on loans made under similar circumstances by persons in the business of making loans.

Payment of benefits

Benefit distributions equal to a participant's vested account balance are payable to the participant or their beneficiaries upon normal retirement (age 65), death, disability or termination of employment. The method of distribution shall be determined by the Plan Administrator in accordance with the provisions of the Plan.

In-service withdrawals

In-service withdrawals are permitted by participants who have reached the age of 59 and 1/2 and can withdraw all or a portion of his interest in pre-tax or roth deferral, safe harbor match and Employer base contribution accounts. Early withdrawals may also be made in the case of financial hardship, as determined by the Employer.

Investment options

Participants direct the investment of their contributions into various investment options offered by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the investment advisers and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the participant contributions are withheld from compensation. Employer contributions are recorded in the year in which the contribution was allocated to the participant.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses as incurred.

No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefit payments are recognized in the year paid.

Expenses

Substantially all expenses of maintaining the Plan are paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Certain administrative expenses are paid by the Plan.

Recent regulatory update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

Events occurring after reporting date

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 10, 2025, the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified by Charles Schwab Trust Bank, the Trustee of the Plan.

NOTE 4 - FAIR VALUE

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using unadjusted quoted prices from active markets for identical assets), Level 2 (not traded on an active market, but for which observable market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets and liabilities measured at fair value:

Mutual funds	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
Collective trust funds	Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

NOTE 6 - INCOME TAX STATUS

The Plan has adopted a pre-approved plan document (Pre-Approved Plan). The Pre-Approved Plan received its latest opinion letter on September 21, 2020, in which the Internal Revenue Service ("IRS") stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has not applied for a separate determination letter.

The Pre-Approved Plan has been amended and restated since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan and Pre-Approved Plan are designed and have been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been provided in the financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in investment securities which are exposed to various risks, such as interest rate, credit and overall market risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

At December 31, 2024 and 2023, the Plan had a concentration of investments in five funds, which represented approximately 73% and 76%, respectively, of total investments.

NOTE 8 - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Plan investments are held by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, rather than a direct payment.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

During the year ended December 31, 2024, the Plan paid administrative expenses amounting to \$222,575 for recordkeeping services.

All other Plan administrative expenses for the year ended December 31, 2024, including fees incurred for professional services, were paid by the Employer and not charged to the Plan.

These party-in-interest transactions are exempt from the prohibited transactions provisions of ERISA and the IRC.
