## Report of Independent Auditors

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

December 31, 2024

### 1. Description of Plan

The following description of the Lavazza Professional North America, LLC 401(k) Plan (the Plan) provides only general information. Effective February 3, 2025, the Plan name was changed to Lavazza North America, Inc. 401(k) Plan. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Lavazza North America, Inc. (formerly Lavazza Professional North America, LLC) (the Company). All employees (except interns and nonresident aliens who received no income from sources within the U.S.) who are age 18 or older are eligible to enroll in the Plan. Eligible employees are automatically enrolled in the Plan at a contribution rate of 6% of eligible compensation unless they affirmatively elect not to participate in the Plan or change the rate of deferral. The Plan also provides for an automatic escalation feature by 1% on the first day of each Plan year up to 10% of eligible compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Ascensus Trust Company is the trustee (Trustee). Ascensus, LLC (Ascensus), as agent for the Trustee, serves as the record-keeper for the Plan.

#### Contributions

Each year, participants may elect to contribute a percentage of their annual compensation, as defined in the Plan, on a pre-tax or after-tax (Roth) basis up to the IRS limit (\$23,000 for 2024). Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions (\$7,500 for 2024). The Company makes a safe harbor matching contribution of 100% of each participant's elective contributions including any catch-up contributions up to 6% of the participant's compensation. In addition, profit-sharing contributions may be contributed at the discretion of the Company. No such profit-sharing contributions were made in 2024 or 2023.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options daily. Participants who are automatically enrolled have their contributions invested in the target date funds based on their age until they change their election. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

##### **Vesting**

Participants are 100% vested in their contributions and the Company's contributions plus actual earnings thereon.

##### **Participant Loans**

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. A participant may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% over the prime rate. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive either a distribution in the form of partial payments or a lump-sum amount or a rollover equal to the participant's vested interest in his or her account payments.

In-service withdrawals are available in certain limited circumstances, as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial hardship, as defined by the Plan.

### Notes to Financial Statements (continued)

#### **1. Description of Plan (continued)**

##### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. The Company pays the majority of the administrative expenses incident to the management of the Plan; however, certain costs can be paid from the assets of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Contributions**

Contributions from Plan participants and made by the Company are recorded in the year in which the participant contributions are withheld from amounts paid.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **3. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedules including investments held and notes receivable from participants at December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, and net appreciation in fair value of investments, interest income on notes receivable from participants, and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus.

#### 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in markets that are not active
  - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

#### 4. Fair Value Measurements (continued)

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used at December 31, 2024 or 2023.

*Mutual funds and money market fund:* Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Participant transactions (purchases and sales) occur daily without restrictions.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **6. Tax Status**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Party-in-interest Transactions**

The Company provides to the Plan certain administrative services for which no fees are charged.

#### **8. Subsequent Events**

Management evaluated subsequent events for the Plan through October 9, 2025, the date the financial statements were available to be issued.
