To the Trustees  
Delta-Sonic Savings and Investment Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements

We have performed audits of the financial statements of Delta-Sonic Savings and Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits – modified cash basis as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for plan benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delta-Sonic Savings and Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

## **1. Description of the Plan**

The following brief description of Delta-Sonic Savings and Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete descriptions of the Plan's provisions.

### **General**

The Plan is a safe harbor 401(k) defined contribution plan covering all non-excluded employees of Delta-Sonic Carwash Systems, Inc. who are age 21 or older. Excluded employees consist of part-time employees not exceeding 1,000 hours of annual service. The Plan is subject to the provisions of ERISA.

The Plan Sponsor is Delta-Sonic Carwash Systems, Inc. The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Contributions**

Each year, participants may contribute up to 90 percent of compensation, as defined in the Plan document, up to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other defined benefit or defined contribution plans. The Plan Sponsor will make safe harbor matching contributions equal to 100 percent of salary deferrals that do not exceed 3 percent of eligible compensation plus 50 percent of salary deferrals between 3 percent and 5 percent of eligible compensation. This safe harbor matching contribution is 100 percent vested. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan Sponsor may also provide a flexible discretionary matching contribution where the Plan Sponsor retains discretion over the formula used for allocating the match. This includes discretion over the matching rate, limits on deferrals or contributions subject to match, the per participant match allocation limits, the participants or categories of participants who will receive the allocation and the time period applicable to any matching formula.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, Plan Sponsor contributions, earnings as allocated and forfeitures of terminated participants' non-vested accounts. The account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. All eligible participants are immediately 100 percent vested in the Plan Sponsor's contribution portion of their account plus earnings thereon.

**1. Description of the Plan (Continued)**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms shall not exceed 5 years, unless the loan is for the purchase of a primary residence in which case the term shall not exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at the prime rate (prime rate was 7.50 percent at December 31, 2024) plus 1 percent, which is commensurate with local prevailing rates as determined by the Plan Sponsor. Principal and interest are paid ratably through payroll deductions and participants may only have one loan outstanding at any time.

**Benefit Payments**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or annuity equal to the value of the participant's vested interest in the participant's account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are provided for retirement at an attained age of 65, or may be deferred if the participant continues in active service with the Plan Sponsor. Benefits are also provided upon attainment of age 59½, or upon specific hardship.

**Forfeitures**

Forfeited non-vested accounts are used to reduce future Plan Sponsor contributions, administrative expenses or can be allocated to qualifying participants. At December 31, 2024 and December 31, 2023, forfeited non-vested accounts total \$693 and \$6,923, respectively. For the year ended December 31, 2024, administrative expenses paid by forfeitures totaled \$15,247.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting, which is an accepted method under the Department of Labor's Rules and Regulations and is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis of accounting differs from U.S. GAAP primarily because certain revenue and related assets have been recognized when received rather than when earned and certain expenses and related liabilities have been recognized when paid rather than when the obligations were incurred. This modified cash basis of accounting resulted in the recording of participant loans at cost plus accrued interest and investments at fair value on the statements of net assets available for plan benefits. Investment income, contributions and other plan income are recognized when received and disbursements, benefit payments and other plan expenses are recognized when paid. The financial statements are not intended to present the net assets available for plan benefits and changes in net assets available for plan benefits in conformity with U.S. GAAP.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

## **2. Summary of Significant Accounting Policies (Continued)**

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

### **Investment Valuation and Income Recognition**

Investments are stated at fair value as certified by the custodian, John Hancock Trust Company LLC. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the modified cash basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and requests for distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation/depreciation in fair value of the investments.

### **Subsequent Events**

The Plan has evaluated for subsequent events through October 6, 2025, which is the date the financial statements were made available to be issued.

## **3. Fair Value Measurement**

Fair value is the price at which an asset could be exchanged in a current transaction between knowledgeable, willing parties. Fair value measurements are categorized into one of three levels based on the lowest level of significant input used: Level 1 (unadjusted quoted prices in active markets); Level 2 (observable market inputs available at the measurement date, other than quoted prices included in Level 1); and Level 3 (unobservable inputs that cannot be corroborated by observable market data).

The following is a description of the valuation methodologies used for assets measured at fair value:

### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 3. Fair Value Measurement (Continued)

#### Common Collective Trust

Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities.

There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents information about Plan investments measured at fair value on a recurring basis as of December 31, 2024 and December 31, 2023, and indicates the fair value hierarchy of the valuation techniques utilized to determine such fair value:

### 4. Financial Certification (Unaudited)

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certification of certain financial information by the custodian in compliance with the audit requirements of the Act.

The following is a summary of the unaudited information included in the accompanying financial statements and supplemental schedule that was prepared and furnished to the Plan by John Hancock Trust Company LLC. The Plan has obtained a certification from John Hancock Trust Company LLC that such information is complete and accurate as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024.

### 5. Party-in-Interest Transactions

Certain plan investments are managed by John Hancock Trust Company LLC, who is the custodian for the Plan. In addition, the Plan uses UBS Financial Services, Inc. for investment advisory services. Transactions with these parties qualify as party-in-interest transactions. Fees paid by the Plan for administrative and professional services amounted to \$93,073 for the year ended December 31, 2024. Fees paid by the Plan for other investment management services are included in the net appreciation in fair value of the investments as they are paid through a fee levelization arrangement rather than a direct payment. The Plan Sponsor pays directly any other expenses related to the Plan's operations.

Notes receivable from participants qualify as exempt party-in-interest transactions as defined by ERISA. Interest earned on notes receivable from participants amounted to \$45,102 for the year ended December 31, 2024.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants would become 100 percent vested in the Plan Sponsor contribution portion of the participant's account.

**7. Tax Status**

The Plan uses a prototype plan document sponsored by John Hancock Retirement Plan Services LLC. John Hancock Retirement Plan Services LLC received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan itself has not received an opinion or determination letter from the IRS. Although the Plan has been amended since the custodian received the opinion letter, the Plan Sponsor believes that the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**10. Subsequent Event**

Effective January 1, 2025, the Plan was amended to exclude union employees covered under a collective bargaining agreement that does not require participation in the Plan, non-resident aliens and leased employees and allow part-time, temporary and seasonal employees to become eligible to participate in the Plan following the later of attaining age 21 or 1 year from their date of hire and removing the 1,000 hour requirement.
