Opinion

We have audited the financial statements of the Employment Transition Benefit Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its benefit obligations and net assets available for benefits for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Employment Transition Benefit Plan (Plan) of Olin Corporation (Olin or Employer) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is an employment transition benefit plan of Olin. The Plan is intended to supplement unemployment compensation and provide additional income during a job transition. The Plan is intended to qualify under Section 501(c)(17) of the Internal Revenue Code of 1986, as amended (Code). The Plan is subject to the applicable provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Plan is administered by the Welfare and Fringe Benefit Administrative Committee.

Eligibility

The Plan provides eligibility to United States employees upon their hire date, provided they are (i) full-time employees scheduled to work more than 20 hours per week on a continuous basis, (ii) are not represented by a collective bargaining agreement, and (iii) are employed by a participating employer and location who has adopted the Plan. Further, to be eligible for benefits under the plan, an employee must (i) have been terminated as a result of a reduction in workforce, plant shutdown, business closing, job elimination, or restructuring activity and (ii) qualify for state unemployment compensation. Additionally, eligible employees must sign a confidentiality agreement and release to be eligible for additional benefits under the Plan.

Benefit Payments

Benefits are based on a terminated employee's years of service and whether they have executed and not revoked a confidentiality agreement and release. Benefits are paid based on the Plan's defined benefit formulas. Benefits may also be paid to terminated employees who do not qualify and receive unemployment due to insufficient earnings, receipt of pension benefits that exceed the amount of unemployment benefits to which they would otherwise be entitled, exhaustion of state unemployment benefits, or failure to complete a waiting period for such benefits.

Trust Fund Management

The Plan is managed through a Voluntary Employees' Beneficiary Association trust (VEBA Trust) agreement between Principal Custody Solutions (Trustee) and Olin. Under the terms of the VEBA Trust agreement, the trustee is responsible for the safekeeping of Plan assets in the VEBA Trust and the maintenance of records relating to receipts and disbursements from the VEBA Trust, and the maintenance of accounting records and any other records relating to the VEBA Trust. Individual

participant recordkeeping and payroll transactions are handled by Total Management Solutions, Inc. (Recordkeeper).

Plan Termination

Although it has not expressed any intent to do so, Olin has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (United States).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Obligation

Benefit obligations are recorded when a claim has been reported and approved for payment. The benefit obligation represents future periodic payments that are attributable under the Plan's provisions to supplement unemployment compensation to any qualifying terminated participants. The obligation is adjusted annually for claims paid, new claims reported and approved for payment, state unemployment adjustments and employment adjustment for participants who are now employed and are no longer entitled to the benefits.

Employer Contribution Receivable

The Plan records a receivable from the Plan Sponsor in the statements of benefit obligations and net assets available for benefits when accrued expenses exceed the Plan's available cash.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Expenses such as trustee, recordkeeping, auditing, legal, and miscellaneous administrative fees are paid directly by the Plan or by Olin and are recorded as administrative expenses in the statement of changes in benefit obligations and net assets available for benefits. Expenses for services performed and not yet paid are recorded as accrued expenses in the statements of benefit obligations and net assets available for benefits. Certain administrative functions of the Plan are performed by officers or employees of Olin. No such officer or employee receives compensation from the Plan.

Funding Policy

The Plan is funded on an as needed basis from the general assets of Olin, including any benefit obligations in excess of net assets available for benefits.

NOTE 3. CHANGE IN ACCOUNTING BASIS

Effective December 31, 2024, the Plan changed its basis of accounting from a cash basis to accrual basis. This change constitutes a change in accounting principle and has been applied retrospectively to the prior period presented.

The impact of the change was to decrease cash by \$36,459, increase employer contributions receivable and accrued expenses by \$4,582, and reduce net assets available for benefits by \$36,459 as of December 31, 2023. The financial statements have been restated accordingly.

NOTE 4. TAX STATUS

The assets of the Plan are held in a VEBA Trust. The VEBA Trust funding benefits of the Plan received an exemption letter dated February 2, 1996 from the Internal Revenue Service stating that the VEBA Trust is exempt from federal income taxes under section 501(a) of the Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements. Although the Plan has been amended since receiving the exemption letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax position taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan had party-in-interest transactions with the Trustee of \$1,390 and with the Recordkeeper of \$13,874 for the year ended December 31, 2024.
