## INDEPENDENT AUDITOR'S REPORT

We have performed audits of the financial statements of Trijicon, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Summary of Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in conformity with generally accepted accounting principles.

Investments – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Contributions – Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses – Administrative expenses in the amount of \$12,303 are shown on the statement of changes in net assets available for benefits. This amount represents administrative costs paid to Fidelity Management Trust Company for recordkeeping services. The employer absorbs all other costs of the plan.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least probable that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Subsequent Events – The Company has evaluated events and transactions that occurred through October 8, 2025, which is the date the financial statements were available for issue.

**2. Plan Description**

The following description of the Trijicon, Inc. 401(k) Profit Sharing Plan & Trust is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – Effective January 1, 1994, Trijicon, Inc. (the Company), adopted the Plan, which is a defined contribution plan, covering substantially all employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Contributions to participants' accounts may be made through voluntary reductions in their compensation, rollover contributions from other qualified plans, as well as discretionary employer matching and profit-sharing contributions. Employees participating in the Plan may contribute up to 95% of their compensation up to the limit in effect for the year (\$23,000 in 2024). Participants aged 50 or older may make an additional “catch-up” contribution (\$7,500 for 2024). For the year ended December 31, 2024, the Company matched 50% of each participant’s elective deferral not to exceed 8% of the participant’s compensation, for a maximum match of 4% of compensation. Additional amounts may be contributed at the option of the Company’s Board of Directors.

The Plan includes an automatic enrollment provision, which enrolls newly eligible employees at a set pre-tax deferral contribution rate of 8.00% on their entry date, unless they elect otherwise. The Plan also includes an annual increase program, which increases deferral rates by 1% annually to a set maximum of 9%, for employees who have elected a deferral rate greater than zero, unless they opted out.

Eligibility – Employees of the Company who have attained the age of twenty-one years and have 2 months of service are eligible to participate in the Plan.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of the (a) Employer’s contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All contributions are invested based on participant-directed investment programs.

Investment Options – Upon enrollment in the Plan, a participant may direct employee contributions among various investment options. Participants may change their investment options at their discretion.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service according to the following schedule:

Forfeitures – Forfeitures may be used to offset administrative expenses of the Plan at any time. Any forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce employer contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested amounts totaled \$6,688 and \$14,187, respectively. During the year ended December 31, 2024, \$66,125 of the forfeitures balance was used to reduce the employer matching contributions.

**2. Plan Description (Continued)**

Payment of Benefits – Participants or their beneficiaries may receive distributions of their account balances in a lump sum upon the earlier of reaching age 59 1/2, permanent disability, death or termination of service, as defined in the Plan. Further, the Trustees may permit a participant who experiences a qualified financial hardship, as defined by the Plan, to receive a distribution of all or a portion of the participant's vested account balance.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

**3. Related Party and Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity Management Trust Company, the trustee, and therefore, these transactions are considered to be party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Certain administrative costs incurred by the Plan are paid by the plan sponsor. The Plan uses the staff, resources, and facilities of the plan sponsor to perform certain administrative activities related to the Plan. These transactions qualify as party-in-interest transactions. Participant notes receivable are classified as both related party and party-in-interest transactions.

**4. Tax Status**

The Pre-Approved Plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**5. Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. Certification of Financial Information**

The following information included in the accompanying financial statements and supplementary schedule as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan: investments at fair value, notes receivable from participants, interest and dividends, and net appreciation or depreciation in fair value of investments.

**7. Nonparticipating Participant Account Balances**

Included in the net assets available for benefits at December 31, 2024 and 2023 are balances due to participants who had terminated employment with the employer, as such they are no longer participating. These accounts are payable on request.

**NOTE:****8. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable input (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Cash and cash equivalents:* Valued at cost, which is fair market value for cash.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are op-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
