Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of APi Group, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects,

Basis for Opinion

Note 1 DESCRIPTION OF THE PLAN

The following brief description of the APi Group, Inc. (the Company and Plan Sponsor) Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

GENERAL

The Plan is a defined-contribution plan covering all full-time employees of the Company who have completed one year of service and are age 21 or older or are members of the Company's management trainee program and are not subject to a collective bargaining agreement. The Plan is an employee stock ownership plan (ESOP) and trust and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the trustee.

On October 1, 2019, the Board of Directors of APi Group, Inc. voted to terminate the Plan effective October 2, 2019. See further discussion in Note 7.

ELIGIBILITY

Employees of the Company and its participating subsidiaries were generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such plan year. Participants who did not have at least 1,000 hours of service during such plan year or were not employed on the last working day of a plan year were generally not eligible for an allocation of Company contributions for such year.

CONTRIBUTIONS

Each year the Company made discretionary contributions, at the option of the Company's Board of Directors, subject to IRS regulations. The Company did not make contributions to the Plan for the year ended December 31, 2024 due to the termination of the Plan.

DIVIDENDS

The Company was taxed as a Subchapter S corporation under sections of the federal and state income tax laws which provide that, in lieu of corporate income taxes, the stockholders separately account for the Company's items of income, deductions, losses and credits. There were no Subchapter S dividends paid to the Plan for the year ended December 31, 2024.

PAYMENT OF BENEFITS

On separation from service, a participant could have elected to receive either a lump-sum amount equal to his or her account, or annual or more frequent installments as conveniently determined, subject to the authority of an administrative committee to set limitations on the number of years over which distributions may be paid. The amount to be distributed was based upon the account valuation date immediately preceding the distribution. Distributions are paid in the form of a single payment or installment payments of cash. Benefit payments to participants are recorded upon distribution or when processed by the trustee. Distributions of the participants' account balances due to the Plan's termination began in 2020 and are expected to continue through 2025 in lump-sum payments.

ADMINISTRATIVE EXPENSES

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

VOTING RIGHTS

In limited circumstances, each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account and was notified by the Trustees prior to the time that such rights are to be exercised. The Trustees were not permitted to vote any allocated shares for which instructions were not given by a participant. The Trustees were required, however, to vote any unallocated shares on behalf of the collective best interest of the Plan participants and beneficiaries.

PARTICIPANT ACCOUNTS

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account was credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who were eligible employees of the Company as of the last day of the plan year received an allocation. Allocations were based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

VESTING

If a participant's employment with the Company ends for any reason other than retirement, disability, or death, he or she will be vested in the balances in his or her account based on total years of service with the Company. A participant's account became fully vested after six years of service with the Company under a graded vesting schedule. Management trainee accounts became fully vested after two years of service with the Company. Effective December 31, 2018, the accounts of all participants became 100 percent vested.

PUT OPTION

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

DIVERSIFICATION

Diversification was offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments which are more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan may have elected to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant could diversify up to 25 percent of the number of shares allocated to his or her account. In the sixth year, the percentage changes to 50 percent.

FORFEITURES

Forfeitures were first used to restore any amounts previously forfeited, then second, to pay non-settlor administrative expenses of the Plan, and lastly allocated to participants. Plan forfeitures were allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Because all participants became 100 percent vested on December 31, 2018, there were no forfeitures for the year ended December 31, 2024.

Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are presented in accordance with accounting principles generally accepted in the United States of America. On October 2, 2019, the Plan's board of directors approved the Plan for liquidation. Plan management determined that liquidation of the Plan is imminent. The Plan applied the liquidation basis of accounting for the years ended December 31, 2024 and 2023.

USE OF ESTIMATES

The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3 CERTIFIED INVESTMENTS

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by GreatBanc Trust Company (the trustee of the Plan), a qualified institution.

Note 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock: Common stock is valued at quoted prices in an active market.

Mutual funds: Mutual funds are valued at quoted prices in an active market.

Note 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invested in APi Group Corporation common stock. These transactions qualified as party-in-interest transactions. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments of \$24,856 to plan service providers which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 6 RISKS AND UNCERTAINTIES

The Plan investments consist primarily of APi Group Corporation common stock, which is exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with the investment, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits (in liquidation).

Note 7 PLAN TERMINATION

On October 1, 2019, the Board of Directors of APi Group, Inc. approved a resolution to terminate the Plan effective October 2, 2019. As a result, management determined that liquidation is imminent. The participants were notified of the termination, all participants were fully vested as of December 31, 2018, and the Plan began distributing participant accounts in 2020. Final liquidation has not been determined; participants are distributed funds based on the Plan document. Effective October 1, 2019, all the shares of the Company common stock held by the Plan were sold. The Plan will hold cash, cash equivalents, and publicly traded stock until the participant accounts are fully distributed.

Note 8 **TAX STATUS**

The Plan has received a final determination letter from the IRS dated August 13, 2020, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
