### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Pueblo Bank & Trust Company 401(k) Plan & Trust (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of the Pueblo Bank & Trust Company (Company) who have ninety days of service. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

##### Contributions

Each year, participants may contribute up to fifty percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching and profit-sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the participants. In 2024 and 2023, the Company matched employee contributions up to 4% of the employees' eligible compensation. Contributions are subject to certain limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent vested after six years of credited service.

In all instances, if a participant's vested account balance does not exceed \$1,000, it will be distributed in a lump sum as soon as administratively practical. In the event the vested account balance is between \$1,000 and \$5,000 the balance will be automatically rolled over to a qualified individual retirement account as soon as administratively practicable. However, if a participant's vested account balance exceeds \$5,000, it will be distributed at the time and in the form the participant elects. Such distribution may take the following forms: lump sum or installment payments made annually over a five-year period not exceeding the participant's life expectancy or the joint life expectancy of the participant and the participant's designated beneficiary.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$108,202 and \$87,389, respectively. These amounts are used to pay Plan expenses.

Subsequent Events

The Plan evaluates events occurring subsequent to the balance sheet date, through the date the financial statements are eligible to be issued, to determine whether the events require recognition or disclosure in the financial statements. If a subsequent event evidences conditions existing at the balance sheet date, the effects are recognized in the financial statements (recognized subsequent event). If a subsequent event evidences conditions arising after the balance sheet date, the effects are not recognized in the financial statements but rather disclosed in the notes to the financial statements (non-recognized subsequent events). The effects of subsequent events are only recognized if material, or disclosed if the financial statements would otherwise be misleading.

With respect to the December 31, 2024 financial statements, the Plan has evaluated subsequent events through September 29, 2025.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The amounts include unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Expenses of maintaining the Plan are paid by the Plan or by the Company.

The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

During 2024 and 2023, the Plan’s investments appreciated by \$922,465 and \$1,235,373, respectively. These amounts include unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Money Market/Bond/Lifecycle/Mutual Funds* – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**NOTE E - RELATED-PARTY TRANSACTIONS**

Certain plan investments are shares of funds managed by Fidelity. Fidelity is the Plan's trustee, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan allows the Company to pay any applicable expense charges and administration charges. Any amounts not provided for by the Company may be paid from the Plan.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their employer contributions.

**NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognized a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator does not believe there are any such uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **NOTES TO FINANCIAL STATEMENTS**

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Pueblo Bank & Trust Company 401(k) Plan & Trust (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering all full-time employees of the Pueblo Bank & Trust Company (Company) who have ninety days of service. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

##### Contributions

Each year, participants may contribute up to fifty percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching and profit-sharing amounts may be contributed at the option of the Company's board of directors and are invested in a portfolio of investments as directed by the participants. In 2024 and 2023, the Company matched employee contributions up to 4% of the employees' eligible compensation. Contributions are subject to certain limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is one hundred percent vested after six years of credited service.

Payment of Benefits

Payments of benefits are made upon retirement, disability, death, termination of employment or financial hardship. In all instances, if a participant's vested account balance does not exceed \$1,000, it will be distributed in a lump sum as soon as administratively practical. In the event the vested account balance is between \$1,000 and \$5,000 the balance will be automatically rolled over to a qualified individual retirement account as soon as administratively practicable. However, if a participant's vested account balance exceeds \$5,000, it will be distributed at the time and in the form the participant elects. Such distribution may take the following forms: lump sum or installment payments made annually over a five-year period not exceeding the participant's life expectancy or the joint life expectancy of the participant and the participant's designated beneficiary.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$108,202 and \$87,389, respectively. These amounts are used to pay Plan expenses.

Subsequent Events

The Plan evaluates events occurring subsequent to the balance sheet date, through the date the financial statements are eligible to be issued, to determine whether the events require recognition or disclosure in the financial statements. If a subsequent event evidences conditions existing at the balance sheet date, the effects are recognized in the financial statements (recognized subsequent event). If a subsequent event evidences conditions arising after the balance sheet date, the effects are not recognized in the financial statements but rather disclosed in the notes to the financial statements (non-recognized subsequent events). The effects of subsequent events are only recognized if material, or disclosed if the financial statements would otherwise be misleading.

With respect to the December 31, 2024 financial statements, the Plan has evaluated subsequent events through September 29, 2025.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The amounts include unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Expenses of maintaining the Plan are paid by the Plan or by the Company.

**NOTE C – INVESTMENTS**

The following is a summary of the Plan’s investments at fair value as of December 31, 2024 and 2023, which was prepared by or derived from information prepared by Fidelity, the trustee of the Plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

During 2024 and 2023, the Plan’s investments appreciated by \$922,465 and \$1,235,373, respectively. These amounts include unrealized gains and losses on investments held, as well as realized gains and losses on investments sold.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3           Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Money Market/Bond/Lifecycle/Mutual Funds* – Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

**NOTE E- RELATED-PARTY TRANSACTIONS**

Certain plan investments are shares of funds managed by Fidelity. Fidelity is the Plan's trustee, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan allows the Company to pay any applicable expense charges and administration charges. Any amounts not provided for by the Company may be paid from the Plan.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their employer contributions.

**NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognized a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator does not believe there are any such uncertain tax positions. The Plan may be subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
