Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ML Healthcare Management 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ML Healthcare Management 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ML Healthcare Management 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 9 of the financial statements, effective January 1, 2025, the Plan was restated and merged into a Pooled Plan. All funds of the Plan were transferred to the new trustee, and a new trust agreement was put into place. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ML Healthcare Management 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets Held at End of Year, December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to the Financial Statements

1. **DESCRIPTION OF PLAN**

The following description of ML Healthcare Management 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2021, the ownership structure of the Plan sponsor changed. This change opens the Plan to employees of the various other entities owned and operated by ML Healthcare Management, LLC. The name of the Plan was changed to the ML Healthcare Management 401(k) Retirement Savings Plan effective on the same date.

During December 2024, the lead Plan sponsor on behalf of all participating employers elected to become a participating employer in a certain pooled plan provider. The restatement and merger effective date of this change is January 1, 2025. Effective December 31, 2024, pursuant to a deconversion with its current recordkeeper and trustee, all plan assets were scheduled to be transferred to a new recordkeeper and trustee. See Note 9 for additional information.

General

The Plan is a defined contribution plan covering eligible employees of the entity who have six months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pre-tax or post-tax (Roth) annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The total deferrals in any calendar year may not exceed a maximum amount that is set by law. ML Healthcare Management contributes 10% per \$1, capped at 5% of gross compensation. Additional amounts may be contributed at the option of ML Healthcare Management's Board of Directors. Contributions are subject to certain limitations.

Participant Accounts

Participant accounts are maintained by Fidelity Management Trust Company. Each participant's account is credited with the participant's contribution and allocations of (a) the ML Healthcare Management's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Each participant directs how his account balance will be invested among the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the sponsor's matching and discretionary contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

Investment Options

Plan assets were invested during the year in money market and mutual funds with Fidelity Management Trust Company. All contributions credited to a participant are directed by the participant to various types of mutual funds. Participants may change their investment options at any time once they are enrolled in the Plan.

Expenses of the Plan

The administrative expenses of the Plan are allocated to participant accounts as a decrease in investment earnings.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a five-year period. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$12,472 (\$6,271 at December 31, 2023). Forfeitures are used to pay reasonable plan expenses first. The remaining forfeited accounts are used to reduce the employer match and then employer nonelective contributions. During 2024, forfeitures of individual account balances totaled \$5,018.

Participants Loans

Participants may borrow from their accounts. Participant loans must be a minimum of \$1,000, and cannot exceed \$50,000 or 50 percent of the participant's vested balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest is paid ratably through monthly payroll deductions. Past due accounts are deemed delinquent and are reported as distributions to the employee.

2. ACCOUNTING POLICIES**Date of Management's Review**

Subsequent events were evaluated through June 19, 2025, which is the date the financial statements were available to be issued.

Method of Accounting

The accompanying financial statements are stated on the accrual basis, and accordingly, include all material assets and liabilities of the Plan. Financial statement presentation generally follows the recommendations of the AICPA Industry Guide, "Audits of Employee Benefit Plans."

Cash and Cash Equivalents

Cash and cash equivalents consist of money market fund investing in a variety of short-term, high-quality debt securities. The potential for low risk and safety are important features of this fund. Investments include obligations of highly rated banks, including certificates of deposit, U.S. Treasury notes and bills, agency issues, and top-rated commercial paper.

Income Taxes

No amounts have been paid or accrued on the financial statements for income taxes. As of December 31, 2024, the Company's tax years for 2021, 2022, 2023, and 2024 are subject to examination by the tax authorities.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investments and Income Recognition

The investments of the Plan are stated at fair value as of the end of the year. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note 8 for information related to the Plan's valuation methodologies. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, ML Healthcare Management has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

4. INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by Fidelity Management Trust Company, the Trustee, which included total investments as of December 31, 2024 and 2023, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, line 4i—schedule of assets (held at end of year).

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the manager and trustee, Fidelity Management Trust Company, has received notification from the IRS that the plan they provide meets the determination of a qualified plan. The Plan follows this pre-approved plan and is qualified under that determination.

7. RELATED PARTY TRANSACTIONS

Plan investments are interests in money market and mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$8,619 for the year ended December 31, 2024.

8. FAIR VALUE MEASUREMENTS

Certain provisions of Accounting Standards Codification (“ASC”) 820 established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1—Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2—Inputs to valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted market prices that are observable for the asset or liability
 - Inputs that are derived principally from or are corroborated by observable market data, by correlation or other means
 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Money Market and Mutual Funds

Investments in money market and mutual funds are valued based on published market prices, which represent the net asset value (“NAV”) of shares held at year-end (Level 1).
