**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Barona Employees 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan covers substantially all employees of Barona Band of Mission Indians (federally-recognized Indian Tribe) (Tribe). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Retirement Committee is responsible for oversight of the Plan as well as determining and reviewing the appropriateness of the Plan's investment offerings, and investment performance. The Tribe contracted with Transamerica Retirement Solutions Corporation to provide plan recordkeeping, administrative and investment services and to provide Trustee services through their agent, State Street Bank and Trust Company.

The Plan is a defined contribution plan under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan became effective on January 1, 2000 and was restated in its entirety effective August 1, 2021.

**Eligibility**

Generally, an employee is eligible to participate in the Plan, upon attaining age 18 and completing 90 days of service. Employees can enter the Plan on the first payroll on or after they become eligible.

**Participant Contributions**

Participants may affirmatively elect to contribute up to 100% of their annual compensation into a pre-tax deferral account and/or an after-tax Roth account up to the maximum allowed by the IRS limitation. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. As of May 1, 2024, the plan has been amended to introduce Automatic Enrollment for eligible participants at a rate of 4%.

**Employer Contributions**

The Tribe may provide for a discretionary matching contribution. The Tribe will match 50% of the first 4% of eligible compensation contributed by participants.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Tribe's contributions, (b) plan earnings, and (c) allocated administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**

Participants direct the investment of all assets, offered by the Plan, in the portions they select. Each participant designates the percentage of any one or more of their accounts that is to be invested in each of several authorized investment funds designated by the Plan's Retirement Committee.

**Payment of Benefits**

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a partial or lump-sum distribution, installment payments, direct rollover to an individual retirement account (IRA) or to another employer's tax qualified plan. Active participants may withdraw a part of their account in a single sum in the event of undue financial hardship or attainment of age of 59 ½ or an in-service distribution from their rollover account at any time. If a terminated participant's account is \$5,000 or less, the Plan may distribute the account balance in one lump sum to an IRA without prior approval of the participant.

**Vesting**

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Tribe's matching contribution is based on years of continuous service. A year of service is obtained with the completion of 1,000 hours of service during a year. A participant is vested in the Tribe's matching contribution based on the following schedule:

**Forfeited Accounts**

Generally, a participant's unvested portion of the Tribe's matching contributions is forfeited upon termination of employment. Forfeitures are maintained in a separate account and can be used to reduce Tribe matching contributions or pay Plan expenses.

Non-vested forfeited account balances at December 31, 2024 and 2023 were \$78,420 and \$30,377 respectively. Forfeitures of \$26,021 were used by the Tribe during 2024 to pay for the Plan expenses.

**Administrative Expenses**

Substantially all administrative expenses are paid directly by the Tribe or deducted from non-vested forfeited accounts. Expenses that are paid by the Tribe are excluded from these financial statements.

Certain investment management fees and other charges paid to the Trustee are offset against fund performance in the net appreciation section of the Statement of Changes in Net Assets Available for Benefits and are not, therefore, separately reflected as investment expenses. The Plan utilizes a reimbursement spending account to collect third party investment management fees from each participant's account then periodically pays the investment advisor. Fees totaling \$159,244 were paid to the investment advisor from this account in 2024 and included in administrative expenses.

**Plan Termination Provision**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become fully vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (GAAP). Employee and employer contributions are recognized in the period that contributions are due.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Retirement Committee to make estimates and assumptions that may affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments, other than the Guaranteed Interest Account and Guaranteed Investment Option, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Retirement Committee determines the Plan's valuation policy utilizing information provided by the Plan Trustee. See Note 3 for discussion of fair value measurements. The Guaranteed Interest Account and Guaranteed Investment Option are fully benefit-responsive; therefore, contract value is the relevant measure for reporting purposes because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair

value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits to Participants**

Benefits are recorded when paid.

**Reclassifications**

Certain accounts from the prior year may have been reclassified to conform to the current year presentation.

**NOTE 3 - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily closing price and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at NAV per unit of the bank collective trust. The NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. This unit value/NAV cannot be independently verified on the open market due to the unit value and multiple underlying securities. Since NAV is a readily determinable value, it is included in the fair value hierarchy table.

**NOTE 4 - GUARANTEED INTEREST ACCOUNT**

The Plan's investment offering included a prior fully-benefit responsive contract fund, the New York Life Insurance Guaranteed Interest Account (GIA). The GIA is a stable value investment option with a guarantee of interest provided by New York Life Insurance Company (New York Life). As of December 31, 2024 and 2023, the contract value of the investment in insurance contract was \$4,058,507 and \$6,910,561, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Participants cannot transfer their New York Life Insurance Company Guaranteed Interest Account balances to competing fixed income funds, such as money market funds, short-term bond funds, or brokerage windows. Balances transferred from the New York Life Insurance Company Guaranteed Interest Account to non-competing funds cannot be transferred to competing fixed income funds for 90 days, but may be transferred back to the New York Life Insurance Company Guaranteed Interest Account at any time. There is a five percent annual corridor limit on participant withdraw that are a result of an employer - initiated event.

Effective September 27, 2023 the GIA contract with New York Life was terminated and the investment option is currently frozen. Participants cannot transfer from GIA to Transamerica Guaranteed Investment Option (TGIO) and must transfer to a non-competing fund for 90 days. After five years, remaining funds can be moved without cost.

**NOTE 5 - GUARANTEED INVESTMENT OPTION**

In September 2023, the Plan replaced the GIA with another fully-benefit responsive contract fund offering, TGIO. The TGIO is a stable value investment option with a guarantee of principal and interest provided by Transamerica Life Insurance Company (TLIC). As of December 31, 2024 and 2023, the contract value of the investment in insurance contract was \$3,362,084 and \$2,000,471 respectively.

At December 31, 2024, the credited rate was 4.75% , this option features a portfolio interest rate design where all deposits receive the same interest rate, which is credited daily. There is no fixed maturity for these deposits. The effective credited interest rate is determined according to the contract provisions.

Participants are not allowed to transfer funds to competing fixed funds, which may include money market funds, short-term bond funds, self-directed brokerage options, or other stable value funds. Transfers to non-competing fixed funds must remain untouched for 90 days before they can be moved to competing fixed funds. Any withdrawals or transfers made by the Employer or participants, except for benefit-responsive withdrawals, may be subject to restrictions or adjustments as per the contract. TLIC will notify participants at least 30 days in advance of any interest rate changes. Additionally, TLIC may implement a delay on withdrawal and transfer requests from all plan sponsors in certain situations. The Plan Administrative Committee does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

**NOTE 6 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Retirement Committee has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company (agent of Transamerica Retirement Solutions Corporation), the Trustee, has certified to the completeness and accuracy of:

- Investments and receivables reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, expenses, and interest reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Transamerica Retirement Solutions Corporation and its agent, State Street Bank and Trust Company; therefore, these transactions are considered to be exempt party-in-interest transactions. Plan administrative expenses paid to service providers directly by the Plan are considered exempt party in-interest transactions.

**NOTE 8 - TAX STATUS**

The IRS has informed the Plan sponsor in a letter dated June 30, 2020 for the prototype plan adopted by the Plan, that the Plan and related trust are designed in accordance with applicable sections of the IRC defined in Note 1. Although the Plan has been amended since receiving the opinion letter, the Plan Retirement Committee believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the Plan Retirement Committee to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.
