## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee and Participants  
of the Unanet Technologies Capital Accumulation Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Unanet Technologies Capital Accumulation Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Unanet Technologies Capital Accumulation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. DESCRIPTION OF THE PLAN

The following description of the Unanet Technologies Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing plan sponsored by Unanet Technologies (the Company), as detailed in the Plan document, and was established on January 1, 2009. The Plan covers all eligible employees of the Company excluding employees covered by a collective bargaining agreement (unless the agreement requires the employees to be included under the Plan), leased employees, and nonresident aliens with no income from a U.S source. Employees meet eligibility requirements of the Plan if they have attained 21 years of age. Employees are allowed to enter the Plan immediately upon meeting all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended January 1, 2024 to exclude payments on student loans from the definition of compensation. Effective September 1, 2024, the Plan was amended to allow for participants to continue to pay off loans from the Plan after they are terminated.

#### **Participant Contributions**

Participants may elect to contribute on a tax-deferred or Roth basis up to 90% of their eligible compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code which totaled \$7,500 for the year ended December 31, 2024. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Participants are auto-enrolled in the Plan at a pre-tax deferral rate of 5% of compensation 35 days after they become eligible for the Plan, unless they affirmatively elect not to contribute. Each year on February 1<sup>st</sup>, participants with a pre-tax deferral rate greater than zero will have that deferral increased annually by 1% as a pre-tax deferral contribution, until a deferral rate of 12% is reached. Participants are able to make deferral contributions on bonuses up to 100%, but if no deferral contribution is elected, then the deferral contribution rate shall be zero. Participants are permitted to make rollover contributions from another qualified plan.

#### **Company Contributions**

The Company provides a safe harbor matching contribution equal to 100% of deferral contributions not to exceed 3% of eligible compensation plus 50% of deferral contributions between 3% and 5% of eligible compensation. All employees who are eligible to participate and make deferral contributions into the Plan are eligible to receive Company safe harbor contributions. Safe harbor matching contributions are calculated and remitted each pay period. The Company performs a true-up calculation at the end of the year for safe harbor matching contributions made throughout the year. Safe harbor matching contributions totaled \$2,449,822 for the year ended December 31, 2024.

#### **Company Contributions – cont'd**

The Company may also make discretionary nonelective profit sharing contributions to the Plan. All participants that are eligible to participate in the Plan who have earned either at least 501 hours of service during the Plan year or who were employed by the employer or related employer on the last day of the Plan year may receive Company nonelective profit sharing contributions. Company nonelective profit sharing contributions are calculated at the end of the Plan year based on the ratio of eligible participant compensation to the total eligible compensation for the Plan during the contribution period. There were no discretionary nonelective profit sharing contributions made to the Plan during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is participant-directed and is credited with the participant's contributions and Company contributions in accordance with the investment options selected by the participant. Plan earnings, losses, and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Notes Receivable from Participants**

Participants may borrow up to 50% of their vested account balances not to exceed \$50,000, without regard to the intended use of the funds. Notes are collateralized by the participant's vested account balance. Interest rates are based on rates available for similar loans from commercial lending institutions. The minimum note amount is \$1,000, and participants may only have one loan outstanding at any given time. Interest and principal repayments are made ratably through payroll deductions. Notes originated for reasons other than the purchase of a primary residence are to be repaid within five years. Notes originated for the purpose of the purchase of a primary residence are to be repaid within a period of no longer than ten years.

#### **Vesting**

Participants are immediately vested in their contributions. Participants are also immediately vested in Company safe harbor matching contributions and nonelective profit sharing contributions, and earnings thereon.

#### Payment of Benefits

Upon termination of service, death, disability, normal retirement (age 65), or attainment of age 59 ½, a participant, or his or her beneficiary in the event of death, is entitled to a distribution of the participant's account balance. Distributions from the Plan are payable in the form of a lump sum payment. Upon termination, if a participant's account balance is less than \$7,000, the Plan administrator may elect to automatically distribute the participant's account balance. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan agreement. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distribution as of December 31, 2024 and 2023.

#### Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by the Trustee with assets of the Plan unless the Company, at its discretion, elects to pay them. The Plan paid direct expenses totaling \$73,622 during the year ended December 31, 2024. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for investments in financial instruments that are exposed to risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Custodian and Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Accounting Standards Codification 820, *Fair Value Measurement (ASC 820)*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Fair Value Measurement – cont’d.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Interest-bearing cash:* Valued at amortized cost using the effective interest method, which approximates fair value.

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

*Interest in common/collective trust:* Valued at fair value based on the unit value of the fund. Unit value is determined by the entity sponsoring the fund by deciding the fund’s net assets at fair value by its unit outstanding at the valuation dates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – cont'd.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through September 5, 2025, the date the financial statements were available to be issued, and there were no material subsequent events requiring disclosure.

### 3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held as of December 31, 2024 and 2023, and interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

### 4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in funds managed by an affiliate of Fidelity Management Trust Company, the Plan Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 6. INCOME TAX STATUS

Effective January 1, 2009, the Plan adopted a volume submitter plan document which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the issuance of the opinion letter, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### 6. INCOME TAX STATUS – cont’d.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan’s financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits in progress for any open tax periods.
