We have performed the audits of the financial statements of the Dekra America, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of plan:

The following description of Dekra America, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan sponsor is Dekra North America, Inc. (Dekra). The Plan is a defined contribution plan covering substantially all employees of Dekra, Dekra Certification, Inc., Behavioral Science Technology, Inc., Chilworth Technology, Inc., Regulatory Consultants, Inc., AT4 Wireless, Inc., Dekra Services, Inc., Safety Consulting Engineers, Inc., and Core Visual Inspections (collectively the Company, Plan Sponsor, or Plan Administrator).

The Plan's eligibility requirements are as follows: eligible employees must complete three months of service to enter the Plan. There are no age requirements for participation in the Plan. Eligible participants may enter the Plan on the first day of the month following attainment of eligibility requirements. The Plan Sponsor provides for safe-harbor matching contributions which are available to all participating employees. All employees of the Company are eligible to participate in the Plan with the exception of participants subject to collective bargaining, part-time, temporary, and seasonal employees who are not regularly scheduled to work at least 1,000 during the Plan year, and non-resident alien employees with no U.S. source income. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees are automatically enrolled in the Plan after attaining eligibility unless they elect otherwise. Automatically enrolled employees are enrolled at a 3% deferral rate. Participants may elect to contribute amounts up to current Internal Revenue Service (IRS) limitations through payroll deductions. Participants who have attained age 50 before the end of the Plan year are permitted to make catch-up contributions. The Company provides a safe-harbor employer matching contribution equal to 100% of each participant's contribution up to the first 3% of compensation and a 50% matching contribution for the next 2% of employee contributions up to a maximum of 5% of eligible compensation contributed, as defined. The Company also has the option to provide non-safe-harbor discretionary employer matching and profit-sharing contributions, which are allocated to all eligible participants in accordance with the Plan document. There were no non-safe-harbor discretionary employer contributions or profit-sharing contributions for the 2024 Plan year.

Contributions - continued

The Plan also has a Roth contribution provision which gives participants the option of also contributing amounts to their individual Roth accounts which are maintained separately from pre-tax contributions. Roth contributions are matched at the same rate as pre-tax contributions as noted above.

Participants may direct both employee and employer contributions to any of the Plan's investment options. Participants may change their investment options daily and their contributions election each payroll period.

Participant accounts

Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contributions, non safe-harbor discretionary matching and profit-sharing contributions, if any, Plan expenses, and Plan earnings.

Allocations of profit-sharing contributions are based on eligible compensation as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$37,373 and \$35,200, respectively, and are included in the Mass Mutual U.S. Government Money Market Fund. Forfeited non-vested accounts may be used to pay Plan expenses or reduce employer matching contributions. During the year ended December 31, 2024, \$6,156 of forfeitures were used to pay Plan expenses. No forfeitures were used to reduce employer contributions to the Plan during the year ended December 31, 2024.

Vesting

Participants are immediately vested in their voluntary contributions and Company safe-harbor matching contributions, plus actual earnings thereon. Participants vest in discretionary non safe-harbor matching contributions and employer profit-sharing contributions in accordance with the following schedule:

1	33%

Participants are immediately vested upon termination of the Plan, upon reaching the normal retirement age of 65, or upon disability or death while an employee of the Company.

Payment of benefits

A participant is entitled to a distribution of the vested value of his or her account upon termination of service, disability, death, or retirement. Participants are required to take distributions as lump-sum payments, with the exception of required minimum distributions. In-service withdrawals of a participant's account are permitted at age 59 1/2 and in cases of proven financial hardship. Participants are also eligible to receive distributions of rollover monies contributed to the Plan at any time. If a participant's account balance is \$7,000 or less upon termination of service, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution.

Notes receivable from participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are for a maximum of five years, unless the loan is for the purchase of the participant's principal residence, for which the term of the loan may be longer at the discretion of the Plan sponsor. Participants may have only one note outstanding at any time. Notes are secured by the participant's account and bear interest at the the prevailing rate as determined by the Plan's administrator at the time of the note's inception. Principal and interest are paid ratably through payroll deductions. Participants may prepay their notes at any time.

Notes receivable from participants - continued

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative expenses

Administrative expenses of the Plan are paid by either the Company or by the Plan, as determined by the Company. The Company pays a portion of administrative expenses of the Plan. Fees charged for processing notes receivable from participants, as well as other account transaction fees, are charged directly to the accounts of applicable participants. The majority of fees charged to the Plan relate to Plan administration and investment advisory services. Total administrative fees paid by the Plan during the year ended December 31, 2024 totaled \$298,246.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Stable value fund

The Plan has a group annuity contract with Empower Trust Company, LLC (Empower) that invests contributions in the SAGIC Diversified Bond II Fund investment. This investment is a general account product. The methodology for calculating the interest crediting rate is based on a formula established by the contract issuer. The crediting interest rate is reviewed on a quarterly basis. The interest rate cannot fall below 0%.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is

the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Empower may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. Generally, a 30 day notice is required by the Company to discontinue the contract. A 90 day notice is required by Empower to discontinue the contract. Empower may elect to defer payment of the contract for up to 12 months after the contract is discontinued.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include 1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options, 3) bankruptcy of the Plan Sponsor or other events that cause a significant withdrawal from the Plan, 4) failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or 5) premature termination of the contract. The Plan Sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract does not permit Empower to terminate the agreement prior to the scheduled maturity date. Additionally, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include 1) an uncured violation of the Plan's investment guidelines, 2) a breach of a material obligation under the contract, 3) a material misrepresentation, and 4) a material amendment to the agreement without the consent of the issuer.

Investment valuation and income recognition

The Plan's mutual fund investments and collective trust fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual fund investments are valued at the net asset value (NAV) of shares held by the Plan. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective trust fund investments are valued at the net asset value of units in the collective trust. The NAV is used as a practical expedient to estimate fair value, where the NAV is based on the underlying assets owned by the fund, less its liabilities, divided by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through October 10, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 4 - Party-in-interest transactions:

The custodian and its affiliates perform services for the Plan, sell products to the Plan, and manage and maintain certain investments of the Plan for which fees are charged to the Plan. The Plan also has a third party administrator. The Plan pays a portion of administrative expenses while the Plan Sponsor pays the remainder of administrative expenses. Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibited transaction rules.

The Plan has a services agreement with Mass Mutual (an affiliate of Empower) whereby the Plan receives revenue from contract asset charge fees related to certain investments of the Plan which is placed into an Expense Budget Account (EBA). The funds in the EBA can either be allocated to participants or used to offset amounts owed to the Plan's service providers for administrative and other services provided to the Plan. During the year ended December 31, 2024, the Plan received \$80,720 of EBA credits associated with the services agreement which are included in other income on the statement of changes in net assets available for benefits. During the year ended December 31, 2024, \$111,517 of expenses were paid out of the EBA account and are included in administrative expenses on the statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the Plan had \$0 and \$30,797, respectively, of EBA income receivables. As of December 31, 2024 and 2023, the Plan had \$6,618 and \$165, respectively, remaining in the EBA account. EBA

monies are held in the Mass Mutual U.S. Government Money Market Fund.

Note 5 - Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants' accounts will become fully vested.

Note 6 - Tax status:

The underlying prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for Plan years prior to 2021.

Note 7 - Correction of operational issues:

For the 2019, 2020, 2023, and 2024 Plan years, multiple delinquent contributions were identified that require corrective action. These are listed chronologically, by plan year, in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions attached to these financial statements. The Plan Sponsor has indicated that they are working with their third-party administrator to calculate lost earnings associated with the delinquent contributions and will deposit all amounts necessary to make affected participants whole.
