Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The U.A. Local No. 467 Health and Welfare Plan and Vacation Plan (the “Plan”) is a multiemployer welfare benefit plan established on September 1, 1952, for the purpose of providing health care and vacation benefits to eligible participants covered by the collective bargaining agreements between the U.A. Local Union No. 467 (the “Union”) and employer associations and individual employers signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are recorded on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Postretirement Benefits

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee’s full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee’s service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by an actuary and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used at December 31, 2024 were: (a) interest rate 5.50% per annum, (b) Mortality - PRI-2012 Blue Collar adjusted tables for “Employee”, “Health Annuitant”, “Contingent Survivor”, sex distinct - projected fully generational using Scale MP-2019, (c) Retirement Age: 100% assumed to retire at age 65, (d) Expenses – assumed costs of benefits and (e) other assumptions and methods for retirement rates, mix of type of retiree coverage, trend rates and per capita cost assumption.

C. Postretirement Benefits (Continued)

The change in actuarial assumptions from 2023 to 2024 relates to the following: (1) the change in the discount rate from 4.85% to 5.50%, (2) medical inflation has been updated to this years Getzen Model, (3) future medical costs assumptions were updated, (4) self pay rates assumptions were updated.

The health care cost trend rate and retiree contribution trend rate have a significant effect on the postretirement benefit obligations. A 1% increase in the health care cost trend rate would increase the net postretirement benefit obligation as of December 31, 2024 and 2023 by \$41,683,007 and \$49,955,435, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

D. Employer Contributions

Employer contributions, including HRA contributions and vacation contributions, as reported are contributions made at a fixed rate per hour worked during the year. Contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for uncollectible accounts.

The Plan has reciprocal agreements in place with other collectively bargained U.A. Local Unions. If a participant works under the jurisdiction of another collectively bargained agreement, the contributions will be transferred to the participants home local in a subsequent month.

E. Employer Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Tax-Exempt Status

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i. Therefore, no provision for federal or state income tax is made.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Risks and Uncertainties

Benefit obligations are reported based on certain assumptions pertaining to health care inflation rates and participant demographics which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Some estimated values may differ from values that would have been used had a ready market existed for the investments. Due to the level of risk associated with investments and the level of uncertainty with respect to the changes in the value of investments, it is reasonably possible that changes in risks in the near term would materially affect the amounts reported in the financial statements.

NOTE 3 - BENEFITS

A. Health and Welfare

The Plan provides health and welfare benefits including medical, dental, vision, prescription drug, and disability for active participants and medical, dental, vision, and prescription drug for retirees. All disability and certain medical claims are self-funded by the Plan. The claims for dental and prescription drugs are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan. All vision, employee assistance, and certain medical benefits are insured with premiums paid by the Plan.

Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-funded medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Under the terms of the 2024 and 2023 contract, individual participant claims incurred in excess of \$800,000 and \$750,000, respectively, are reimbursed to the Plan.

The Plan provides extended insurance and self-funded benefit coverage to active participants based on a member's accumulated reserve hour bank. The accumulation of at least 650 work hours for non-residential participants or 450 work hours for residential participants is required to earn initial eligibility depending on the plan. Coverage will begin the first day of the month following the month that the initial hour requirement of 650 or 450 work hours is met. When coverage begins, the 650 hour bank is reduced by the monthly charge off of 130 hours for coverage or the 450 hour bank is reduced monthly by the monthly charge off of 150 hours for coverage. In addition, the bank is also reduced by the cost of the next two months, 260 or 300 hour charge off, for coverage. This initial charge off of three months establishes the Plan's double skip month eligibility. After initial eligibility is established, participants can accrue up to 390 or 450 hours. An additional three months of extended coverage, in their reserve account with a monthly charge off of 130 or 150 hours.

A retiree is eligible for coverage by meeting the following requirements: the retiree must be qualified to receive and actually be receiving benefits from the U.A. Local 467 Defined Benefit Plan and have at least ten years of benefit credits under the plan. Benefits are provided only to members of U.A. Local 467 in good standing. Also, the retiree must have been eligible as

an active employee under the welfare plan during the 44 out of 48 months immediately preceding the month of retirement and maintain continuous coverage to the date of retirement. Self-payments made by the 20th of the month produce eligibility on a skip month basis.

B. Vacation

Vacation benefit payments are made by the Plan directly to members upon receipt of a properly authorized withdrawal request. Special emergency withdrawals may be made at any time with the approval of the Board of Trustees. Transfers to the U.A. Local No. 467 Credit Union and Political Action Fund, as well as payment of union dues, may be made on behalf of employees who so authorize.

NOTE 4 - CONCENTRATION OF CREDIT RISK

During the year, the Plan had bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

NOTE 5 - RELATED PARTY TRANSACTIONS

Union staff provide assistance to union members related to obtaining information and services pertaining to the Plan. As periodically approved by the Board of Trustees, the Plan reimburses the Union for a portion of an allocated share of salaries, fringes, and overhead. The total reimbursements paid to the Union during the years ended December 31, 2024 and 2023 was \$76,738 for both years.

The Plan holds the lockbox transit account that receives contributions on behalf of related trust funds and other organizations. These contributions are allocated based on each plan's contribution rate and should be transferred monthly. As of December 31, 2024 and 2023, the amount due to other trust funds and other organizations was \$1,206,688 and \$1,624,550, respectively.

NOTE 6 - INVESTMENT VALUATION AND INCOME RECOGNITION

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Level 1 investments consist of short-term investment funds, government debt securities that are direct U.S. Treasury Note, and mutual funds, recorded at fair value based on quoted market prices. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - MEDICARE SUBSIDY

The Medicare Prescription Drug, Improvement and Modernization Act of 2003 includes a prescription drug benefit under Medicare as well as a federal subsidy to sponsors of retiree health care benefit plans providing a benefit that is at least actuarially equivalent to Medicare Part D. The Plan's postretirement benefit obligation reflects an amount associated with the Medicare subsidy allowed under the Act because the Plan is directly entitled to the Medicare subsidy.

NOTE 8 - HEALTH REIMBURSEMENT ARRANGEMENT

The Plan has Health Reimbursement Arrangement ("HRA") accounts enabling participants to use pretax dollars to pay for qualified medical expenses. The following reflects the HRA activity:

NOTE 10 - PRIORITIES UPON TERMINATION

It is the intent of the Board of Trustees to continue the Plan in full force and effect; however, the Plan may be terminated at any time by the Board of Trustees by an instrument in writing executed by mutual consent, subject to the provisions of the plan document. Upon termination, any monies remaining in the Plan after the payment of all expenses and obligations of the Plan, shall be paid or used for the continuance of one or more benefits in accordance with the provisions of this Plan until such Plan is exhausted. No assets of the Plan may revert to the signatory employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 11 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 21, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
