We have performed an audit of the accompanying financial statements of StanCraft 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) Audit]. The financial statements are comprised of the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. Description of the Plan**

The following description of the StanCraft 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the trust agreement and official plan document for more complete information of the Plan’s provisions. Juliette Corporation dba StanCraft Boat Company (the “Company”) is the Plan Sponsor.

General

The Plan is a defined contribution plan which became effective January 1, 2017 and was most recently restated on March 1, 2023 to incorporate language from past legislation and plan amendments. The purpose of the Plan is to provide retirement and associated benefits for employees and their beneficiaries under a profit-sharing plan under Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In 2024, the Plan was amended to become a safe harbor plan. In addition, eligibility was changed from 6 months of service and 500 hours to 90 days of service. Both amendments were effective January, 1, 2024.

The Plan is administered by the Company in the form of an advisory committee consisting of Company officers. Charles Schwab Bank (“Schwab”) is the Trustee of the Plan and the custodian of the assets. Randall and Hurley, Inc. (“R&H”) are the record keepers as well as the third-party administrator of the Plan. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. The Plan pays substantially all administrative expenses associated with the administration of the Plan.

Eligibility

All employees are eligible to participate in the Plan on their date of hire except for those covered by a collective bargaining agreement, leased employees and non-resident aliens. Employees can start making contributions the earlier of the first month after they have completed 500 hours of services in a six-month period or 1,000 hours of service within a 12-month period beginning with the first day of employment.

Employee Contributions

Participants may make voluntary tax-deferred and/or taxed (Roth) contributions to the Plan through payroll deductions of a minimum of 1% up to 100% of annual W-2 compensation subject to Internal Revenue Service maximum limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For 2024, the elective deferral limit is \$23,000 for individuals under the age of 50 and \$30,500 for individuals who attained the age of 50 prior to or during 2024. Participants may also contribute (rollover) amounts representing distributions from other qualified benefit or defined contribution plans. During the year ended December 31, 2024, total employee contributions, including rollovers, were \$521,511.

Employer Contributions

The Plan’s provisions permit the Company to make three types of employer discretionary contributions. The first is an Employer Discretionary Matching Contribution, which may be made each Plan year to eligible participants. The Company may, in its sole discretion, make a matching contribution on behalf of employees in an amount determined by the Company. For the year ended December 31, 2024, Employer Discretionary Matching Contributions totaled \$402,347.

Employer Contributions, Continued

The second type of employer discretionary contribution is an Employer Non-Elective Contribution. The Company may, at its sole discretion, make a contribution to eligible participants in an amount and allocation it determines. Employees with at least one hour of service during the plan year are eligible for these contributions. For the year ended December 31, 2024, the Company did not make an Employer Non-Elective Contribution.

In addition to the contributions described above, the Company, at its sole discretion, may make additional Qualified Non-Elective Contributions to eligible participants in an amount and allocation it determines. For the year ended December 31, 2024, the Company did not make a Qualified Non-Elective Contribution.

Participants direct the investment of their total contribution, including the Plan Sponsor's portion, into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions as well as allocation of the Plan's earnings or losses. The Plan Sponsor's Employer Non-Elective and Qualified Non-Elective contributions are allocated to eligible employees in a manner determined by the Plan Sponsor. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting of Contributions

Participants are immediately 100% vested in their elective deferral, rollover contributions to the Plan and qualified employer non-elective contributions, plus earnings thereon. Employer discretionary matching and non-elective contributions vest at the graduated rate of 33% per year beginning with the second year of service, and become 100% vested after three years of service, as follows:

1 - 2 years	33%
2 - 3 years	67%
3 or more years	100%

All employer contributions and earnings thereon, become 100% vested for a participant who terminates employment with the employer due to death or disability while an employee or attains normal retirement age.

Notes Receivable from Participants

Participants may borrow funds from their accounts up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance and a minimum of \$1,000. Loan terms cannot exceed five years except for the purchase of a primary residence, which cannot exceed fifteen years. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. A participant may only have one loan outstanding at any time. Principal and interest payments are paid through periodic payroll deductions.

Payment of Benefits

Participants are eligible to receive 100% of their vested account balance at normal retirement (age 59-1/2), death, or permanent disability. Participants who terminate employment are eligible to receive their vested account balance after separation from service. On termination of service for any reason other than death, a participant receives the value of the vested interest in his or her account in a lump-sum payment or under a continuous right of withdrawal elected by the participant. Upon death of a participant, distributions to beneficiaries are made in accordance with IRS regulations. If the vested amount in a participant's account does not exceed \$5,000, the payment must be a lump-sum distribution.

Forfeitures

The non-vested portion of a participant's account is forfeited upon termination of employment. Forfeitures are retained in the Plan and are first used to reinstate forfeited balances of re-hired employees, then are used to pay Plan administrative expenses. Any remaining forfeitures may then be used to reduce future employer contributions.

For the year ended December 31, 2024, no forfeitures were used for reinstating forfeited balances of re-hired employees or to pay administrative expenses. In addition, no forfeitures were used to reduce employer profit-sharing contributions. At December 31, 2024, there were \$49,872 of remaining unallocated forfeitures.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of a Plan termination, all participants would become 100% vested in their portion of employer contributions, and benefits under the Plan would be distributed based upon participant account balances accumulated on the date of termination of the Plan.

**2. Summary of Significant Accounting Policies**

Basis of Accounting

The Plan's financial statements have been prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment Valuation and Income Recognition, Continued

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation or depreciation in the fair value of its investments, which consist of realized gains (losses) and unrealized appreciation (depreciation) on those investments.

Fair Value Measurements

ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy for those assets and liabilities measured at fair value, that distinguishes between assumptions based on market data (observable inputs) and the Plan’s own assumptions (unobservable inputs). The hierarchy consists of: Level 1 – quoted market prices in active markets for identical instruments; Level 2 – inputs other than Level 1 inputs that are observable; and Level 3 – unobservable inputs developed using estimates and assumptions determined by the Plan.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publicly list their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore are included in Level 1 of the hierarchy.

*Collective trust fund:* Valued at NAV that is computed daily and is available on the custodian’s website. Although the NAV is not publicly quoted in an active market, it is available to current investors or when Plan participants access their account value and therefore is considered to be a “readily determinable fair value.” Because the collective trust fund is valued similar to mutual funds and considered to be fair value, they are included in Level 1 of the hierarchy.

*Money market:* Interest-bearing cash equivalents are recorded at fair value, which is generally the same as cost.

Certain assets and liabilities are measured at fair value on a nonrecurring basis; that is, the instruments are not measured at fair value on an ongoing basis, but are subject to fair value adjustments only in certain circumstances (for example, when there is evidence of impairment). The Plan had no assets or liabilities measured at fair value on a nonrecurring basis during 2024 or 2023.

Benefit Payments to Participants

Benefit payments to participants are recorded when processed for payment. Benefit payments that have been processed, but not yet remitted to, or on behalf of, participants are reported as benefits payable.

Administrative Expenses

Participant loan fees are paid by the participant, through a reduction of the proceeds of the loan. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. All other costs associated with administering the Plan are charged to all individual participant accounts, based on the individual participants' account balances at the date of payment.

Notes Receivable from Participants

Notes receivable from participants are stated at their outstanding balances, including any accrued but unpaid interest. Interest income is recorded on the accrual basis, and related fees are recorded as administrative expenses as incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates and affect the amounts reported in the financial statements.

Subsequent Events

The Plan's management has evaluated subsequent events through October 9, 2025, the date as of which these financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024 that required recognition or disclosure in these financial statements.

**4. Plan Tax Status**

The Trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code as a tax-exempt organization. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the last letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

**4. Plan Tax Status, Continued**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**5. Risks and Uncertainties**

The Plan provides options for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities may occur and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**6. Information Certified by the Custodian**

The Plan administrator has received certification from Schwab (see Note 3) that the following information is complete and accurate:

- Investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024.
- Net appreciation in fair value of investments and interest and dividend income from investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**7. Party-in-Interest Transactions**

Schwab is the Plan's custodian and trustee and, therefore, investment in funds and transactions with Schwab qualify as party-in-interest transactions. The Plan occasionally has funds in money market and cash accounts that are administered by Schwab. As of December 31, 2024 and 2023, the balance of the Plan's investment in the Schwab Bank Savings money market account was \$49,872 and \$897, respectively. Fees paid by the Plan to Schwab for plan administration services totaled \$1,750 during 2024.

R&H provides third-party administrator services to the Plan and is considered to be a party-in-interest to the Plan. Fees paid by the Plan to R&H for plan administration services totaled \$2,860 during 2024.

**8. Reconciliation of Financial Statements to Form 5500**

There were no differences in net assets available for benefits or net change in net assets available for benefits between the financial statements and the Form 5500 as of or for the year ended December 31, 2024.
