**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the PMC, Inc. and Subsidiaries Employees’ Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document and any amendments regarding specific provisions of the Plan.

The Plan is a defined contribution plan covering all employees of the PMC, Inc. and Subsidiaries (the “Company”) who meet the eligibility requirements of the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participants may contribute through salary deductions up to 50% of their compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations. The Company may, at its discretion, make a matching contribution to the Plan on behalf of the participants.

Participant contributions, rollover contributions and related earnings vest immediately. Vesting in the Company’s contribution and related earnings is based on years of service. A participant vests 20% after the second year of service and an additional 20% each year thereafter, and is 100% vested after six years.

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant’s vested account balance, bears interest at available market financing rates, and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period is 10 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 3.50% to 9.50%.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**B. Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

GAAP requires disclosures about fair value measurement and establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

**C. Investment Valuation and Income Recognition (Continued)**

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Investment related expenses are included in net appreciation of fair value of investments.

**D. Administrative Expenses**

Most administrative expenses of the Plan are paid by the Company.

**E. Income Tax Status**

The Plan uses a prototype plan document sponsored by Lincoln Retirement Services Company LLC received an opinion letter from the Internal Revenue Service ("IRS"), dated March 31, 2014, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Distributions and Withdrawals**

Each participant's share of the net assets of the Plan is allocated to an individual account. Vested benefits are payable upon termination, death or retirement. Additionally, a participant may withdraw vested amounts from his or her account prior to termination of employment with the Company after attaining age 59½ or, prior to that age, by demonstrating financial hardship, as defined by the Plan.

**G. Forfeitures**

Forfeitures are used to reduce future employer contributions or pay administrative expenses of the Plan. As of December 31, 2024 and 2023, there was \$108,445 and \$122,709, respectively, of unused forfeitures. During 2024, \$108,581 was used to reduce Company contributions.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., the trustee of the Plan.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 7 - RELATED PARTY TRANSACTIONS**

Certain Plan's investments are issued or managed by the trustee or its affiliates. Transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 8 - STABLE VALUE ACCOUNT**

The Plan maintains a fully benefit-responsive group fixed annuity contract with Lincoln Financial Group Trust Company, Inc. ("Lincoln") that guarantees a fixed rate of interest. The credited interest rate may be based on an index rate specified in the contract or a declared rate, either or which may be changed quarterly and will never be below the guaranteed rate.

The Stable Value Account Contracts are backed by the general account assets of the issuing company.

**NOTE 8 - STABLE VALUE ACCOUNT (Continued)**

Due to the nature of these contracts, they do not have specific underlying assets assigned. The value of the group fixed annuity contracts that Lincoln reports is at contract value, which approximates fair value. Contract value represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing Plan. Lincoln believes that it is reasonable to conclude that the Stable Value Account meets the requirements for the fully benefit-responsive investment contracts and as such are shown at contract value.

The crediting rate is based on a formula established by Lincoln, but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The crediting rate for each quarter of the 2024 and 2023 Plan years were 3.25% and 2.85%, respectively.

The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

**NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the year ended December 31, 2024, the Company unintentionally did not remit participant contributions and loan payments totaling \$108,777 in a timely manner. Failure to remit participant contributions in a timely manner constitutes a prohibited transaction under Department of Labor regulations. The Company is in process to correct the late contributions and loan payments.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
