Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Metro Bank 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Notes To Consolidated Financial Statements

NOTE 1. PLAN DESCRIPTION

The following description of the Metro Bank 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and employee stock ownership plan ("ESOP") which covers substantially all employees of Metro Bank (the "Company") who have completed one year of service and are age 21 or older. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") of 1986, as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's Company common stock is held in a trust established under the Plan. The Board of Trustees is responsible for the oversight of the Plan. The Plan's investment advisors advise the Plan Administrator on investment offerings, monitor investment performance, and report to key members of Plan management.

Contributions

Each year, participants may contribute between 1% and 80% of pretax annual compensation, as defined in the Plan, subject to the statutory limitation of \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a matching contribution equal to 100 percent of the first 3% of a participant's contributions, plus 50 percent of the participant's contributions in excess of 3%, not to exceed 5% of a participant's eligible compensation. The Company may also make additional contributions on a discretionary basis on behalf of all eligible employees whether or not they made elective contributions for the Plan year. For the year ended December 31, 2024 the Company made a discretionary contribution of \$240,000. Only those participants who are eligible employees of the Company as of the last day of the Plan year, and have completed more than 500 hours of service during the Plan year, will receive an allocation of the discretionary contribution.

The Plan records employer and employee contributions receivable when compensation is paid and deferrals are withheld. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching and discretionary contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Company common stock account of each participant shall be credited as of each anniversary date with the participant's allocable share of Company stock (including fractional shares) purchased and paid for by the Plan or contributed in-kind by the Company.

NOTE 1. PLAN DESCRIPTION (CONTINUED)

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,535 and \$1,500, respectively. These accounts will be used to reduce future employer contributions, pay reasonable expenses of the Plan, or reallocated to participants as an additional discretionary nonelective contribution. For the year ended December 31, 2024, \$0 of forfeited nonvested accounts were reallocated to participants as an additional discretionary nonelective contribution. No employer contributions were reduced by forfeited nonvested accounts and no forfeited nonvested accounts were used to pay Plan expenses during 2024.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested in the Company's contributions ratably over five years of credited service.

Notes Receivable from Participants

Notes receivable from participants are not permitted by the Plan.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either (a) a lump-sum amount equal to the value of the participant's vested interest in his or her account or (b) a direct rollover to an individual retirement account or another employer plan. If a participant's vested account balance is less than \$5,000, the Plan Administrator will distribute the vested interest in the account as a lump-sum distribution. A participant may elect to withdraw all or part of his or her elective contributions due to financial hardship (as defined by Internal Revenue Service (IRS) regulations) or attainment of the age of 59 ½ or later. Distributions are made in cash or, if a participant elects, in the form of Company common stock, or both.

Under the provisions of the plan for the ESOP, should the participant request, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Plan Termination

Although it has not expressed any intent to do so, the Company may wholly or partially terminate the Plan or direct the discontinuance of contributions at any time, subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their account balances.

Voting Rights

All voting rights on shares of Company common stock held in the Plan shall be exercised by the Plan Administrator.

NOTE 1. PLAN DESCRIPTION (CONTINUED)

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his/her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%.

Put Option

Under federal income tax regulations, the Company common stock held by the Plan and its participants is not readily tradable on an established securities market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments and shares of Company common stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, or depreciation, includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Insight Stable Value Fund's investment objective is to provide defined contribution plan investors current income while maintaining stability of invested principal. The Fund pursues its investment objective by investing primarily in a diversified portfolio of guaranteed interest contracts (GICs); synthetic GICs; separate account GICs; cash and cash equivalents; and other instruments that can be carried at book value. At the date of issuance, the Fund's GICs, synthetic GICs, and separate account GICs will have a duration of six years or less. The Fund generally will maintain a weighted average duration of one to three years.

NOTE 2. SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Expenses

Investment-related expenses are included in net appreciation, or depreciation, in fair value of investments. Administrative expenses for the year ended December 31, 2024, were \$74,004. Other administrative expenses such as third-party administrator, accounting and legal fees are paid by the Company rather than the participants and are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this guidance are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation method process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Bank. The appraiser prepares a preliminary report, which Plan management, along with the ESOP trustee, reviews in detail, discusses, and approves.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Stable value fund: Valued based on the fair value of the underlying investments as described in Note 2. Units of participation of the stable value fund are valued at the NAV provided by the fund's trustee as a practical expedient to estimated fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participants may purchase or redeem units in the relevant class for cash or securities based on the unit valued determined as of valuation date. Class unit value is generally determined each business day of the year.

NOTE 5. PARTY-IN-INTEREST TRANSACTION

Certain Plan investments were shares of mutual funds managed by Mid-Atlantic Trust Company. Mid-Atlantic Trust Company is the custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services and recordkeeping amounted to \$74,004 for the year ended December 31, 2024. Transactions conducted with the Company, which is the Plan sponsor, also qualify as party-in-interest transactions. At December 31, 2024, the Plan held investments in the Bank's common stock valued at \$4,132,190. For the year ended December 31, 2024, the Plan was paid dividends of \$281,835 on the Company's common stock.

NOTE 6. TAX STATUS

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under IRS Section 401(b). Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has been amended since the prototype determination, and an applicable determination has been submitted to the IRS.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more-likely-than-not would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan has filed a Form 5500, Annual Return of Employee Benefit Plans, for all years through December 31, 2023. The Plan Administrator believes the Plan is no longer subject to income tax examinations prior to 2021.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities and shares of the Company's common stock. Investment securities and common stock are exposed to various risks, such as interest rate, market and credit risks as well as valuation assumptions based on earnings, cash flows and/or other such techniques for the valuation of common stock. Due to the level of risk associated with certain investment securities and common stock, it is at least reasonably possible that changes in the values of investment securities and common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8. INFORMATION CERTIFIED BY PLAN CUSTODIAN

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Mid-Atlantic Trust Company, the custodian of the Plan, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The Plan Administrator has obtained certifications from the custodian that the following information is complete and accurate.
