### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of BRC 403(b) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and June 30, 2024, and the related statement of changes in net assets available for benefits for the six-month period ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

The following description of the BRC 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of Bowery Residents' Committee, Inc. (the Sponsor) not covered by a collective bargaining agreement. Effective January 1, 2025, the Plan was amended to merge with the BRC Union 403(b) Plan, therefore, allowing employees covered by a collective bargaining agreement after the merger. The merged Plan's name was changed to BRC 403(b) Plan as well as a change to the merged Plan's year-end date to December 31, with a transitional short year from July 1, 2024 to December 31, 2024.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

### **Contributions**

The Sponsor is eligible to make contributions covering all eligible employees. There is no minimum age requirement and no minimum service requirement for participant contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant's total elective deferrals in any calendar year may not exceed a certain dollar limit, which is set by law (elective deferral limit).

Under the terms of the Plan, an employee is eligible for the Sponsor matching contribution on January 1 and July 1 of each year following the completion of one year of service and attain the age of 18. The Sponsor will make a matching contribution each payroll period equal to 100% of the employee contribution but not to exceed 4% of eligible compensation. Effective July 1, 2023, the Plan was amended to increase the employer matching contribution rate to 6% of eligible compensation.

Effective June 9, 2023, the Sponsor can make a nonelective employer contribution at the discretion of the employer at a flat dollar amount. While these contributions do not have any eligibility requirements, employees are required to have compensation during the plan year and be actively employed on the last day of the plan year to receive these contributions. There were no contributions of this type during the six-month period ended December 31, 2024; however, approximately \$406,000 of these contributions were provided to all employees covered by the Plan and were remitted subsequent to year-end June 30, 2024.

The Plan does accept rollovers and transfers from other qualified plans, but only for those employees eligible to participate in the Plan. Effective January 1, 2024, the Plan also allows Roth contributions, as amended.

### **Participant Investment Account Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are 100% vested in their voluntary contributions and Sponsor's contributions plus earnings thereon.

### ***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

### ***Payment of Benefits***

A participant's vested account is payable upon termination, retirement, disability, or death. The participant, or designated beneficiary upon the participant's death, may choose to receive a lump-sum payment or installment payments.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

**Note 3. Certifications of Plan Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (Empower), qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and June 30, 2024
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the six-month period ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the six-month period ended December 31, 2024 and the year ended June 30, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

## **Note 5. Investment Contract with Insurance Company**

In 2023, the Plan entered into a fully benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York (Empower Insurance Company). Empower Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Sponsor or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The investment contract held by the Plan are in EI Fixed Account – Series VI in the amount of \$3,807,151 and \$3,810,064 at December 31, 2024 and June 30, 2024, respectively.

## **Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Empower, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for investment management services were included as a reduction of the investment return on each fund. In addition, the Plan paid the Trustee \$37,963 as an administrative fee for the six-month period ended December 31, 2024. The Sponsor provides certain administrative services at no cost to the Plan.

**Note 7. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Great-West Trust Company, LLC, as amended. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Plan Merger**

As noted previously, effective January 1, 2025, the BRC Non Union 403(b) Plan (the “surviving plan”) consummated a merger with the BRC Union 403(b) Plan, and the combined plan was renamed to the BRC 403(b) Plan.

In connection with the merger, the transfer of the BRC Union 403(b) Plan’s assets to the surviving plan was initiated on December 31, 2024 into the same investment funds held by the BRC Union 403(b) Plan and was completed in January 2025.

In connection with the certifications provided by the Trustee, the assets are being reported as having transferred in as of December 31, 2024. Accordingly, the total transfers in is included on the statement of changes in net assets available for benefits for the six-month period ended December 31, 2024. The total transfer in was made in three major batches as follows (1) mutual funds totaling approximately \$7,300,000 (initiated and certified by the Trustees of both plans as of December 31, 2024 and settled on January 2, 2025); (2) investment contract asset of approximately \$1,500,000 (initiated, but not certified by the Trustee of the BRC 403(b) Plan as of December 31, 2024 and settled on January 2, 2025); and (3) notes receivable from participants of approximately \$700,000 (initiated, but not certified by the Trustee of the BRC 403(b) Union Plan as of December 31, 2024 and settled on January 14, 2025). Accordingly, there was a transfer receivable recognized by the Plan on the statement of net assets available for benefits as of December 31, 2024 relating to the batches not certified by the Trustee as of December 31, 2024.

**Note 9. Plan Termination**

Although they have not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA.
