### 1. DESCRIPTION OF PLAN

The following description of Tessera Therapeutics, Inc 401(K) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a 401(k) defined contribution retirement plan covering substantially all employees of Tessera Therapeutics, Inc (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

#### b. Eligibility

Employees who have reached the age of twenty-one and have completed two months of service following the month of hire are eligible to participate in the Plan and receive Plan Sponsor contributions. Non-resident aliens, residents of Puerto Rico, and interns are excluded from the Plan as defined in the plan document. Effective June 2, 2025, contractors and consultants are also excluded from the Plan.

#### c. Contributions

Each year, participants may contribute up to 90% of pre-tax annual compensation which is subject to Internal Revenue Service (IRS) limitations. Participants who have attained the age of fifty before the end of the plan year are eligible to make catch-up contributions. The Plan has a Roth component in which participants can elect to make post-tax contributions into the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are auto-enrolled into the Plan at 4% of eligible compensation, unless a participant elects otherwise. Participants may opt out of participation in the Plan.

Effective January 1, 2024, the Plan allows for safe harbor non-elective employer contributions. The Plan Sponsor funded safe harbor non-elective employer contributions equal to 3% of an employee's eligible compensation on a per pay period basis totaling \$1,813,380 for the year ended December 31, 2024.

The Plan Sponsor may elect to fund discretionary employer matching contributions and discretionary employer non-elective contributions to all eligible employees. For the year ended December 31, 2024, the Plan Sponsor did not make any discretionary employer matching contributions or discretionary employer non-elective contributions to the Plan.

#### d. Participant Accounts

Each participant's account is credited with the participant's contribution, Plan Sponsor contributions, and allocations of plan earnings or losses and charged with an allocation of administrative fees paid by the Plan, if any. Allocations are based on participant's earnings or losses, account balances, or directly charged, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their voluntary contributions and the Plan Sponsor contributions and actual earnings or losses thereon.

#### f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$1,000. Participants may only have one outstanding loan at a time. The loan term cannot exceed five years, unless proceeds are used to purchase a primary residence, in which case the loan term can be up to thirty years. Loans are secured by the vested balance in the participant's account and bear interest at an amount determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are repaid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. There are also retirement benefits available upon disability or death. Upon termination of service, a participant may elect to receive an installment payment or direct rollover, unless the participant elects to receive a lump-sum payment. The Plan allows balances up to \$5,000 to be paid out to participants upon termination. Effective January 1, 2024, the involuntary cash-out distribution limit was increased to \$7,000 per the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeited Accounts

Forfeitures represent employer contributions corrections forfeited by participants. Forfeitures of terminated participants' non-vested accounts are used to pay the Plan's expenses or reduce future employer contributions. There were \$2,543 and \$1,311 of unallocated forfeitures as of December 31, 2024 and 2023, respectively.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds and common collective trusts. Mutual funds are stated at fair market value as determined by the qualified institution, based upon the last reported sales price on the last business day of the plan year. The Plan's interests in the common collective trusts are stated at net asset value (NAV) based on information reported by the investment advisor using the audited financial statements of the collective trusts at year-end. Gains and losses are recognized as incurred upon the sale or maturity of investments based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. There were \$5,559 of defaulted loans that were deemed distributed included in benefits paid to participants as of December 31, 2024.

#### Contributions

Contributions from plan participant and the safe harbor non-elective contributions and the discretionary employer matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. Discretionary employer non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the participants' account and are included in administrative fees. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued. Except as noted in Note 1b, there were no other events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity), a qualified institution, has certified to the completeness and accuracy of investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### 4. FAIR VALUE MEASUREMENT (Continued)

*Common collective trusts:* Valued at the NAV of the units held by the common collective trusts (CCTs). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCTs less their liabilities. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the CCTs will be sold for amounts different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the CCTs at amounts different than NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCTs, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. COMMON COLLECTIVE TRUSTS

The CCTs are represented by the underlying investment in the AB US Large Cap Gr M Fund and Invesco Stable Asset Fund, which invest in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investments in the CCTs are not considered fully benefit-responsive investment contracts and are reported at fair value (see Note 4). The CCTs are direct filing entities.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution and notes receivable from participants are considered party-in-interest transactions. The Plan paid \$3,363 of administrative fees to the qualified institution during the year ended December 31, 2024.

### 8. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 9. RISKS AND UNCERTAINTIES

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the statements of net assets available for benefits.

### 10. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2024 and 2023, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction. The Plan Sponsor calculated and funded lost earnings for the 2023 delinquent contributions in 2025. The Plan Sponsor intends to calculate and fund lost earnings for the 2024 delinquent contributions in 2025.
