Independent Auditor's Report

To the Plan Administrator  
Physician Affiliate Group of New York Retirement Plan

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Physician Affiliate Group of New York Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

*Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1 - Description of Plan

The following description of the Physician Affiliate Group of New York Retirement Plan (the "Plan") is intended to give a general summary of the Plan's principal provisions. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan, formerly known as Downtown Bronx Medical Associates, P.C. Retirement Plan, was originally established on September 1, 2000 by Downtown Bronx Medical Associates, P.C. ("DBMA") and was adopted by Downtown Bronx Dental Associates, P.C. ("DBDA"), a related entity to DBMA. PhyCare Solutions, Inc. ("PhyCare") adopted the Plan on February 15, 2007.

The Plan was restated on October 1, 2010. As of that date, Physician Affiliate Group of New York, P.C. ("PAGNY"), a newly formed organization affiliated with DBMA, adopted the Plan.

On August 1, 2011, New York Dental Alliance, U.F.P.C. ("NYDA") and New York Medical Alliance, U.F.P.C. ("NYMA"), two entities affiliated with PAGNY, also became adopting employers of the Plan.

On November 6, 2011, PAGNY became the successor company to DBMA. In connection with this event, PAGNY became the primary employer and sponsor of the Plan (the "Sponsor").

On July 1, 2012, the Plan was restated and renamed to the Physician Affiliate Group of New York Retirement Plan. As of that date, PhyCare ceased to be an adopting employer of the Plan. In addition, NYMA and the Physician Affiliate Group of New York Defined Contribution Plan merged and transferred assets into the Plan on July 3, 2012.

Effective July 1, 2018, the Plan year-end is on December 31 rather than the previous year-end date of June 30.

As of January 1, 2019, the Plan began transitioning its assets from the Principal Financial Group to Fidelity Investments, Inc.

PAGNY, DBDA, NYMA and NYDA are collectively referred to as the "Company" or "Employer".

##### **Eligibility**

The Plan is a defined contribution plan covering all eligible employees of the Company. Per diem employees are not eligible to participate in the Plan unless they attain 1,000 hours of service in their first year of employment or in a subsequent Plan year. Fidelity Management Trust Company ("Fidelity") is the trustee, custodian and recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Directors is responsible for oversight of the Plan. The HR Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

#### Participant contributions

Each year, participants may contribute a portion or all of their compensation, as defined by the Plan, subject to an annual limitation set forth by the Internal Revenue Service (the "IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Employer contributions

The Company shall make employer contributions equal to 7% of eligible compensation for eligible employees who are active participants (as defined in the Plan document), after the completion of one year of service. The one-year service requirement is waived for employees hired before July 1, 2013. The Company's employer contributions amounted to approximately \$29,298,000 for the year ended December 31, 2024.

Upon date of hire, the Company shall make qualified nonelective safe harbor contributions in an amount equal to 3% of eligible compensation for eligible employees who were active participants (as defined in the Plan document). Compensation shall exclude compensation for any portion of the Plan year in which the employee is not an active participant. The Company's qualified nonelective contributions are 100% vested when made. The Company's qualified nonelective contributions amounted to approximately \$14,052,000 for the year ended December 31, 2024. Participants also direct the investment of Company contributions.

Participants who are members of a union sponsored qualified plan and receive separate employer contributions are not eligible to receive the Company's employer or safe harbor contributions.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions and (b) Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions, the safe harbor contributions and earnings thereon. Participants entering the Plan prior to July 1, 2013 are 100% vested in the Company's 7% employer contributions. Participants entering the Plan subsequent to July 1, 2013 are 0% vested in the Company's 7% employer contributions for their first three years of service and 100% vested after three years of service.

#### Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. All loans are required to be repaid within five years of the loan. The loans are secured by the balance in the participant's account. The interest rate, as determined periodically by the Plan administrator, is fixed for the term of the loan and rates range from 4.25% to 9.5%. Principal and interest are paid ratably through weekly payroll deductions.

#### Payment of benefits

Participants are entitled to distributions of their vested benefits upon retirement, death, disability, termination of employment or termination of the Plan. Upon retirement, distributions may be taken in whole or in part at the election of the participant.

The Plan also allows a financial hardship withdrawal to an eligible participant only if the participant has received all other withdrawals or loans available to the participant under the Plan. An eligible participant who elects a financial hardship withdrawal will have his future employee contributions suspended for a period of six months. Acceptable reasons for hardship withdrawals may generally be made for any of the following reasons provided the participant does not have other resources readily available:

1. To pay medical expenses that would be tax deductible (without regard to whether the expenses exceed 7.5% of adjusted gross income).
2. To purchase a primary home, stop eviction from the primary home or stop foreclosure on such home.
3. To pay tuition, related educational fees and room and board expenses, for the next 12 months of post-secondary education for the participant and dependents (as defined in the Plan).
4. To pay funeral or burial expenses for the participant's parents, spouse, children or dependents (as defined in the Plan).
5. To pay expenses to repair damage to the primary home that would be tax deductible (without regard to whether the expenses exceed 10% of adjusted gross income).

#### Forfeited accounts

Forfeited nonvested accounts are used to reduce future employer contributions and administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$420,959 and \$420,968, respectively. During the year ended December 31, 2024, employer contributions were decreased by \$122,005.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### Use of estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Contributions**

Participant contributions and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. In the year ended December 31, 2024, included in benefits paid were defaulted loans in the amount of \$108,853.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

### **Note 3 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

#### Note 4 - Related party and party-in-interest transactions

Certain Plan investments are managed by the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made a direct payment to the third-party administrator of \$646,464, which was not covered by revenue sharing.

#### Note 5 - Tax status

The IRS has determined and informed the Company by letter dated November 8, 2013, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8 - Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 9 - Nonexempt transactions**

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain Plan contributions were not remitted to the Plan within the time frame specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the year ended December 31, 2022. The Company has determined that contributions totaling \$9,366,859 for the year ended December 31, 2022 were remitted to the Plan outside of the specified time frame. Subsequently, the Company took corrective actions in calculating the principal and interest for lost earnings and remitted to plan on March 13, 2024.
