### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Amundi US, Inc. Saving and Investment Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. # AMUNDI US, INC. SAVINGS AND INVESTMENT PLAN

## NOTES TO FINANCIAL STATEMENTS AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

### 1. DESCRIPTION OF PLAN

The following description of the Amundi US, Inc. Savings and Investment Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** — The Plan is a defined contribution plan, qualified under Section 401(k) of the Internal Revenue Code (the "IRC"), covering all eligible U.S. employees, as defined, of Amundi US, Inc. and its wholly owned subsidiaries (the "Company" and "Plan Sponsor") upon the later of hire date or attainment of age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant directed.

The Company, a Delaware corporation, and its subsidiaries, are wholly owned by Amundi Holdings US, Inc. ("AHUS"), a wholly owned subsidiary of Amundi Asset Management S.A.S. ("Amundi"), a global asset manager headquartered in Paris, France.

The Retirement Plan's Committee of the Company is the plan administrator and is responsible for the general administration of the Plan, including compliance with the reporting and disclosure requirements of ERISA.

**Contributions** — Contributions to the Plan are made by the participants and the Company. Participants designate as their contribution (participant contribution) to the Plan an amount between 1% and 50% of their compensation, as defined. The Company contributes matching funds (employer matching contribution) to each participant's account on a dollar for dollar basis equal to the participant's contribution, up to 2.5% of the participant's compensation, as defined. Contributions are subject to certain IRC limitations.

**Participant Accounts** — Individual accounts are maintained for each participant. Each participant's account is credited with the contributions from the participant and the Company and earnings thereon, and is debited with withdrawals and expenses, if applicable. Net realized gains or losses, dividends, interest, and other distributions from any mutual fund are reinvested in shares of that mutual fund based on each participant's account balance. The benefit to which a participant is entitled is his or her vested account balance.

**Investment Options** — All participants are entitled to direct their investments to a core list of certain of the Pioneer Family of Mutual Funds, third party mutual funds, and common/collective trusts, or they may direct their investments to other mutual funds via a self-directed account managed by Bank of America, N.A. (the "Trustee"). The self-directed brokerage account allows plan participants to invest in a wide array of securities, mainly registered investment companies, beyond those offered under the standard Plan offering. The allocation may be changed and an election to transfer all or part of an account balance between investment options can be made at any time by the participant.

**Vesting** — Participant contributions, Company matching contributions, and actual earnings thereon are immediately vested.

**Payment of Benefits** — The Plan provides for benefits to be paid to participants who have reached retirement age (normally age 65) and who have retired from active service with the Company. Such benefits are based on the amount in the participant’s account as of the distribution date. The Plan also provides for the payment of benefits in the event of death, disability, or termination of employment. At the participant’s election, benefits will be paid in a lump sum or in annual installments over a period that is at least two years, but not more than ten years.

**Hardship Withdrawals** — In service withdrawals may be made to the extent of an immediate and heavy financial need from pre-tax and Roth elective accounts only without respect to earnings. The minimum amount of a hardship withdrawal is \$250 and participants are allowed one hardship per twelve month period.

**Notes Receivable from Participants** — Notes receivable consist of loans to participants. Loans may not exceed the lesser of \$50,000 or 50% of a participant’s total vested account balance and must be a minimum of \$1,000. Repayment is made in equal installments through payroll deductions over a term not to exceed five years for a general purpose loan and not to exceed 20 years for a primary residence loan. Interest is charged at an agreed upon percentage based on prevalent market rates, and as payments are made, both interest and principal will be added back to the participant’s individual account. At December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%. Administrative fees of \$50 per new loan (one-time fee paid to recordkeeper) are charged directly to participants’ accounts.

**Forfeited Accounts** — As of December 31, 2024 and 2023, forfeited accounts totaled \$48,525 and \$12,854, respectively. Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining amounts will be used to reduce Employer contributions payable to the Plan. During the year ended December 31, 2024, \$64,495 of forfeitures were generated and \$30,967 of forfeited non-vested accounts were used to reduce Employer contributions and pay administrative expenses. Subsequent to year end, \$48,106 of forfeitures were used to offset a portion of the Employer contribution due for the 2024 Plan year.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Presentation** — The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Investments, Investment Valuation and Income Recognition** — Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation of investments represents realized gains (losses) and the change in unrealized appreciation. The average cost basis is used in calculating realized gains and losses from the sales of investments in mutual funds during the year.

**Unit Values** — Individual participant accounts for the common/collective trust funds are maintained on a unit value basis. Participants do not have ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Excess Contributions Payable** — Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to the following April 1 of each year.

**Notes Receivable from Participants** — Notes receivable are valued at amortized cost, which is unpaid principal plus accrued interest. While any loan amount remains outstanding, no distribution shall be made from the participant's account with respect to the portion of the account balance representing the value of the loan as an asset of the account. If the participant dies or does not repay their loan according to the terms agreed upon by the participant and plan administrator, the plan administrator may, upon termination of the participant's employment, reduce the balance of the participant's account in the Plan by the outstanding loan amount and any interest then due, or, alternatively, exercise such rights or remedies as it may have as a creditor of the participant.

**Risks and Uncertainties** — The Plan provides for various investment options which are exposed to interest rate, market, credit, and other risks depending on the nature of the specific fund or other investment security. Market risks include global events such as an international conflict which could impact the value of investment securities. Accordingly, it is at least reasonably possible that these factors will result in changes in the value of the Plan's investments which could materially affect amounts reported in the statements of net assets available for benefits, the statement of changes in net assets available for benefits, and the related participants' account balances in the near term.

**Use of Estimates** — The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities, at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses** — Administrative expenses of the Plan are deducted directly from participant accounts, and the balance of the Credit Account was distributed to participant account balances as noted below.

Under the terms of a fee schedule entered into on December 6, 2016, between the Plan and the recordkeeper, the recordkeeper may be required to deposit into the Plan's trust a Credit Account, as defined in the fee schedule, which can be used to pay administrative expenses of the Plan or can be allocated to participant account balances. At December 31, 2024 and 2023, \$51 and \$48 was remaining in the Plan related to the Credit Account, respectively. There were no administrative expenses paid from the Credit Account during the year ended December 31, 2024.

**Subsequent Events** — The Plan has evaluated subsequent events through October 8, 2025, the date that the financial statements are available to be issued.

On July 9, 2024, Amundi entered into a definitive agreement to sell AHUS and its subsidiaries to Victory Capital Holdings, Inc. (“Victory Capital”), subject to regulatory and shareholder approval and customary closing conditions. The transaction was completed on April 1, 2025, and AHUS was combined into Victory Capital. There were no changes to the Plan for the year ended December 31, 2024. Effective as of the closing, the Plan was frozen to new contributions. On July 1, 2025, the Plan was merged into the Victory Capital 401(k) Plan, and all plan assets were transferred accordingly.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds (Pioneer, Third Party, and Self-Directed Brokerage Accounts)* — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Shares of open-end registered investment companies (including money market mutual funds) are valued at NAV. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trusts* — Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. In accordance with Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

#### 5. TAX STATUS

The Plan has received a favorable determination letter, dated September 28, 2015, from the IRS that the Plan and related trust were designed in accordance with the applicable requirements of the IRC. The Company and plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

## 6. UNCERTAIN TAX POSITIONS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## 7. RELATED PARTY AND PARTY- IN-INTEREST TRANSACTIONS

Certain of the Company's wholly owned subsidiaries earn fees on assets invested by the Plan in the Pioneer Family of Mutual Funds. Additionally, certain investments managed by the Trustee earn fees on assets invested by the Plan. Investments in the Pioneer Family of Mutual Funds, the Common/ Collective Trusts, and participant loans represent party-in-interest transactions. For the year ended December 31, 2024, \$62,310 of fees were paid to the recordkeeper. In addition, notes receivable from participants also qualify as exempt party-in-interest transactions, as defined by ERISA.

## 8. INFORMATION CERTIFIED BY TRUSTEE

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Bank of America, N.A., the Trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certification from the Trustee that such information is complete and accurate. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
