## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ACLI Income Plan, formerly, American Council of Life Insurers Shared Tax-Advantage Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the Financial Statements**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Note 1. Plan Description and Significant Accounting Policies

The following description of the ACLI Income Plan, formerly, American Council of Life Insurers Shared Tax-Advantage Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan was established January 1, 1985 and is sponsored by American Council of Life Insurers (the Association). The Plan is a defined contribution plan, with profit sharing and 401(k) features, funded by elective contributions from participants and contributions from the Association. The Plan Administrator is responsible for oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator.

**Plan description:** The Plan is a defined contribution plan covering substantially all eligible employees of the Association. All employees who have attained age 21 and are included in an eligible class of employees, as defined by the Plan, are eligible to participate as of the first day of the calendar quarter on or after the date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan amendments:** Effective September 1, 2023, the Plan was restated to adopt the Principal pre-approved document and to amend the definition of compensation for employer non-matching contributions. The Plan name was also changed with this amendment.

**Participant contributions:** Each year, participants may elect to make salary reduction contributions from 1% to 100% of eligible compensation, as defined in the Plan's provisions, subject to certain restrictions under Section 401(k)(3) of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. For participants under the automatic enrollment provisions, the deferral percentage is increased by 1% each year until it reaches 15%. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time. Pretax and Roth participant contributions to the Plan are made through payroll deductions. The Plan accepts rollovers from other qualified defined benefit or defined contribution plans, subject to Plan provisions.

**Employer contributions:** The Association matches 100% of eligible employee contributions up to 6% of the employee's eligible compensation based on years of service and date of hire. In addition, the employer will contribute from 2.4% up to 7% of the employee's eligible compensation as a non-matching contribution to all employees based on years of service and date of hire. Contributions are subject to certain IRC limitations.

Employees hired prior to January 1, 2014:

##### Years of Service

0-10 years of service	5% non-match and up to 6% employer matching contributions
10+ years of service	7% non-match and up to 6% employer matching contributions

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's and the Association's contributions and allocations of Plan earnings/losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan offers participant-directed investment options in mutual funds, guaranteed withdrawal accounts and a guaranteed interest account. Transfers of funds from the guaranteed interest account to a mutual fund must remain in the mutual fund for a minimum of 90 days before being eligible for transfer back to the guaranteed interest account.

**Vesting:** Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Effective January 1, 2006, participants vest in the employer matching and non-matching contributions and related earnings thereon at a rate of 20% per year upon completion of one year of service, with full vesting occurring upon the completion of five years of service. However, if an active participant dies, becomes disabled or attains retirement age, the participant's account becomes 100% vested.

**Notes receivable from participants:** Each participant may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 (subject to reduction based on prior loans (a maximum of 5 loans) from the previous 12-month period). The term of the loan may not exceed five years, unless the proceeds are used for the purchase of a participant's primary residence. The loan is secured by the vested balance in the participant's account and bears interest equal to the prime rate quoted in *The Wall Street Journal* at the time of the loan plus 1%. Interest rates on outstanding loans range from 4.25% to 9.50% with the loans maturing through 2055. Principal and interest payments are made through semimonthly payroll deductions. Participants may also make payments directly to the Plan.

**Payment of benefits:** On termination of service due to death, disability or retirement, the automatic form of distribution is a lump-sum amount equal to the value of the participant's entire vested interest in his or her account, a single-sum distribution of a portion of the participant's vested account balance or installment payments payable monthly, quarterly, semiannually or annually over a period not longer than the participant's life expectancy. Participants, under certain conditions, may take a financial hardship withdrawal of all or part of their vested account. Such withdrawals may not exceed the amount required to meet the immediate financial needs created by the hardship. Additionally, under certain conditions, participants may make in-service withdrawals of all or part of their vested account contributed by the employer prior to December 31, 2013. Effective for contributions made on or after January 1, 2014, employer matching and non-matching contributions are no longer eligible for in-service withdrawals.

**Forfeited accounts:** At December 31, 2024 and 2023, there was \$974 and \$6,884, respectively, in forfeited nonvested accounts. These accounts are used to reduce future employer matching and non-matching contributions or offset Plan expenses. For the years ended December 31, 2024 and 2023, forfeitures of nonvested funds used to reduce employer contributions were \$12,306 and \$50,544, respectively.

A summary of the Plan's significant accounting policies follows:

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by Principal Trust Company, the trustee and custodian. See Note 3 for a discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan.

**Contributions:** Contributions from Plan participants and the contributions from the employer are recorded in the year in which the underlying compensation is paid.

**Excess contributions payable:** Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefit payments to participants are recorded when paid.

**Operating expenses:** Plan expenses which are paid by the Association are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's accounts and certain record-keeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events (events occurring after December 31, 2024) through October 8, 2025, the date the financial statements were available to be issued.

#### Note 2. Information Certified by Qualified Institutions

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by qualified institutions. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (current trustee) certified as of and for the year ended December 31, 2024 and for the period of September 1, 2023 to December 31, 2023. Prudential Bank & Trust, F.S.B. and the successor, effective April 1, 2023, Empower Trust Company, LLC (former trustees) and Empower Annuity Insurance Company (former custodian) certified for the period of January 1, 2023 to August 31, 2023.

#### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4. Guaranteed Interest Account

In 2023, the Plan entered into a fully benefit responsive guaranteed investment contract with Principal Life Insurance Company (Principal) that is reported at contract value. Principal maintains the contributions in a general account. The account is credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer that is reset on January 1 and July 1 each year. Up until December 31, 2026, the interest rate may not be less than 3%. After this time, the minimum rate will be based on the rate required by state regulations where Principal is domiciled. The contract shall terminate on the date on which there are no Deposit Arrangements in effect under this Contract; provided, however, that provisions relating to annuities in course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value if held to maturity or at fair market value if prior to maturity.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. As reported by Principal, the fair value of the guaranteed interest balance contract approximates contract value. The average yield and crediting interest rates based on actual earnings and based on interest rates credited to participants were approximately 5.025% for the year ended December 31, 2024.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of Such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreement without the consent of the issuer

#### **Note 5. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits. The Guaranteed Interest Account with Principal represented approximately 27% and 31% of the Plan's net assets as of December 31, 2024 and 2023, respectively. As such, this investment is considered a concentration of credit risk.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Principal Trust Company is the trustee and custodian of the Plan; therefore, transactions with this entity qualify as party-in-interest transactions. The Association also paid certain administrative expenses of the Plan.

#### **Note 7. Plan Termination**

Although it has not expressed intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 8. Tax Status**

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
