Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sixth Street Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Part IV, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and Schedule H, Part IV, Line 4i - Schedule of Assets (Held At End Of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

(1) Description of the Plan

The following description of the Sixth Street Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan is a defined contribution plan established by Sixth Street Partners, LLC (the “Company”, “Plan Administrator”, or “Employer”) for the U.S.-based employees of Sixth Street Partners, LLC, and certain affiliated entities (“Sixth Street Employees”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Company is the Plan Administrator, and Fidelity Management Trust Company (the “Trustee” or “Fidelity”) is trustee, and Fidelity Workplace Services LLC, a wholly owned subsidiary of Fidelity, is the recordkeeper of the Plan.

(b) Contributions

All U.S.-based employees, excluding temporary employees, are eligible for participation in the Plan. Under the Plan, participants may voluntarily defer a portion of their compensation, ranging from 1% to 90%, by contributing to the Plan; however, such pre-tax or Roth contributions may not exceed certain IRS limitations (\$23,000 in 2024). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch up contributions, up to \$7,500 in 2024.

The Company may make a matching contribution of participant’s eligible compensation at a rate determined by the Company each year. During 2024, the Company made matching contributions of up to 5% of participants’ eligible compensation. The Company may also make additional discretionary contributions each year to eligible participants. These discretionary contributions are allocated to participants pro rata on the basis of eligible compensation paid to all participants. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. During the year ended December 31, 2024, discretionary contributions net of forfeitures of \$4,245,061 are receivable to the Plan.

Participants and all eligible employees, prior to satisfying the Plan’s participation conditions, may make a rollover contribution from another qualified plan to the Plan.

Plan investment decisions are made at the discretion of the participants, and as such, the Plan is participant directed. Participants may choose from a variety of investment options including mutual funds and common/collective trusts selected by the Company.

(c) Plan Administration

In accordance with the trust agreement, the Plan’s assets and income therefrom are held and administered by the Trustee. The Company has responsibility for making Employer contributions, appointing and removing the Trustee, establishing a funding policy and method, and amending or terminating the Plan.

(d) Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s matching and discretionary contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(e) Expenses

Expenses that are paid by the Employer are excluded from the Plan’s financial statements. Investment related expenses are included in net investment income.

(f) Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons, or upon request after attaining normal retirement age, vested account balances less than \$5,000 are distributed in lump sum payments. Vested account balances exceeding \$5,000 are distributed in one of the following manners:

- Lump sum distributions;
- Periodic installments;
- Direct rollover to an IRA or another eligible retirement plan; or
- Combination of cash and direct rollover distribution.

(g) Vesting

In general, participants' Employer contributions and related earnings vest in five years. However, participants or their beneficiaries become immediately and fully vested in their Employer contributions and related earnings upon full and permanent disability, death or attaining the normal retirement age of 65. Participant contributions, including rollover amounts, and related earnings are always 100% vested.

(h) Notes Receivable from Participants

Any Plan participant may apply for a loan from the Plan. A participant may borrow a minimum of \$1,000 and no more than the lesser of (1) 50% of the vested account balance or (2) \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve month period. A participant may only have one loan outstanding at any given time. Loan terms are not to exceed five years unless it is for the purchase of a principal residence in which it can be repaid over ten years. The Plan Administrator shall treat a loan in default if any scheduled repayment remains unpaid more than ninety days or there is an outstanding principal existing on a loan after the last scheduled repayment date. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates are prime rate plus 1% and the loans mature on dates ranging from 2025 to 2034. Principal and interest are paid ratably through payroll deductions or in accordance with procedures provided by the Plan Administrator.

(i) Forfeitures

When participants terminate employment, the non-vested portion of their Employer contribution and related earnings account is forfeited. Forfeitures are retained in the Plan to pay Plan expenses and used to reduce future Employer contributions. During the year ended December 31, 2024, forfeitures of \$1,361,645 were used to offset Employer contributions. The unused forfeitures as of December 31, 2024, and 2023 were \$13,148 and \$405,339, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with United States generally accepted accounting principles (“U.S. GAAP”).

(b) Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

(c) Notes Receivable from Participants

Notes receivable are valued at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis.

(d) Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Payment of Benefits

Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan but had not yet been paid as of December 31, 2024.

(3) Plan Termination

The Company has the right, under the Plan agreement, to terminate the Plan at any time. Upon termination of the Plan, the individual accounts of all participants and beneficiaries, which includes Employer contributions, become fully vested and nonforfeitable. In the case of such an event, the individual accounts of all participants will be distributed according to the Plan agreement. Termination is not contemplated at this time.

(4) Tax Status

FMR received an Opinion Letter from the IRS dated June 30, 2020, that states the document is acceptable under Section 401 of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan, as amended, and related trust, is currently designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Information Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee of the Plan).

(5) Information Certified by Trustee (continued)

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedules, that was prepared by or derived from information certified by the Trustee, and furnished to the Plan Administrator.

(6) Related–Party and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is a wholly owned subsidiary of Fidelity, the Trustee of the Plan. The Plan issues loans to participants, which are secured by the vested balance in the participant’s account, therefore, these transactions qualify as party-in-interest transactions.

Fidelity Investments provides certain administrative services to the Plan pursuant to a Retirement Plan Services Agreement (RSA) between the Company and Trustee. The Trustee receives revenue from mutual fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund service providers exceeds the amount owed under the RSA, the Trustee remits the excess to the Plan’s trust on a quarterly basis. There were no excess amounts in 2024.

(7) Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy inputs under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

(7) Fair Value Measurements (continued)

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. These funds publish their daily Net Asset Value (NAV) and transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common/Collective Trusts: Valued at Net Asset Value (NAV), which is calculated at the end of each business day. The unit value is based on the current value of the fund's holdings divided by the total number of outstanding units to obtain a daily NAV.

(8) Risks and Uncertainties

The Plan invests in various investments which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

(9) Prohibited Transactions

As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, for the year-ended December 31, 2024, certain participant contributions and loan repayments in the amount of \$549,341 were inadvertently not remitted to the Plan timely thus constituting nonexempt transactions between the Plan and the Company. The Plan Sponsor is in the process of making this correction and will deposit any lost earnings for the late 2024 deposits in 2025. The Plan Sponsor will file Form 5330 and pay the applicable excise tax to the IRS in 2025. The correction and payment of any excise taxes will be made from the Plan Sponsor's assets and

not from the assets of the Plan.

(10) Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued.
