Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Slocum Orthopedics, P.C. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Slocum Orthopedics, P.C. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Slocum Orthopedics, P.C. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the Plan administrator.

Participating Companies

The following Companies (the “Company”), which are related parties, are participating employers in the Plan:

Slocum Orthopedics, P.C. (“Plan Sponsor”)
Orthopedic Healthcare Ancillary Services, LLC

General

The Plan is a defined contribution plan formed covering all employees of the Company who are age 21 or older and have obtained 312 hours of service during the first 3 months of employment. If the employee does not satisfy these requirements, participants are eligible to participate in the Plan upon completion of 1 year of service defined as a 12-month period in which an individual works at least 1,000 hours. An eligible participant is allowed to enter the Plan on the first day of the calendar quarter immediately following the completion of eligibility requirements. Independent contractors or a person who is not treated as an employee for purposes of withholding federal employment taxes are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of annual eligible compensation as pre-tax or Roth contributions, as defined by the Plan. Participants may also contribute rollover amounts representing distributions from other qualified plans. Participants, age 50 or older, are allowed to make catch-up contributions as defined by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollees will continue to have their deferral rate increase by 0.5% automatically every August 1st up to a maximum of 5% of eligible compensation unless another deferral rate is selected. Participants direct the investment of all contributions into various investment options offered by the Plan.

Each Plan year, the Company contributes a nonelective safe harbor matching contribution equal to 100% of the first 3% of compensation deferred on, and 50% of the next 2% of compensation deferred on. Total employer safe harbor matching contributions for the year ended December 31, 2024, were \$1,137,102.

Additionally, the Company may make a discretionary nonelective contribution to the Plan at the option of the Company. A participant is required to be age 21 or older, have worked one year with 1,000 hours, and to be employed on the last day of the Plan year to receive nonelective contributions unless the participant terminated employment during the Plan year due to death, disability, or attainment of normal retirement age, as defined by the Plan. During 2024, the Plan sponsor authorized profit-sharing amounts of \$1,476,500.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Participant Investment Account Options

The Plan currently offers various mutual funds, and a money market account, as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's nonelective safe harbor matching contribution, and allocations of (a) the Company's discretionary nonelective contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company nonelective safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions, plus earnings thereon, is calculated at 20% after the first two years of service, 40% after three years, 66 2/3% after four years, and 100% after five years of credited service.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a single lump-sum distribution equal to the value of the participant's vested interest in his or her account, annuities, or installment payments only if the participant is subject to lifetime RMDs. Account balances that do not exceed \$5,000 on the participant's date of termination may result in an involuntary distribution to an IRA or in the form of a lump sum payment. In addition, the Plan allows for in-service distributions if the participant is 59 1/2 or older and if the participant meets service and participation requirements, as defined in the plan.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$76,000 and \$15,000, respectively. Forfeitures may be used, as elected by the Company, to either reduce Company contributions, restore previously forfeited balances, reallocate as Company contributions, or used to pay reasonable Plan expenditures. For the year ended December 31, 2024, Company contributions were reduced by approximately \$21,000 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment trustee (or custodian). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank ("Charles Schwab"), the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

Excluding investments of approximately \$24,000 and \$89,000 at December 31, 2024, and 2023, respectively.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (ASU) Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Cash held within a bank savings account that pays interest and is not subject to market risk. It is not a mutual fund.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Charles Schwab. Charles Schwab, is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid to the custodian by the Plan for the year ended December 31, 2024, total approximately \$21,000.

Prime Pensions Northwest, LLC is the third-party administrator of the Plan, and these transactions qualify as party-in-interest. Fees paid to the third-party administrator by the Plan for the year ended December 31, 2024, total approximately \$35,000.

Northwest Plan Services is the recordkeeper of the Plan, and these transactions qualify as party-in-interest. Fees paid to the recordkeeper by the Plan for the year ended December 31, 2024, total approximately \$32,000.

Zuna LLC and R.V. Kuhns & Associates, Inc. are the investment advisors of the Plan, and these transactions qualify as party-in-interest. Fees paid to the investment advisors by the Plan for the year ended December 31, 2024, total approximately \$45,000.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS

The Company has adopted a pre-approved Plan document that has received an opinion letter from the Internal Revenue Service ("IRS") dated November 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the pre-approved Plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 28% and 31% of the Plan's investments were invested in two funds, respectively.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
