NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the FAMILY CENTER OF HARRISONVILLE 401(k) PROFIT SHARING PLAN (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of FAMILY CENTER OF HARRISONVILLE, INC. (the Company) who have completed six months of service and attained the age of eighteen. The provisions of the Plan were amended and restated December 1, 2022. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

Until November 30, 2022, ADP Retirement Services provided recordkeeping services to the Plan. Reliance Trust Company was the custodian of the Plan's investments and served as trustee. On December 1, 2022, Standard Insurance Company began providing recordkeeping services and Minnesota Life Insurance Company was the custodian of the Plan's investments and served as trustee. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Participant Accounts

All Plan investments are participant directed. Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Net assets available for plan benefits include the accounts of active participants, as well as certain separated, vested and retired participants who have elected to receive their benefits in installment payments.

Contributions

Participants may contribute up to the percentage or dollar limit allowable by law of their annual compensation, as defined in the Plan. Participants may make pre-tax, Roth, rollover, and In-Plan Roth rollover contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Effective January 1, 2019, the Plan adopted an automatic deferral election for newly eligible employees, which the Plan is referred to as a “qualified automatic contribution arrangement 401(k) plan”. The first and second years’ automatic contribution is three percent (3%) of compensation per pay period increasing by one percent (1%) each Plan year up to ten percent (10%) with increases beginning in the third Plan year following the date deferrals were first automatically withheld.

For participants who have attained the age of 18, and have six months of service, the Company makes a safe harbor matching contribution equal to 100% of a participants’ deferrals on the first 1% of employee compensation and 50% of a participants’ deferrals from 1% to 6% of employee compensation.

The Company may also make discretionary matching contributions, profit sharing contributions, and qualified non-elective contributions (QNEC) to meet nondiscrimination compliance requirements. Employer discretionary matching and profit sharing contributions are allocated to participants employed on the last day of the Plan year with at least 1,000 service hours, unless due to death, disability or attainment of normal retirement age. No discretionary matching or profit sharing contributions were made for the years ended December 31, 2024 and 2023. During 2024, a QNEC of \$7,281 was paid from forfeitures. During 2023, a QNEC was not required.

All contributions, participants and Company, are invested as directed by the participants. Contributions, participants and Company, are subject to certain Internal Revenue Code (IRC) limitations. Forfeitures may be used to pay Plan administrative expenses or to reduce Company contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in several investment options held by Minnesota Life Insurance Company.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and are limited to two outstanding loans, one for general purposes and one for the purchase of a principal residence, at one time. Loan terms range from five years or less for general purpose loans and thirty years for principal residence purchase loans. Participant loans are reported at their unpaid principal balances plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are considered collectible because the loans are secured by each respective participant's account balance. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the safe harbor matching, discretionary matching and profit sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. For vesting purposes, a year of service is defined as a Plan year including 1,000 hours of service.

For safe harbor matching contributions, participants become 100 percent vested after two years of service. For discretionary matching and profit sharing contributions, participants become 20 percent vested after two years of service and vesting increases at the rate of 20 percent per year until participants become 100% vested after six years of service.

Participants' accounts become fully vested upon attainment of six years of service, the normal retirement age of 65, or in the event of death or disability.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to pay Plan expenses or reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,267 and \$1, respectively. During 2024 and 2023, forfeitures reduced Company contributions by \$14,590 and \$6,965, respectively. During 2024, forfeitures in the amount of \$7,281 were used to pay a QNEC. During 2023, a QNEC was not required.

Payment of Benefits

On termination of service, including due to death, disability, or retirement, a participant may elect to receive benefit payments in a lump sum amount equal to the value of the participant's vested interest in his or her account as defined in the Plan. The Plan also allows for in-service withdrawals for "hardship" (as defined by the Plan) and after a participant attains age 59 1/2. A participant is also permitted to withdraw the amount of rollover contributions, if any.

A participant will receive the value of their vested interest in a lump sum, if the vested interest is less than \$5,000. If the participant with a vested interest less than \$5,000 does not make arrangements for a distribution or rollover, the value of the participant account will be rolled over into an Individual Retirement Account (IRA) in the participant's name. If the vested interest is greater than \$5,000 on termination of service, a participant may elect to receive either a lump sum amount at termination or elect to delay the receipt of distributions subject to Plan requirements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Contracts

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurements attribute for fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The investment contract held by the Plan is fully benefit-responsive. Therefore, the investment is recorded at contract value as of December 31, 2024 and 2023. See Note 4 for a description of the investment contract.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date. Investment income includes realized gains or losses and the unrealized appreciation or depreciation on these investments. Interest from investments and notes receivable from participants is recorded on the accrual basis.

Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Minnesota Life Insurance Company (the custodian of the Plan).

All investments are participant directed.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants or distribution fees are charged directly to the participant's account. Investment related expenses and fees charged directly to the participant's account are included in the net appreciation (depreciation) of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Loans Receivable From Participants

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

NOTE 3 - BASIS OF ACCOUNTING FAIR VALUE MEASUREMENTS

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets or liabilities, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based upon the available inputs to measure fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan could access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts are valued at the quoted market prices for identical or similar assets which represent the net asset value of shares held by the Plan at year end. These funds are valued daily. There are no restrictions on the redemption of these investments.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Guaranteed Return Account is a guaranteed return contract with an interest rate guarantee. Deposits are guaranteed in both principal and interest by Minnesota Life Insurance Company. Amounts are held in Minnesota Life Insurance Company's general account and are credited on a net daily basis at annual effective rates. This contract is fully benefit responsive and is reported at contract value. The contract is valued at the accumulated cash contributions, transfers and interest credited to the Plan's contract less any withdrawals. The fair market value is equal to the contract value less any contingent deferred sales charge, if applicable.

NOTE 5 - PLAN TERMINATION

The Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become fully vested in their accounts. As discussed in Note 9, subsequent to December 31, 2024, the plan sponsor terminated the plan and transferred the plan assets to a new custodian and administrator and the plan was restated.

NOTE 6 - FEDERAL INCOME TAXES

The Company has adopted a defined contribution plan. The Plan obtained its latest determination letter on July 8, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and/or State taxing authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of funds managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is the custodian as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants qualify as parties-in interest transactions. Certain administrative costs are paid by the Company. The Company pays for other services, such as the accountant, investment advisor and attorney. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Events that occur after the Statement of Net Assets Available for Benefits date but before the financial statements were available to be issued must be evaluated for recognition or disclosure. The effects of subsequent events that provide evidence about conditions that existed at the Statement of Net Assets Available for Benefits date are recognized in the accompanying financial statements. Subsequent events, which provide evidence about conditions that existed after the Statement of Net Assets Available for Benefits date, require disclosure in the accompanying notes. Management evaluated the activity of the Plan through October 9, 2025 (the date the financial statements were available to be issued) and concluded that the following subsequent events required recognition in the financial statements and/or disclosure in the notes to the financial statements.

During July 2025, the Plan transferred all assets and accounts to the Mid-States Multiple Employer Plan and changed the custodian to Transamerica Life Insurance Company, which will effectively terminate this Plan.
