Independent Auditor's Report

To the Plan Sponsor and Participants of the
Milestone Therapy 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Milestone Therapy 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note 1: Description of Plan

The following description of the Milestone Therapy (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan’s provisions.

General

The plan is a qualified retirement plan commonly referred to as a “401(k) plan” covering all eligible employees of the company who have at least ninety days of service and are age eighteen or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to a combined maximum limit of 100% of their compensation or the Internal Revenue Code limit of \$23,000, whichever is less. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options.

The company may make discretionary matching and profit-sharing contributions to the plan. For the year 2024, employer contributions were elected in total of \$38,337.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s matching contributions and (b) participant account earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in Company contributions plus earnings thereon is based on continuous years of service, as follows:

2	25%

6 or more	100%

Participants automatically become 100% vested upon Normal Retirement Age. 100% eligibility can also occur if you become disabled during employment or attain early retirement age as defined in the plan documents.

Note 1: Description of Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the remaining balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Principal and interest is paid through monthly payroll deductions. Loans have terms of up to 5 years, or 15 years if the money is used to purchase a primary residence. Participants are allowed to have 2 outstanding loans at a time.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 5-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited and Nonvested Accounts

As of December 31, 2024, nonvested accounts totaled \$16,603. This amount includes \$4,807 of funds that were forfeited that will be used to pay plan expenses or reduce future employer contributions. This amount also includes funds that will be allocated to participant accounts.

Note 2: Summary of Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Plan Administration

The Company is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United State of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default or if the participant leaves the plan before the loan is repaid, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. In 2024, \$9,317 of outstanding loans were distributed to participants.

Note 2: Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Tax status

The Plan Sponsor has adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the "Prototype Plan"). The Prototype Plan received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The management of the Plan are not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Benefits are recorded when paid.

Administrative expenses

The Plan collects fees from participants for recordkeeping and investment management expenses. Additionally, other fees apply for loan origination and certain benefit distributions. For the year ended December 31, 2024, the total fees collected from participant accounts for recordkeeping and investment management expenses were \$22,917.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Net appreciation (depreciation) in fair value of investments, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investments, at fair value, in the schedule of assets held as of December 31, 2024

Note 4: Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1:* Quoted market prices (unadjusted) for identical assets or liabilities in active markets that the plan had the ability to access as of the measurement date
- Level 2:* Significant other observable input other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, and other inputs that are observable or can be corroborated by observable market data
- Level 3:* Significant unobservable inputs that reflect the plan's own assumptions about the assumptions that market participants would use in pricing and asset or liability.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable input and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair value of the mutual funds is valued at quoted market prices, which represent the net asset value (NAV) of shares held by the plan at year-end. The NAV is a quoted price in an active market and classified within level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Plan Termination

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6: Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Reportable Event

During the plan year ended December 31, 2024, the Plan Sponsor identified an operational error involving the late allocation of participant contributions to individual participant accounts. The delay was due to a processing issue that resulted in contributions being held in the plan's cash account for a period before being invested in accordance with participant elections.

The affected contributions were ultimately allocated to participant accounts, and the Plan Sponsor calculated and restored any lost earnings resulting from the delay. The correction was made in accordance with the Internal Revenue Service's Employee Plans Compliance Resolution System (EPCRS) under the Self-Correction Program (SCP).

The Plan Sponsor has implemented enhanced internal controls and procedures to prevent recurrence of similar errors, including automated reconciliation and monitoring of contribution allocations.

Management has evaluated the impact of the error and determined that it did not materially affect the financial statements.

Note 8: Party-in-Interest Transactions

During the year, certain Plan investments were comprised of mutual funds and a stable value fund maintained by John Hancock Life Insurance Company of New York. These transactions qualify as party-in-interest transactions because the John Hancock Life Insurance Company is the record keeper and custodian of these investments. Fees paid by the Plan for the recordkeeping and investment management services amounted to \$22,917 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Notes receivable from Plan participants qualify as party-in-interest transactions. These are also exempt from the prohibited transaction rules of ERISA.
