Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Create A Pack Foods Inc. Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



NOTE 1 DESCRIPTION OF PLAN

The following description of the Create A Pack Foods Inc. Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 2008. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective September 1, 2021. The Plan covers all employees of Create A Pack Foods, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees of the Company who have two months of service and are age 18 or older are eligible to participate in the deferral and match components of the Plan. Participants are eligible for the profit-sharing contribution after one year of service.

Contributions

Participants may elect to make voluntary pre-tax contributions up to 100% of their compensation into their participant deferral accounts through payroll deductions in accordance with annual dollar limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also accepts Roth elective deferrals. The Plan includes a safe harbor provision whereby the Company matches 100% of elective deferrals up to 3% of eligible compensation, plus 50% of elective deferrals that exceed 3% but do not exceed 5% of the participant's compensation. Additional discretionary amounts in the form of a profit-sharing contribution may be contributed at the option of the Company. No discretionary contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account. Participants may elect to change the allocation of their contributions among the available funds at any time. Participants are also able to redistribute accumulated contributions among these funds.

Vesting

Participants are always 100% vested in their deferral contributions and Company safe harbor contributions plus actual earnings thereon. Participants become vested in their portion of Company discretionary nonelective contributions plus actual earnings thereon proportionately over a six-year period based upon years of service, whereby the balance vests at a rate of 20% per year (beginning after year two of service) with 100% vesting achieved after six years of service (as defined in the Plan).

Vesting (Continued)

Participants become fully vested upon death while employed by the Company, disability, retirement, reaching normal retirement age, or partial or full termination of the Plan.

Notes Receivable from Participants

Loans are available to participants up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loan terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. Loan repayments are required through payroll deductions. Loans bear interest at the prime rate plus 1%. All loans are collateralized by the participant's account balance.

Benefit Payments

Upon termination of service, retirement, disability, or death, a participant or designated beneficiary is eligible for a lump sum amount equal to the value of the participant's account balance, subject to the vesting provisions of the Plan. The Plan also provides for hardship withdrawals and in-service withdrawals. Participants are eligible for in-service withdrawals after reaching age 59½ and at any age on account of financial hardship. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Former participants' nonvested balances in their Company discretionary nonelective contribution accounts become forfeitable after distribution of the participants' entire vested account balance or after five consecutive break in service years (as defined in the Plan). Forfeitures will be used to reduce future Company safe harbor or discretionary nonelective contributions or may be used to pay Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled approximately \$-0-. There were no forfeitures used to reduce Plan expenses or Company contributions for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company and certain expenses are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Standard Insurance Company, a qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Minnesota Life Insurance Company, a qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2023.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Investments in the pooled separate accounts are valued using the net asset value of units, as determined by the qualified institution. NAV is a readily determinable fair value and is the basis for current transactions. Pooled separate accounts are valued based on the market prices of the underlying investments in the accounts at year-end.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company discretionary nonelective contributions.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore, not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by Minnesota Life Insurance Company. Minnesota Life Insurance Company is a qualified institution as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.
